THE MARR FAMILY

General Information

The family name is found with many different spellings, such as: Mar, Mars, Marr, Marrs, Mahr, etc. The origin of our branch of the family has not been definitely determined. Some believe there is a connection with the Erskines, The Earls of Mar, who owned and occupied Kildrummy Castle in Scotland. This castle is located on the Don about ten miles above Alford, and dates back to the 13th century, but has been partially dismantled. We have not been able to establish a tie with our Marr Lineage and that of the Erskines, who held a great deal of wealth. both in money and real estate, in Scotland and also in England. A news item from THE DETROIT FREE PRESS of September 1, 1874, relates to a meeting held that day at The Chapman House, Lansing, Michigan, for the purpose of securing for the Marr family the \$200,000.000 estate left sixty years before by Henry Marr, who died intestate. At the time of his death he was living t Linlittle, County Edenburgh. of Henry Marr's heirs supposedly came to New York about 1850, and the family spread to various parts of the United States from that start. This fact alone would let our group out, as we know they were in the Carolinas and Tennessee by 1800. However, there was a tremendous court battle in England over this estate which was finally taken to the House of Lords, which in England, is comparable to our Supreme Court. A decision was handed down on February 25, 1875 in favor of the late Earl's cousin. This decision was appealed and was reversed in 1885 by a special act, The Earldom of Mar Restitution Act, in favor of the son of the late Earl's cousin. An excerpt from Nile's Register of June 13, 1835, Volume 48, page 265, gives a different account. A son of the Earl of Mar came to Portsmouth, New Hampshire, in about 1720, according to this account, where he married and had a family of six children who stayed in this country, and the family spread to different parts of this country from this start. This article from Niles lists the value of the estate at \$60,000,000 to \$80,000,000 and says the heirs here had sent an agent to Newcastle upon Tyne to recover this property.

The Family of Seletha Marr

A word of explanation about the attached genealogy chart. each person is assigned a number as they appear on the scene, and they retain that same number for any future appearances. Much of the information for this chart and also for this write-up was supplied by Leita M. Davis, (159) who had discussed many of these happening with Seletha Marr Racer Carson (108). The 1880 census of Fulton County, Ill. shows Jonathon B. Marr and his father and mother as having been born in South Carolina. However Jonathon B. Marr's obituary states he was born in North Carolina. It appears we must regard the census data as the more reliable since, presumably, Jonathon B. Marr gave that information himself.

Mary Bell (102) who married Benjamin Marr (101) was a relative, possibly an aunt, of John Bell, Speaker of the House from Tennessee in 1834. We have no data on Daniel Marr (105). Jeanette Marr (104) married Pate, and Sallie Marr (105) married Stonecipher.

Jonathon Benjamin Marr (103) came to the Knoxville, Tennessee, area when a young man and married Viola Love, probably in about 1824-25. We have no record whatever of the ancestry of Viola Love. She died in childbirth when Seletha Marr was born, September 11, 1826. At this time the Loves, Viola's parents, took Seletha to raise. Seletha's obituary says she was born in Johnson Co., Tenn., however she had said at one time that she was born at or near Cumberland Gap, Tenn. So far in checking the 1830 and 1840 census lists I have not found the Love family in either area. Johnson Co. was not formed until several years after Seletha was born. Johathon B. Marr soon married again. The name of his second wife is not known. However, she died soon after a daughter, Sallie (110) was born to them. Cause of her death possibly typhoid fever. Viola Love's parents also took this child to raise along with her half-sister, Seletha.

Jonathon B. Marr's third marriage was to Hepsibeth Hale (111). They had eleven children. The names of eight of which are known. After this marriage he probably taught school but also went out as an itinerant Baptist preacher holding meetings as he traveled west. Hepsibeth enjoyed these meetings and accompanied him. In 1830 he established a home at or near Mccomb, McDonough Co., Ill. In about 1842 brought the half-sisters, Seletha and Sallie Marr, his children by his first two marriages to Ill. to live with him. The two girls did not find a congenial relationship with the step-mother, Hepsibeth, and both married young. Seletha on July 11, 1842 to James Raser, a trapper and fur trader, and Sallie to _____ Gaston, date of her marriage not known. Both marriages probably took place in McDonough Co., Ill. The name Raser is also spelled Rasor and Racer on different records.

In the late fall of 1849 James and Seletha Raser were located in the Indian Village of Wyandotte at or near the present site of Kansas City. They had three small children, Martin C., Sarah Elizabeth, and Albert. Seletha was carrying a fourth child to be named James Russell, who did not live past early childhood. On about November 15, 1849, James Raser left his family and as far as is known was never seen by them again. Seletha, with help from the Indians, made her way back to south central Iowa where her half-sister, Sallie Gaston, was living. In Iowa she was able to keep her family together although often by engaging in the most menial and arduous tasks. She has told of working over fourteen hours one day washing heavy quilts and bed clothes, for which her pay amounted to twenty-five cents. Eventually Seletha secured a divorce, and married my grandfather, William Carson (129), a widower, thirty years her senior, with a family of grown children by a previous marriage. They remained near Martinsburgh, Iowa, until the summer of 1870 when they took two covered wagons and joined a wagon train headed for Kansas. It should be mentioned here that at this time William Carson was a mere 73 years of age. The spirit of the true pioneer is indeed strong! The trip was much slower than anticipated because of bad weather and other unexpected drawbacks. One family lost a horse and the entire train was slowed down as it was necessary to break their cow to work with the remaining horse pulling their wagon. Apparently there were no spare horses taken along. William and Seletha Carson reached Montgomery Co., Kansas, in the late fall of 1870 and spent the winter in a rented house at the now non-existent town of Radical City. In the spring of 1871 land adjoining Elk City was purchased where they made their home, and where William Carson died on December 30, 1875. William was one of the founders and a charter member of the Masonic Lodge at Elk City, Kansas. It was named

It was named after him and still is designated as Carson Lodge No. 132. In 1906 the family consisted of Seletha, her two unmarried sons, Lafayette and Thomas, and her married son, Robert, and his wife Bertha, with their children Glenn A., Marie, La Rue and Robert. This was the time when they all moved to Perkins, Oklahoma. It was here that Seletha died on March 3, 1912.

Two sons of Seletha by her first marriage saw service in the War Between the States. Martin C. Raser enlisted in Co. I of the 1st Iowa Cavalry on June 13th, 1861 at Ottuma, Iowa, and was discharged on September 9, 1864 at Davenport, Iowa. In the service he contracted a lung ailment and also was thrown against his saddle while riding, sustaining a hernia. Someone has told me that after the war the doctor told him he should go to a dry climate because of his lung problem, and that he was fixed up with a horse and light wagon and supplies and mede the trip to Uvalde, Texas area by himself. I do not know if this was from Iowa or Kansas, or even it it is true.

Albert Raser was about 15 when he signed for service by giving his age as 18. He signed at Martinsburgh, Iowa, July 13, 1863 and was reported missing July 30, 1864. He was on "McCook's Raid" at Newman, Ga., about 30 miles southwest of Atlanta when he was shot off his horse and taken prisoner. Others tried to rescue but he told them to leave him as they were hopelessly outnumbered. He died at Andersonville Ga., Prison on December 14, 1864 of Scorbutus, which is malnutrition. He was apparently attached to Sherman's Army as Sherman was in this area and started his "march to the sea" from here at about this time. Sherman was near Andersonville but did not try to take it as I suppose he was anxious to deal the South's morale a blow by marching thru to the sea.

Some branch of the Marr and Love family was there in 1830.

"In 1891 the state of Tennessee enacted legislation which established a Board of Pension Examiners...Both Federal and Confederate veterans who were bona fide residents of Tennessee for at least one year before making application were eligible for pension, provided they met the qualifications set forth by the Pension Act. However, the Federal Government's earlier and more liberal pensions to Union veterans prompted them to apply to that government rather than to the Tennessee Board...Most pension applications and their supporting papers contain information of much interest and value to soldier's descendants, to genealogists, and to other researchers. They are more informative than official service records because they give more detailed information about a soldier's military, personal, and family history. application lists the veteran's place of enlistment, unit, period of service, battles participated in, and whether he was wounded or captured. Made out in questionnaire form, it also asked such information as place of birth, number of children, and value of personal and real property owned by the veteran....Pensions for soldier's widows were first issued in 1905. Their applications show place of birth for both widow and husband, and in many instances the names and ages of children. As proof of marriage was required for admission to the pension rolls, a copy of the marriage certificate is often found in widow applications. Additional supporting papers: Letters, affidavits, and abstracts supply much information.

RICHARD CARNEY. JR. - REVOLUTIONARY WAR

Richard Carney Jr. was a lieutenant in the American army during the Revolution. During that time all the Carneys moved from Portsmouth. Norfolk County, Virginia to North Carolina, Then Richard Jr. returned to Virginia and in 1808 came west, settling first in Robertson County, Tennessee, and in 1809 established his home in Montgomery County. He married Sally Lewelling of Virginia. A son, Christopher N. Carney born 1782 in N. C. came to Montgomery County, Tenn. 1807. He died 1862. He married (1) Elizabeth Johnson - (no issue) (2) Margrett Carnes Lynn born 1818 dau. of Andrew and Nancy Smith Lynn.

One of the children of Christopher N. Carney was Norfleet Lynn Carney born Sept 21, 1854 M. D. Dr. Carney married in 1888 Hattie Ginter of Cadiz, Kentucky. JOHN NEBLETT - REVOLUTIONARY WAR

John Neblett was born 10 September 1755 in Lunenburg Co., Va. He died 11 March 1830 in Montgomery Co., Tenn. He married before 1770 to Susannah Hightower, daughter of William Hightower. She was born about 1753 and died 1 November 1836.

John Neblett was a son of a prominent Lunenburg family. His father was Francis Neblett and his mother was Elizabeth Sterling. In Virginia

John Neblett was a Methodist Minister and farmer. His returns are listed in "Old Free State" - Bell. Page 436 to 439. He came to Tenn. in 1806. In Tennessee he was a farmer, blacksmith and at one time served as sheriff of Montgomery Co.

JAMES N. SMITH - WAR OF 1812

James N. Smith, son of John Smith, both born in Virginia. Smith was born December 1798 and died 1874. His wife, Nancy Allen, was born in N. C. 1800 and died ten years after her husband. They were the parents of eleven children, one being Valentine W. Smith, who was born Nov. 30, 1834.

During the Indian hostilities which disturbed this maddle west he served under General Jackson. (HALE & MERRETT, Vol. VI - page 932-33)

James Smith married Nancy Allen, daughter of Valentine Allen Dec. 1823 (Old marriages of Montgomery County, Tenn.)

James N. Smith was the administrator of John Smith Jan. 19, 1835 (Wills of Montgomery County, Tenn. Bk G. page 106) The property of John Smith was divided into six lots. 1. James Smith 2. Francis P. Smith 3. Francis Pennice 4. William H. Allen 5. Samuel McFall 6. Mrs. Fanny Smith (Frances Smith was not the mother of the children but the second wife of John Smith and the widow of Gully Moore.)

James N. Smith and wife, Nancy, are buried in Mount Pleasant Methodist Church Cemetery. (Vol. I CEMETERY RECORDS OF MONTGOMERY COUNTY, TENN.)

Bill Shelton, a great-grandson of James N. Smith, has the cane which James carried when he followed Jackson.
