RIGGINS MANN PATTERSON--NORMAN ALPHEUS By Margaret Frances Riggins June. 1966

On December 11, 1827, there was born to William and Theresa Chisenhall Riggins on the Riggins farm, Dover Road, near Clarksville, Tennessee, a son, whom they named Mann Patterson.

Eight years later on a neighboring farm was born a daughter to Lemuel and Delilah Dodd Cherry. She was given the name, Frances Jane, called Fannie. Her birthday was November 8, 1835.

When she was fourteen years old, she and Mann became engaged. He told her, "Fannie, when you grow up, we are going to be married". She believed him, and they were married on April 20, 1854.

Mann did not like farm life, so went to New Providence, called "String town on the pike", and established a mercantile business. The became a successful business man, and built a home near the Cumberland River not far from the store.

Three children came to bless this union, Stanley Wallace, Norman Alpheus, and Delilah. Wallace and Delilah died in childhood. Their illness was the result of eating green peaches. Norman survived the peaches and grew up to be an energetic boy. He inherited a quick, bright mind and his parents determined that he should have as good an education as they could provide. After going through the local school he went to Bethel College at McKenzie, Tennessee. This was and is, at present (May, 1966), the official school of the Cumberland Presbyterian Church. He remained in school until an epidemic of cholera swept the country. His father became uneasy about him and sent for him to come home a few weeks before he was to be graduated.

He became associated with his father in business. After a few years hey moved the family and the business to Paducah, Ky. then to Missouri, then to Florida. But more of that, later.

Norman was a small boy when the Civil War broke out. He was born September 25, 1858, in the home in New Providence.

As the armies, both Federal and Confederate passed through the town, Mann decided that it was prudent to move the family to a farm on Ringgold Creek, where he hoped that they would not be molested. He was disappointed for the Yankee soldiers found them and searched the farm for family breasure, using their bayonets to probe the grounds around the house. Norman"s big mastiff dog objected and was stabbed by one of the men. This infuriated Norman and from that day until the day he died he hated "Yankee blue" and refused to wear blue clothes, always wore gray suits. Fortunately, Drummer, the dog, recovered.

Mann took his merchandise down to Alabama and sold it for a little gold and "a trunkful" of Confederate money. On one of his visits to the family, he went through the garden and kicked over a big cabbage. Into the hole he planted his little bag of precious gold,

replaced the cabbage and went on his way. When the conflict was over and he came home to stay, he went to the garden, found the hole and dug up his bag of gold. That was the capital which financed a new business.

A battle was fought near the Riggins farm. It was afterward known as the battle of "Riggins' Hill". Norman and the cousins dug small cannon balls (called mini balls) out of the fields, years later. When it became apparent that there would be a skirmish near the famr house, William Riggins sent Theresa and the children to visit kinfolk where he thought they would be safe. He was urged to go, but he said, "No, I'm staying here to look after my property". He sat on his doorstep with his gun across his knees, ready for the first forager from the Yankee army. He was not molested.

It was told for fact that J.D. (Bud) Riggins, son of George and Rebecca Riggins, became a "sharp shooter" after he came home wounded from the Confederate Army. He was greatly feared by the Federals who strayed down the country roads. He didn"t tolerate blue uniforms in his neighborhood. His pictures show that he was a tall, handsome man. He was dedicated to the Confederate cause.

When the war was finally over, the families returned to their homes and the boys came home from the battle fields.

Mann re-established his business in New Providence. After Norman came home from college, they decided to move to Paducah, Kentucky. Fannie and Mann, Norman, Margaret Brown Cherry (Fannie"s sister who lived with them), Melville (Fannie"s younger brother), and Mary Whitefield (colored housekeeper who had lived in the home since about 1858), packed their belongings and "Pulled up stakes" and departed for Kentucky. It was there that Melville met and married Emma Reiki, sister of Will Reike who owned Reiki! Department Store.

Paducah was a prosperous business town, but as it was a "river town" it was also rather rough. Mann heard of the rich land over in south wast Missouri. So after, investigating, he moved the store and the family to Dexter, Stoddard County, Missouri. Melville Cherry bought the Paducah store and conducted a profitable business until his death.

Dexter was a small town but the back country was rich farm land. The farmers soon learned that Riggins & Son were honest merchants, consequently, gave the firm their business. Much of the selling was barter, eggs, butter, and farm products for flour, sugar, coffee, etc. The eggs and butter went to St. Louis, the eggs for sale, the butter to the creamery. Norman told about an "honest farmer" whose balls of butter looked too small. When the clerk cut them open the centers were buck shot. There were cheats in that day, too.

In the winter of 1882 Mann decided that Norman needed a vacation. As he had not done much travelling outside of Tennessee, he thought that a trip to the "wilds of Florida" would be an interesting adventure. On February 1st he left Dexter for St. Louis, his starting point. The intention was to go to Mobile and from there take a boat to Tampa, Florida. He found that the boat trip had been discontinued so, he took the train again for Jacksonville. The St. Johns River boasted a line of river boats and he took passage on one

of them, small but sturdy. It meandered up the crooked stream, through Lake George and Lake Monroe to Sanford, which was the northern terminus of a twenty mile railroad.

The road ended at Orlando, in Orange County. He arrived in Orlando only to find that there was no train, boat or stage coach to take him to Polk County, which was his destination. Consequently, he went back to Sanford, back down river to Tocoi and was ferried across the river to Astor. By narrow gauge railroad the trip was to Fort Mason on the shores of Lake Eustis. A handmade "side wheeler" was the vehicle that took him through the lake, through a canal called Dead River into Lake Harris and landed him at Leesburg, a small but charming town. He spent the night at the "Lake View Hotel" which building stood and was used until the 1950's, when it was declared obsolete and was torn down to make way for something more modern.

Wildwood was the next stop, reached by livery hack. Then Sumpter-ville, and on to Tampa through the pine forests by night to Tampa. Tampa was and is in Hillsborough County, which adjoins Polk County. The mail carrier was accommodating and took him on as passenger in nis "buckboard" along with the mail sacks for Bartow, the county seat of Polk County, and points between.

After spending Sunday in that frontier town, he and the mail carrier and the mail sacks, made the return trip to The Port of Tampa. The remainder of the trip was made by boat along the gulf coast to the mouth of the Mississippi River and up the river to New Orleans and to St. Louis, the starting point.

When the family and neighbors in Dexter learned that Florida was not all swamp and alligators, they were much interested. In fact, Mann was so impressed that he consented for Fannie to go with Dr. and Mrs. Whitledge to spend a few weeks in Bartow, the following winter.

In January of 1883, Norman was married to Sallie Major Richardson, daughter of Mary Ellen Richardson-Kitchen and step-daughter of Col. Solomon G. Kitchen, a rpominent attorney and farmer.

Immediately after the wedding, Fannie and the Whitledges began their journey to Polk County, Florida. Their trip was much the same as Norman" had been, except that they took a wagon from Orlando to Bartow. In February, Mann followed to spend a few weeks away from business cares and to satisfy his curiosity about the wonderful land that Norman told about. He and Dr. Whitledge hired a livery rig and drove around through the pine woods near Bartow. About fifteen miles to the north and west, they came upon high pine land intersperced with clear fresh water lakes. They were so favorably impressed by one tract on the side of a small lake that Mann bought an eighty acre tract, from Mr. John Zebendon. It lay between lakes Morton and Hollingsworth.

When he came home to Dexter, he told Norman what he had done. Norman asked him it there was a town nearby. He said, "no". Was there a railroad near? the answer was, "no". Then Norman said, "Pa, are you crazy?' Mann said, "no, but it is such a beautiful spot that there must be a town there some day."

In August 1884, the Riggins & Son mercantile business, the family plus a cousin or two, arrived at the anticipated town by way of

THE PLANT SYSTEM RAILROAD to the still unorganized town named Lakeland. The town was incorporated early in 1885.

And that is how the Riggins family happened to live in a new town, in a frontier state, and have lived there ever since.

Norman wrote a description of his 1882 trip to Florida which was pubin the local paper, THE LAKELAND LEDGER, about twenty years ago, Copies are available. Being written by an Irishman, it is very readable.

"Baker's Campground" Church ???

These early church records were found in the Bible of Marmaduke Norfleet and Malinda McFaddin Norfleet. These records are ASSUMED to be Baker's Campground Church which was in the eastern part of Montgomery County between 1840 and 1860. The Bible is owned by Wm. A. Norfleet, Trenton, Kentucky. Letters after the names refer, evidently, to attendance.

SOLDIERS FROM MONTGOMERY CO., TENNESSEE in the REVOLUTIONARY WAR and THE WAR OF 1812 by Anita Whitefield Darnell

WILLIAM RIGGINS - War of 1812

William Riggins applied for a pension on the 18th day of June 1872, age 79 years. He was drafted in Capt. Michell's and Capt. Robenson's Co., Col. Pipkins, at Fort Deposit on Tennessee River in 1813. He was honorably discharged at Mobile, Alabama in December 1814. He was a private in the infantry at Mobile. His discharge is on file in the Pension Office of the United States. It was filed there when he made application for bounty land warrant. The rolls of Capt. John Robinsons Company of Tennessee Militia shows that William Riggins served from 20 October 1814 to February 1815.

William Riggins was born in Orange Co., N. C. on January 21, 1793 and died in Montgomery Co., Tenn. August 4, 1875. His pension application for the War of 1812 states "...that he is married; that his wife's name as Thursey Chisenhall, to whom he married at her father's residence in said county (Montgomery Co.) in 1822." William is living in District β in Montgomery Co. when he made this application.

His records show that he was a private in the late Capt. Robertson's company of Infantry, 1 Reg't Tennessee Militia. He appears on the ompany muster roll for June 20 to Dec. 19, 1814. Date of enlistment Aug. 6, 1814(?).

Methursia or Thursey Chisenhall was the daughter of Reuben and Jane (Leigh) Chisenhall. She was born in Orange Co., N. C. 1803 and died in Montgomery Co., Tenn. Nov. 5, 1874.

William Riggins and wife Methursia with 5 of their 9 children are buried in Liberty Church Cemetery in old District 8.

William Riggins married twice. The name of his first wife is not known. He evidently married in Orange Co., N. C. for his oldest son was born in N. C.

John Teasley was born in 1755 Isle of Wright County, Virginia. He died March 8, 1816 Montgomery County, Tennessee. He married in Raleigh, North Carolina in 1775 to Lucy Hunt. She was born May 18, 1757 in North Carolina and died November 4, 1846 in Montgomery County, Tenn.

Service: Enlisted July 7, 1778. Served as a private in Lt. Cole's Company, North Carolina Troops. He was in the Battle of King's Mountain.

DAVID BURTON

Information contributed by Victor E. Morris, 1355 Pearl Street, Apt. 106, Denver, Col. 80203, with excerpts from correspondence with Ann Taylor Brown and your editor. If you have additional information on this family, please contact Mr. Morris.

David Burton was born March 15, 1816 in Montgomery County, Tenn. On April 1, 1835, he married Martha Ann Adkins, born July 13, 1813 in Montgomery County, Tenn. Whether they were actually married in Montgomery Co. is not known. One descendant stated that Martha Ann said they were visiting outside the county when they were married.

Their first four children were born in Montgomery County:

- 1. Nancy Jane Burton b. January 4, 1836 d. October 9, 1910 m. Lively. He was a descendant of the old John Lively who settled in Southern Illinois from South Carolina around 1805. See LIVELY'S OF AMERICA.
- 2. Mary Ann Burton b. January 10, 1838 d. ___ m. (1) Blair (2) Rittenhouse
- 3. Emily Elizabeth Burton b. April 6, 1840 d. __m. (1) Anderson (2) Pulliam
- 4. Frances Moss Burton b. December 10, 1842 d. February 14, 1925. m. Evilsizer.

The 1840 Census of Montgomery County lists David Burton with a wife and three daughters

After the birth of Frances Moss Burton in 1842 David moved his family to Smithland, Kentucky, where his first son was born:

5. William Thomas Burton b. April 6, 1845 d. June 25, 1919. m. Macklehenny.

After a short stay in Smithland, Kentucky, David moved his family to Washington Co., Illinois where the rest of the children were born:

- 6. Lemuel A. Burton b. 1847 d. 1909. No marriage.
- 7. John Henry Burton b. September 6, 1851 d. August 6, 1927 m. Lowry.
- 8. Howell U. Burton b. December 2, 1856 d. October 18, 1939 m. Ivans.

David Burton died in Nashville, Washington Co., Illinois shortly before his son, Howell, was born in 1856. He is buried in Lively Grove, Ill. Martha Ann Adkins Burton died February 11, 1901 in Washington Co., Ill. and was buried in the Masonic Cemetery in Nashville, Ill.

The father of David Burton has not been proven at this writing. The 1820 census of Montgomery County lists four Burtons: Hilory, John, James and a second John. Any of the four COULD be the father of David as all four had males under ten years of age in the household in 1820.

Correspondence with a descendant of Hilory Burton produced the names of three of Hilory's children. David Burton was not included on this list. However, the 1850 Census of Montgomery County listed a fourth son. Could there have also been a fifth son, David, who by this time was living in Illinois?

The 1850 Census Records indicate Nancy Burton, wife of Hilory, was born around 1802. If David was her son, born 1816, she would have given birth to a child at the age of fourteen. There is the possibility that Hilory Burton, born about 1788 may have been married twice and the wife, Nancy, listed in the 1850 census may have been his second wife.

The 1820 Census of Montgomery County shows Hilory Burton with one son under ten years of age. Yet the 1840 census shows Hilory Burton with three sons all under the age group ten to fifteen. So one son listed in the 1820 sensus, even if only one year old at that time was not included in the 1840 census. He must have died or married and left home. (David married in 1835)

By 1840 one of the John Burtons on the 1820 census had died and his wife Nancy, about 80, was listed as head of the household. No children were mentioned. It has always been my thinking that David Burton was the son of John and Nancy Burton. Note David had children named John and Nancy. However, the ages given John and Nancy, if correct, would almost make them too old to be the parents of David. Yet David did not leave Montgomery County until both John and Nancy were dead.

It could be that David Burton was the son of Hilory and Nancy Burton; and Hilory was the son of John and Nancy Burton.

There was a James Adkins who showed up in the 1798 Tax list with 12,240 acres of land. He was listed under Captain James Hollis Company. The 1820 census lists a Howell Atkins. Later Census records seem to spell the name ADKINS. Whether Martha Ann Adkins was related to either of the above is not certain. Notice, however, that David and Martha Ann's youngest son was named Howell....After a Grandfather, perhaps?????

This book contains 181 cemeteries with 5000 entries, representing about one-half of the cemeteries in each district of the county. The cemeteries range from the well kept church cemeteries to a group of stones found leaning against a tree.

Each cemetery is numbered and a corresponding number is placed on the enclosed map to designate its location. Directions for locating the cemetery are also included with the cemetery listing. Locating a desired cemetery should be no problem for a searcher with these directions and the map.

The print is clear and easily read. The surnames are listed first and typed in capitals making it easy to pick out a particular name from the listings of stones.

This book is indexed by surnames as well as by cemeteries.

This is a much needed resource for those of us having Robertson County connections.
