### ABNER GUPTON

### REVOLUTIONARY WAR SOLDIER

Abner Gupton was born in North Carolina about 1761. The approximate year of his birth is derived from his following Montgomery County, Tennessee census:

1820 - Age 45 and up 1830 - Age 60 - 70 1840 - Age 70 - 80 1850 - Age 89

Abner Gupton was a son of James and Sarah Gupton and a great-great grandson of William Gupton who came to Virginia in 1662.

Abner Gupton was a soldier in the War for Independence and was wounded at the Battle of Guilford Court House, North Carolina. This was one of the last significant battles of the Revolutionary War in America fought on March 15, 1781 when troops led by General Nathanael Greene "out-marched, outmaneuvered and outfought" the British under Charles Lord Cornwallis. Cornwallis is reported to have made this statement, "I never saw such fighting since God made me. The Americans fought like demons."

History has it that though the Americans fired and fell back in The Battle at Guilford Court House, they inflicted heavy losses on the British which whipped them down and made them ready for their surrender at Yorktown, Virginia where the forces of the Crown were forced to give up and the fetters of tyranny were taken off. Abner Gupton and his countrymen laid their lives on the line for the future of their families Their families were "their country" to them and we, almost 200 years later, are a part of their families. Because of those men who fought for freedom, we are privilized to be Americans. We should show our appreciation and respect for those forefathers by endeavoring to perpetuate their memories. I am grateful for my heritage from Abner Gupton.

If the wounds he received while fighting for our Country had been mortal, I, as well as an innumerable number of his descendants, would not have been born. No doubt he wore the scars of his wounds throughout his long life as his portrait bears evidence that he walked with the aid of a cane. In the portrait, a cane with his powder horn attached on its top, was held firmly in his left hand. A copy of this portrait is preserved at the headquarters of the National Society of the Daughters of the American Revolution in Washington, D. C. It was submitted with the application papers of Mrs. Martha (Harrison) Harty, of Missouri, in 1941. Mrs. Harty, a descendant of Abner Gupton through his son, Robert Thomas Gupton, was the first member of the Daughters of the American Revolution credited to the Revolutionary War Service of Abner Gupton.

About fifteen years after the war, Abner Gupton married Judith "Judy" Hunt on August 30, 1796 in Franklin County, North Carolina. She, a daughter of James Hunt, Senior and Mary (Rackley) Hunt, was born in Bute (now since 1779 Franklin) County, North Carolina. Four children, Mary "Polly," James H., Sarah "Sally," and Abner Gupton, Junior were born to Abner and Judy in North Carolina.

On December 29, 1807, Abner Gupton, then residing in Franklin County, North Carolina, sold his 617 acres of land on both sides of Cypress Swamp to Michiel Eley "for the sum of 3000 Silver Dollars" and shortly thereafter, he moved to Montgomery County, Tennessee.

On July 21, 1808, Abner Gupton of Montgomery County, Tennessee, purchased his first tract of land in Tennessee from William Ward and his wife, Prudence (Drake) Ward for the sum of \$900.00. This tract of 300 acres in Montgomery (now since 1857 Cheatham) County, Tennessee on Half Pone Creek, began at the mouth of Raccoon Creek at Joseph Cartwright's north west corner and was originally the land which was granted to Jonathan Drake by the State of North Carolina by Grant Number 1014.

Less than two months after Abner bought his first tract of land, he added to it by purchasing for the sum of \$640.00, 320 acres from Darcus Gray (conveyed to her by Frederick Davis) on September 4, 1808. This 320 acre tract, on the lower side of the Raccoon fork of Half Pone Creek in Montgomery (now Cheatham) County, Tennessee, began at trees on the south of said Raccoon fork of Half Pone Creek and was a part of a 640 acre survey granted originally to Joseph Cartwright, a soldier of the Continental Army, by the State of North Carolina by Patent Number 525. For the exact location of these first two tracts of Abner Gupton's land, see pages 76 (map of Grants - numbers 22 and 23) and and 77 (Grants in watershed of Half Pone Creek) of the book, The Southern Virginia Weakley Families and Their Descendants by Samuel Anderson Weakley.

According to tradition, the early settlers erected a block-house (a fortified structure with openings for gunfire) at the forks of Half Pone and Raccoon Creeks for their protection from the roving bands of hostile Indians. It was here where Abner Gupton built his home and lived for the fifty-one years of his life in Tennessee, and where three of his children - Judith, Robert Thomas, and Elizabeth were born.

During Abner's life, his settlement was known as Gupton's Cross Roads (now Henrietta) Tennessee. It is said that it was then a village that had a mill, a store and a sizable population. In 1836, Gupton's Store at the forks of Half Pone and Raccoon Creeks (then District Number 9, Montgomery (now Cheatham) County, Tennessee, was the voting place of the citizens of the area.

Abner Gupton served as Magistrate of Montgomery County for many years. When the widow of his grandson, James Lafayette Pardue (born 1834), was 99 years old and retained a remarkable memory, she (Mary (Cain) Pardue - born 1837) stated in a news interview that the most beloved resident of Montgomery County in his day was her husband's grandfather, Abner Gupton. "Everybody knew him as Grand Daddy Ab" she explained. "He owned just about all the land from Clarksville to Ashland City, and whenever poor folks came along and no way to support their wives

and children, he just told them'to go over there on that hill and build you a cabin and go to work.' He would give them that land and pay the taxes on it for them. Grand Daddy Ab was, I reckon, the richest man this County (Montgomery) ever saw. He had a hundred and eight Negroes and thousands of acres of land. He owned property fifteen miles wide from Clarksville to Ashland City. My husband's part (1/9th of 1/7th EZC) of his estate would have made us rich if it hadn't been for the war (Civil War). Just about all of it was lost during the war."

Abner Gupton's material wealth showed his ability in management of his business. His unselfishness showed his compassion for his fellow men and he was concerned for the spiritual needs of his community. He gave them land on which to build their House of Worship, the Mount Herman Baptist Church which was organized over 135 years ago. The congregation of this religious faith, many of whom are no doubt the descendants of Abner Gupton, still meet at the Mount Herman Church building which is now located in Montgomery County, Tennessee just across the Cheatham County line. It is a lovely little building and to me it would, or should, be considered an historical land mark. The following deeds which are recorded in the Montgomery County Courthouse in Clarksville, Tennessee should be of interest to the people of this area:

Deed Book T, page 334. Abner Gupton to the Church: "Abner Gupton to Matthew Williams and Marmaduke Pinson, agents for the benefit of the United Baptist Church of Christ, Mount Herman, one acre of land lying on the east side of the road leading from Cheap Hill to John Duke's Store beginning on a white oak saplin thence running north seventy-five yards to an ash saplin thence east to a poplar and dogwood fifty-one yards thence south seventy-five yards to a white oak saplin thence west to the beginning for the purpose of building a house of worship with a free privilege the free use of the Spring which lies east of said ground and nearest to said land to have and to hold for ever and ever with the following restrictions to wit - whenever the aforesaid Church is not a using said anticipated meeting house that all other authorized Preachers may and have opportunity to preach in said anticipated meeting house and in case the aforesaid Mount Herman Church should disolve as a church in that case all other orthodox Preachers may and shall have equal privilege to said lot of ground and said anticipated House with the same benefits of said Spring water. As witness my hand and Seal this 22nd day of October 1839.

Abner Gupton (Seal)

witnessed by Abner Hunter and Nimrod Gupton. Registered December 16, 1843.

Deed Book 1 (One), page 304: Abner Gupton to George Reynalds and Corneleus Morgan (Deacons of the United Baptist Church at Mount Herman and their successors in office one acre, more or less of ground lying on the west side of the Road leading from Gupton's Cross Roads to Clarksville and between said Cross Road and

the Road leading Davice's Ripple to be near enough to the spring that Alic Carnes uses for his family - commencing on stake on said Clarksville Road, thence running with said Road 70 yards to a stake, thence at a right angles, running a northward corse seventy yds. to a stake, thence to the beginning for the purpose of building a House of Worship for the Mt. Herman United Baptist Church of Christ. -- And the said church is to have free use of the above mentioned springto have and to hold, same forever, with the following Restrictions (Viz) whenever the aforesaid House of Worship shall cease to used as such, then the said parcel of ground is to fall back to the oredgonal tract it now is a part of. But as long as it is kept as a place of Worship it is to be held as such. This deed is given in Room and stead of one I gave to the said Baptist Church lying at the back of the field where R. T. Gupton now lives on said Clarksville Road given Oct. 22nd 1839 and recorded at Clarksville on 14th day of December 1843 and this Deed is given in lieu of the other which is given back to me for the above named parcel of ground. Given under my hand and seal, this 24th November 1851.

Abner Gupton (Seal)

Test: Joseph Gupton and Thomas Gupton. Registered March 1st A.D. 1852.

It is evident from this 1851 deed that the location is the present (1974) location of the Mt. Hermon Church. A history of this church was written by Mrs. Henry Evans and was published on page 5 in the Clarks-ville Leaf-Chronicle on February 16, 1963. Mrs. Evans wrote that "a small church was built where the remodeled church now stands. In 1896 a new church was built a few feet north of the log one. In 1956 and '57 when the new highway started its work, it caused the people of Mt. Hermon to have to work also. A full-sized basement was dug where the old log church stood. The church was moved over on the basement and the same auditorium that was built in 1896 was completely remodeled, etc." I'm sure it would pleasure him if Abner could know that this church still exists.

His wills are recorded in the Cheatham County Courthouse in Ashland City. Tennessee in Will Book "A" (1), pages 127, 128, 129, 130. His first will was written on April 5, 1841 when he was about 80 years old. From this will it appears that he and his wife, Judith, were sick at that time - Judith died 9 days later on April 14, 1841 at the age of 63 years.

Five months from the day of Judith's death, a license was issued in Montgomery County, Tennessee on September 14, 1841, for an intended marriage of Abner Gupton to Mrs. Martha A. (Ward) Power. This marriage was executed on October 5, 1841 - 6 months from the date of Abner's first will - by his son, Robert Thomas Gupton, Justice of the Peace.

She was the widow of Samuel D. Power, Senior and the mother of Martha Henrietta (Power) Gupton, wife of Robert Thomas Gupton, and was at least 40 years younger than Abner.

(Dees anyone know when the village of Gupton's Cross Roads was changed to Henrietta? Was it re-named in honor of Henrietta (Power) Gupton?

The 7 children of Abner and Judith (Hunt) Gupton were:

- (1) Mary "Polly" Gupton (married Thomas Hunter in Montgomery County, Tennessee, March 20, 1817)
- (2) Sarah "Sally" Gupton (married John "Jack" Pardue, Junior in Montgomery County, Tennessee, 1820-1821)
- (3) James H. Gupton (married l/Sarah Hale; 2/Martha Moke; 3/Margaret Dowling and had 2 children by first wife and 2 children by the third wife)
- (4) Abner Gupton, Junior (married Jane Batts in Montgomery County, Tennessee, May 19, 1844)
- (5) Judith Gupton (married Enoch Dozier)
- (6) Robert Thomas Gupton (married Martha Henrietta Power)
- (7) Elizabeth Gupton (married Matthew T. Hale)

I am a descendant of Abner and Judith (Hunt) Gupton through 2 of their daughters as follows:

Mary "Polly" (Gupton) Hunter (married Thomas Hunter, Junior, a son of Thomas and Priscilla (Smith) Hunter of Nash Co., N. C. Thomas Hunter, Senior was a Colonel in the Revolutionary War).

Abner Hunter (married Mary Ann Bell)

Fredonia Tennessee Hunter (married Henry Abner Pardue)

Sophia Bell Pardue (married John C. Zornes)

Edna Irene Zornes (married Oscar Lee "Tom" Cabler)

and

Sarah "Sally" (Gupton) Pardue (married John "Jack" Pardue, a son of John Pardue, Senior of Warren County, North Carolina. John Pardue, Senior (born 1760-70) was a brother to George Pardue, father of Littleton John Pardue. Littleton John "L. J." Pardue (born 1804) and my great-great grandfather, John "Jack" Pardue, Junior (born 1798) were first cousins)

Andrew Jackson Pardue (married Mary Catherine Felts)

Henry Abner Pardue (married Fredonia Tennessee Hunter)

Sophia Bell Pardue (married John C. Zornes)

Edna Irene Zornes (married Oscar Lee "Tom" Cabler)

Abner Gupton (born about 1761 in North Carolina) died on August 20, 1859 at about 98 years of age. He was buried near his home at the forks of Half Pone and Raccoon Creeks. His family cemetery has been located. His grave is not marked and cattle have roamed over his grave and the graves of his loved ones. This fact is a sad ending to this brief account of the life of Abner Gupton.

This once beloved man, a soldier of the American Revolution and the ancestor of many present day descendants, should not be forgotten. Therefore, I am preparing to obtain, if possible, a head stone to erect at the site of his grave. It is with hope in my heart that in the near future (perhaps during this year of 1974), I will be able with the help of Ann Pardue (Abner Gupton's great-great-great grand-daughter through his daughter Sarah "Sally" (Gupton) Pardue) and others to purchase and erect a suitable fence for the protection of the head stone and this Abner Gupton family cemetery.

The observance of our Bicentennial of American Independence is fast approaching and <u>now</u> would be an ideal and appropriate time to honor this and other Revolutionary War Soldiers. We will not be here 100 years from now when the Tricentennial is upon us and <u>time</u> waits for no one.

NOTE: Additional data relating to the genealogy and history of the Gupton and allied families is in the possession of Edna (Zornes) Cabler and may be furnished to individuals on an exchange of records basis or for a reasonable fee.

### 1836 MAP OF MONTGOMERY COUNTY

On 3 December 1835 the Tennessee General Assembly passed an act to provide for the laying off of the several counties into civil districts of convenient size under which Justices of the Peace and Constables should be elected.


James Reasons, William Trotter and Armstead Rogers were appointed commissioners to accomplish the districting for Montgomery County. On March 8, 1836 they recorded the results of their labors in Will Book G, pages 258-263. A copy of their plat appears on the following page, together with annotations derived from the accompanying plat narrative.

The district number and polling places are located, as well as the large water courses, roads, and towns. Residences named in the plat narrative are located.

District 11 and about one half of District 9 are now (1974) in Cheatham County.

### BENJAMIN MALLORY War of 1812

Benjamin Mallory was born Oct. 10, 1789 in North Carolina. He married Mary Williams on December 12, 1826 in Montgomery County, Tenn. Soon after this they moved to Robertson Co., Tenn. where he died August 20, 1851. He was a soldier of the War of 1812.

Mary (Williams) Mallory was born May 4, 1806 in Montgomery Co., Tenn. and died in Robertson Co. April 14, 1863.

One of their children was Capt. T. E. Mallory born Aug. 30, 1833 in Robertson Co. In 1861 he enlisted in Go. E Fifteenth Tennessee Infantry. He was appointed adjutant of the regiment at Fort Donelson and was taken prisoner there. He was exchanged after six months and was in the battles of Vicksburg, Raymond and Jackson. On November 27, 1865 he was married to Lecie A. Polk, daughter of James I. and Elizabeth Polk. She was born Sept. 25, 1842. Their children were Benjamin I. Mallory and Thomas L. Mallory.

Dr. James Mallory was born in North Carolina April 14, 1796. He immigrated with his parents to Tennessee in 1808. He married Sally Petty in Montgomery Co., Tenn. who bere him three children. The mother died in 1880 and the father is still living. (1886). One of their children was George P. Mallory who was born Mar. 10, 1841 in Montgomery Co., Tenn. He enlisted in 42nd Reg. Tenn. Confederate Inf. as a private and rose to lieutenant. He was captured at Fort Donelson. In 1870 he married Cornelia A. Newson. They had two children, James and George. In 1870 he lived in Cheatham Co., Tenn. (Cheatham established in 1856)

### JEREMIAH BROWN 1771 - 1838

of

### North Carolina, Tennessee and Missouri

Jeremiah Brown was born in North Carolina of Feb. 18, 1771 and died October 8, 1838 (Bible) on his land about one mile from Charleston, Missouri (County recores).

His first wife was Mary (Polly) Ann Ballard (acc. Rachel Brown Allen), born in North Carolina in 17 --. She signed papers on Oct. 4, 1847 and her administrator was appointed on January 3, 1848, so she propably died in December 1847. She was buried on the plantation of her son, James Brown in Montgomery County, Tennessee.

### Children:

1. James Brown born North Carolina August 29, 1793. He married Susanna Staley (acc. Eva Clark) who was born in North Carolina in 17--. She died in Montgomery Co., Tenn. in 1868. (Acc. to L. Bagwell her name was Susan.) James died of a respiratory ailment July 22, 1848 and is buried near his mother on his land now the Jesse Brown farm.

Children:

- a. Mary born Montgomery Co., Tenn. Oct. 2, 1817 and died July 13, 1898. She married Wylie F. Crotzer, son of Philip Krotzer from near Salisbury, N. C. - b. Mahala was born June 26, 1819 and died December 5, 1895. married Jesse L. Crotzer, brother of Wylie F., and in the 1850 census they had a son Wylie, 6 years old. Mahala Brown Crotzer is buried at Sango.

c. William G. Brown was born June 18, 1820 and died May 20, 1895.

- He is buried near his father on the Jesse Brown farm. Unmarried d. Jacob Brown was born Oct. 2, 1823 and died March 15, 1901. On Oct. 28, 1846 he married Nancy Funk, the granddaughter of Henry Funk 1780-1865 of Swiss ancestry who settled Lancaster, Pa. 1709, and Elizabeth Funk 1785-1863. On the 1870 census a daughter Mary 17 and son Andy 14 were listed. Also Sam was listed as farm laborer. He was ex-slave of Jeremiah Brown,
- who had been sold to James Brown. He is buried in Sango. e. Riley M (Mack) Brown was born Oct. 2, 1826 in Montgomery Co., Tenn., and died Apr. 30, 1910. His wife was Nancy?... A son, Jesse E. was born July 19, 1850 and died Jan. 14, 1908. They are all buried on Mack Brown's home place, now called the Tommy Connor farm.
- f. Andrew J. Brown was born about 1829 (21 on 1850 census) and he died about 1861. He is buried near his parents on Jesse Brown farm. He died unmarried.
- 2. Sarah (Sally) Brown was born in North Carolina about 1794. She married Phillip Short. In 1841 they were living in Davidson Co. Tenn. In the 1860 census she was living alone on McAdoo Creek, Montgomery Co., Tenn.

3. Mary Brown was born about 1795 (census) in North Carolina. She married Robert L. Brown (said to be a cousin), the son of Lockey Brown and his wife, Sallie. Lockey, who died in Montgomery Co., Tenn. in 1825, was living in Lunenberg Co., Va. in 1776, witness and landowner. In 1790 Va. census he lived in Surrey Co. with "4 white souls". His son Richard was born in Va., but Robert L. was born in North Carolina.

After his first wife's death he married Mrs. Elizabeth Staley Whitsett, a widow, born in Tennessee about 1803. She died in Illinois in 1888 and is buried at Stokes Chapel, White Co., Ill.

- Children of the second marriage: k. Mary "Polly" Ann born ca. 1835 died 1915. She married James Green Stokes. They had a large family.
- 1. Henry Craw Brown 1836 1898. Married Sarah Gamron. 8 Ch. m. Rachel born 1841 died 1893. Married Wm. Smith n. Malinda 1843 1915. Married Silas Elliott.

Archibald Brown died March 8, 1872 and was buried on his land, now Brown Cemetery, White Co., Ill.

6. David Brown was born in North Carolina on December 27, 1803 and died in Montgomery Co., Tenn on October 15, 1887. He married Amma Moody from Northampton Co., N. C. She was born April 16, 1803 and died August 15, 1882. They are buried in his cemetery on McAdoo Creek, Montgomery Co., Tenn.

David came with his parents from North Carolina to Tennessee some time before 1808, locating on McAdoo Creek. When his father died in Missouri in 1838, David was one of the administrators of Jeremiah's estate in Tennessee and Missouri. He and his brother, Nelson Brown, bought the shares of the other seven brothers and sisters. In the 1840 census, david and Nelson were living in Missouri, having gone there to probate their father's estate. In 1842 they sold the Missouri land. They also lived in Illinois for some years but returned to live in Tennessee.

David Brown spent many years as a Montgomery Co., Tenn. officer. He was a Magistrate, Justice of the Peace, and Deputy Sheriff.

In the 1850 census these children were listed: Elizabeth 17; Louisa 14; George W. 9; Jeremiah 8; Benjamin F. 6; and Angelina 2.

His son Jeremiah (Jeb) was born April 25, 1842 and died Oct. 18, 1900. He served 4 years in the Confederate Army. He received a wound that grazed his head, making a part in his hair. It did not seem serious, but later he went blind in his right eye. He believed that the wound cut an artery carrying blood to his eye. "Jeb" Brown married Eliza W. Smith, June 6, 1870, Clarksville. He is buried in the David Brown cemetery on McAdoo Creek.

David's son Benjamin F. Brown, born Sept 14, 1843 and died Jan. 21, 1912. Benjamin married Mary Trotter, born Jan. 6, 1850, and died Oct. 17, 1923. They are buried in David Brown's cemetery.

David Brown made his will in 1882. It was probated 1887. His property went to his wife and to his daughter Elizabeth Smith for reason of Elizabeth's excellent care of her parents. The other children mentioned in his will were Manervy Walls, Mary Jane Bagwell, Louisa Welker, Angeline Smith, Georgie Crotzer, Jeremiah, Benj. F. and grandson G. R. Smith. He mentions other grandchildre but not by names.

7. Nelson Brown was born August 3, 1808 in Montgomery Co., Tenn. and died there on August 14, 1885. He married Mary Foust, dau. of Jacob Foust, born N. C. 1809. She died 1883. They are buried in Sango Cemetery. Nelson was a Mason.

On the 1850 census his children were Henry 20; Green 18; Wm Riley 16; Sarah E. 13; Eliza A. 10; Mary A. 7; Finus 1. On the 1860 census another daughter, Indiana 5, was shown.

Nelson's son Henry was born August 1, 1829 and died July 29, 1909. The 1860 census gives his wife, Emeline 25 and his children Ann 5; John 2; and Mary 1. He remarried and the 1880 census gives

his wife as Hattie 33 years old. Henry is buried at Sango.

Nelson's on Green Brown was born May 23, 1831 and died on August 5, 1891. He married Mary G. Albright at Clarksville, Tenn. on Oct. 17, 1867. She was born Sept. 22, 1838 and died Oct. 28, 1896. They are buried at Sango Cemetery. Acc. to Mr. Burton of Sango, the Clarence I. Brown Family buried at Sango and many of the Browns buried at Oak Plain (nearby) are descendents of Green Brown.

Nelson's son, William Riley Brown, was born 1834 and died in 1904. He married Amanda Stephans at Clarksville, Tenn. on Dec. 15, 1859. She was born 1838 and died 1923. The 1870 census gives their children as Jesse 10; Columbus 8; Elizabeth 6; Sue E. 4; and Robert 3. The 1880 census shows also Mary V. 10 (she died 1902); Francis 8; and Marthy 3. Wm R. and Amanda Brown and some of their children, including a son, Arthur, are buried in a choice lot of Greenwood Cemetery, Clarksville, Tenn.

Nelson's daughter, Indiana was born June 23, 1854 and died Sept. 22, 1887. She married J. D. Wall.

Finus E. Brown was born in Montgomery Co., Tenn. on November 30, 1848. He had married, but left no children. He is buried at Sango. He died about 1938 but there is no death date on his tombstone. Finus was probably the last surviving grandchild of Jeremiah and Mary Ballard Brown.

8. Elijah Brown was born Oct. 22, 1810. He married Elender Stack who was born in S. Carolina in 1805 and died in Ill. in 1870. He died in Illinois Sept. 10, 1877 and was buried on his own land, now Bryant Cemetery, White County, Ill.

The 1850 Ill. Census lists his children as James R. 16; Caroline 14; Mary A. 12; William 10; and John Wes. 8.

9. Nancy Brown was born about 1813 (census). She married John C. Burney on Dec. 29, 1847, who often signed Jack C. Burney. They had a son Jeremiah who died at the age of 10 of scarlet fever.

Another son Jake (24 on the 1880 census) married Nancy ----. She is buried in the Welker Cemetery, Montgomery Co., Tenn. According to her grandson, J. W. Burney, Nancy Brown Burney died about 1886.

Jeremiah went to Southeastern Missouri before 1830 and lived there with his second wife, Eleanor Stuart Brown.

#### WILLIAM HANKINS

William Hankins was not long a resident of Montgomery County, Tennessee, but somewhere in that county, he lies buried, the date sometime before April 19, 1824 when James Fentress appeared in court with letters of administration of William Hankins estate. William probably came to Montgomery County between 1811, at which time he is recorded in Humphrey County deed records, and 1817 when he became constable in Montgomery County. His name is on the 1820 Montgomery County census.

Montgomery County records list settlement of William Hankins estate, sale of household goods, a year's provision ordered for his widow, Wilmoth Hankins. Some of these items were: forty pounds of coffee, one hundred and twenty-five pounds of sugar, ten bushels of salt, 1,200 pounds of bacon, sixty-five barrels of corn. In 1830, Wilmoth Hankins continued to reside in Montgomery County and her son Carter Hankins is also listed on the census for that year. Carter Hankins and his brother Harrison Hankins in 1832 sold a tract of land in Montgomery County, it being part of land alloted to the widow Hankins as her dower. 4 Although this sale is on record, earlier records of this land have not been located at this time.

Related to the Hankins family through marriage of William Hankins children were an Austin and Wells family. The Austin family was related through the marriages of Fountain C. Austin to Polly Hankins and Lucinda Austin to Carter Hankins. David Wells married Nancy Hankins. David Wells, Jones Wells and David Austin were present in 1824 when William Hankins household goods were sold. Few records have been located at this time for David Austin in Montgomery County, however, he is listed on the 1820 Dickson County census and David Wells is listed on the 1820 Humphrey County census.

By 1836, the Hankins family were living in Haywood County and in 1838 Wilmoth Hankins died in that county. Her non-cupative will is recorded there, naming her children: Carter Hankins, Harrison Hankins, Polly Austin, and Nancy Wells. Before 1850, Carter and Lucinda Hankins, Harrison and Rebecca Hankins, and David and Elizabeth Austin, Fountain C. and Polly Austin, all moved to Drew County, Arkansas. Children of Nancy and David Wells moved to Drew County.
