McReynolds Funeral Home was first located in the First National Bank Building under the name of T. E. McReynolds and Son Furniture and Undertaking.

These old records are hard to read, some barely visible. The pages are yellowed and torn. There are no words to describe the handwriting. The records were made available to me by Mr. John Stanley, my brother-in-law, and Mr. Jim Harpel of McReynolds Funeral Home.

The first page of the 1898 records is missing. Also, some 1897 records are mixed in with the 1898 records. Each date does not have the year listed. The year is marked on each page. The following are on pages marked 1898. I have checked some of them and the tombstones read 1897. (NBM)

SOLDIERS FROM MONTGOMERY CO. TENNESSEE
in the
REVOLUTIONARY WAR and THE WAR of 1812

WILLIAM PACE JUNIOR - War of 1812

William Pace, Senior, born 1740-1750, lived in North Carolina as late as 1789-1790 and moved to Tennessee as early as 1803. On Nov. 26, 1803 he was "of Davidson Co., Tenn." when he purchased 100 acres of land from Absalom Hooper, Senior. The land, located "in Robertson Co., Tenn., on the North side of Cumberland River, about 8 miles from said river on the Waters of Half Pone Creek, it being part of 640 acres whereon James Hollis lived and adjacent to land of Ann Choats." This deed was recorded on July 22, 1805 in Deed Book F, pages 64-65, Robertson Co., Tenn.

On October 4, 1805, William Pace, Senior, "of Robertson Co., Tenn." added to his first purchase of land by purchasing 100 more acres from Jos. Choate "it being a part of a tract of 640 acres originally granted by the State of North Carolina to James Hollis and a part thereof conveyed to Joseph Choate by said Hollis. Number of Grant #185, bearing date March 17, 1786, being in Robertson Co., Tenn. on the waters of Half Pone Creek. (See Index to Deed Book A (1788-1796) Montgomery Co., TN. page 16. Deed from James Hollis to Ann Chote; page 59, Deed from J. Hollis to Joseph Choate.) The deed from Joseph Choate to William Pace, Senior, was recorded in Robertson Co., Tenn. court at its April Term 1808.

On January 8, 1817, William Pace, Senior, sold 61 acres of this land to Allan (Allen) Hunter "of Montgomery Co., Tenn." and this deed is recorded in Montgomery Co., TN., Deed Book I, page 777 on Jan. 6, 1832. William Pace, Senior, sold 151 acres of this land to Matthew R. Hunter of Robertson Co., TN. (Deed Book X, pages 334-335 Robertson Co., TN)

William Pace, Senior (1740-50 -- 1845) wrote his will on November 6, 1829. It was proved in Montgomery Co., Tenn. court at its October term 1845 and recorded in Will Book J, pages 453-454 Montgomery Co. Tenn. The name of William Pace Senior's wife is not known by Edna (Zornes) Cabler at this time (March 4, 1974) but an extensive effort of research is being made in the early Edgecombe County, N. C. court records for possible proof that her maiden name may have been Cain. She died between 1820 Robertson Co. Census for William Pace, Senior and before the writing of his will (November 6, 1829).

The heirs of William Pace, Senior (1740-50 -- 1845) are listed in his will of Nov. 6, 1829 in the following order:

Dau: Patience (Pace) Williams; son: Joel Pace; Heirs of Patsy Harris
Dau: Sally (Pace) Davis; Son: Henning Pace; Son: William Pace;
Son: John Pace; Son: Hardy C. (Cain) Pace; Dau: Cally (Pace) Shaw;
Son: Dempsey Pace; Granddaughter: Sissity McGraw; Grandson: Uriah McGraw;
Granddaughter: Elizabeth McGraw; Grandson: Archibald McGraw;
Dau: Mary (Pace) McGraw; Grandson: Christopher S. Pace;
Grandson: Edmund A. Pace; Son: Gideon Pace.

Notes by Edna Zornes Cabler: Alsey Pace, son of William Pace, Senior, married Sarah (Sally) Stump August 17, 1808 in Davidson Co., TN and died by 1815. Christopher Stump Pace and Edmund A. Pace were sons of Alsey Pace and Sarah Stump Pace.

The given names of the husbands of Patience (Pace) Williams, Patsy or Martha (Pace) Harris and Mary (Pace) McGraw are not known by me. It is said that Gideon Harris was the husband of Patsy or Martha Pace Harris. I would appreciate hearing from anyone who might know about these men and their descendants.

Sarah "Sally" Pace, dau. of William Pace, Senior, was born in N. C. about 1772 (age 78 in 1850 Robertson Co. Tenn. census) She married John Davis February 28, 1803 in Davidson Co., Tenn.

Cally Pace, dau. of William Pace, Senior, married James (Jim) Shaw, son of Thomas Shaw, Senior, and Sarah (?) Shaw.

Hardy Cain Pace, son of William Pace, Senior, was born in N. C. about 1789-1790. He married Martha Nicholson, daughter of Britain Nicholson and Mary (Molly) Harris Nicholson.

ED. NOTE: See Bible Records of George Washington Pace in this issue.

Gideon Pace, son of William Pace, Senior, married Martha Hunt.

John Pace, son of William Pace, Senior, was born about 1785. It is said he married a Hunt (Sarah?), "sister of Levi Hunt?"

Joel Pace, son of William Pace, Senior, moved to Haywood Co., TN and died there. The name of his wife is not known.

Henning Pace, son of William Pace, Senior, married Martha Bradshaw March 25, 1800 in Davidson Co., TN.

WILLIAM PACE, JUNIOR

son of William Pace, Senior, was born in North Carolina July 16, 1778. He married Martha "Patsy" Shaw (born in North Carolina January 7, 1784, daughter of Thomas Shaw, Senior and Sarah (?) Shaw) "on or about the 29th day of January A.D. 1807 by William Connell, JP in Robertson Co., TN". William Pace, Junior, "died on or about the 18th day of October A.D. 1835 at his home in Robertson Co., Tenn." (in Thomasville community now in Cheatham Co., TN.) The references to the birth dates are found in the family Bible which belonged to William Hackney Pace (born 28th July 1821--died April 25, 1900), son of William Pace, Junior and Martha "Patsy" (Shaw) Pace. The references to marriage of William Pace, Junior and Martha Shaw Pace and to death of William Pace Jr. are found in his widow's application for Bounty Land to which she was entitled (1855) through his service of War of 1812. (William Pace-Bounty Land Warrent #76658-160-55-War 1812) (Order from Military Service Records NNC S, National Archives GSA, Washington, D.C. 20408..Cost \$2.00)

According to his widow's declaration William Pace Junior (born 1778-died 1835) was "a private in the company commanded by Captain Benjamin Elliott in the 1st Regiment of Tennessee Mounted Men commanded by Colone Archer Cheatham in the War with the Hostile Indians. He volunteered at Springfield, Tenn. on or about the 13th day of May AD 1812 during the war and continued in actual service in said war for a term of 17 days and

was honorably discharged at Springfield, Tenn., on or about the 28th day of May AD 1812". James Stewart and Daniel Sanders residents of Robertson Co., Tenn, upon their oaths, declared on April 14, 1855, that they were personally and well acquainted with Martha (Shaw) Pace and her husband, William Pace during his life time and that they were persons of the highest respectability and standing in their community and had reared a large family of children who were all grown up (in 1855) and respected citizens. James Stewart and Daniel Sanders further stated that William Pace actually performed the War of 1812 service for they were in the service with him." The War of 1812 service of William Pace is also found in the Manuscript Section, Tenn. State Archives on page 1777, War 1812 Compiled List of Soldiers and Officers, Sheet Numbers 1701 - 1800 and his Branch of Service is listed as " 5th Brig. Mounted Infantry." He and his brother Dempsey Pace enlisted the same day, May 13, 1812 under Lt. Col. Archer Cheatham and were the first sons of William Pace, Senior to enlist in the War of 1812. Other sons of William Pace, Senior in the War were in order of enlistment:

Alsa Pace, Private. Enlisted December 10, 1812. Commander Col. John Coffee and Capt. Frederick Stump. Branch of service Cavalry

Hardy (Cain) Pace, Private. Enlisted Oct. 1, 1813. Under Col. John K. Winn and Capt. Bayless Prince (A Montgomery Co., Tenn. Unit). Branch of Service - Infantry (Hardy C. Pace applied for Bounty Land Claim. National Archives file designation BLWT #44123-120-55 War 1812)

Gideon Pace, 3rd Corporal. Enlisted Oct. 1, 1814 Under Col. John K. Winn and Capt. Bayless Prince. Branch of Service-Infantry.

John Pace, 4th Sergt. Enlisted Nov. 13, 1814. Under Col. John Cocke and Capt. John Weakley. Branch of Service- Infantry. (John Pace applied for Bounty Land 1851 and 1855 while living in Panola Co., Texas. National Archives file designation BLWT 29185-80-55 War 1812. He died Dec. 1859 in Montgomery Co., Tenn. at age 72.)

Children of William Pace, Junior (1778-1835) and Martha "Patsy" (Shaw) Pace (1784 - died after 1860 Cheatham Co., Tenn Census) were:

1. Mary "Polly" Pace. Married 1. Owen Hudgens 2. James "Jim" Maxey
2. Thomas Pace. Married Martha Miles
3. "Lovina" or Lavinia Pace married James Nicholson
4. Cassie Cain Pace married Jacob Shores (Notice the given name CAIN appears again in the William Pace, Senior family and further strengthens the supposition that CAIN may have been the surname of William Pace, Senior's wife. EZC)
5. Joel W. "Joe" Pace married Mary "Polly" Davis.
6. William Hackney Pace married Judith Pardue, dau. of John "Jack" Pardue (1798-1865) and Sarah "Sally" (Gupton) Pardue.
7. Martha J. Pace married John W. Pardue, son of John Pardue and Sarah Gupton Pardue.

8. James H. Pace married Catherine "Kitty" Bigger(s).

9. Elizabeth "Betsy" Pace married Henry R. Felts. She was born about 1819 (age 31 in 1850 Census). She married Henry R. Felts in 1839. Their first child, Mary Catherine Felts (1840-1930) married Andrew Jackson "Andy" Pardue, son of John Pardue (Jack) (1798-1865) and Sarah "Sally" Gupton Pardue, in 1859. She was the mother of Henry Abner "Black Ab" Pardue (1863-1929). Henry Abner Pardue married Fredonia Tennessee "Tennie" Hunter (1865-1947). They were the parents of Sophia Bell Pardue (1900 -). Sophia Bell Pardue married John Carlyle Zornes (1892 - 1964) in Cheatham Co., Tenn., June 10, 1916. They were the parents of Edna Zornes born March 21, 1917, married Oscar Lee "Tom" Cabler on Aug. 12, 1939.
