## THE INGRAM FAMILY

## by Dibmold Inorgan Dibrell Ingram

Our bunch of Ingram's seem to descend from John Ingram, who was living in Northumberland County Virginia in 1645. He owned a ship and transported many people across the Atlantic to Virginia. He became wealthy in money and land. His will is on file in Northumberland County. He died in 1654. He had Jane, Thomas and Elizabeth.

Thomas Ingram born in Northumberland County in or about 1654, died in 1707. He married Katherine Winter by 1671 and they had John, who married Ann Sisson, Thomasine married a Parker, Charles born 1670-80 married Elizabeth Daveron and Mary ---- Died 1760 in Northumberland County. His will is dated 1754. They also had Abraham (living in 1716).

Charles and Elizabeth had John, Samuel, George, Charles, Joseph, a daughter that married a Gill, Grace, Mary, Benjamin and Bartholomew.

John, born 1700, married Hannah Pines and moved into that part of Spotsylvania County that later became Orange, in 1733. He moved from Orange to Brunswick County in 1741. Here he acquired over 5000 acres of land. His "Manor Place" was in Meherrin Parish. He died in 1763. I have a copy of his will.

John and Hannah had these children: John Jr., Jesse, Joshua, Richard, Benjamin, Joseph, and Elizabeth who married Reuben Vaughn and Tabitha married William Gee.

Richard Ingram, through whom our line descends, was born about 1742, married about 1764 and died in 1788. His wife was ----- He left no will. I have a copy of his inventory. Joseph Yarbrough was appointed Guardian for his orphan children in 1792, with the approval of the Court and Joshua and Mary Ingram. The minor children in 1792 were: Lucy, Sterling, John and Betsy Ingram.

I first find Sterling Ingram at Greenville, S. C. in 1799 when Joshua sold 4 slaves to Jesse Carter. Sterling witnessed this sale and later married his sister, Mary Carter about 1805. They had a son Jesse Carter Ingram, born in 1806, and died at St. Joseph, Mo. in 1872 - a wealthy man. I visited St. Joseph in 1974 and visited his grave and old home and saw some of his people. He married at Dover, Tennessee about 1831 and had two girls. They died as young children. He married the second time to Margaret Kay of Christian County, Ky. in 1833 and they had a daughter, Margaret Cornelia born at Dover. She died at St. Joseph in 1916. I visited her grave.

Jesse Carter Ingram was a merchant at Dover, Tenn. from about 1830 to 1850, when he sold out. The firm was Ingram, Kay and Lee. In 1851 he moved to St. Joseph and again went into the mercantile and land business. He really prospered this time and retired in 1856 a wealthy man. His daughter, Margaret Cornelia, married James C. Roberts in 1855. They had 4 sons. The eldest, Jesse Ingram Roberts, married a Donovan. His daughter, Jessie Ingram Roberts, taught mathematics in

the St. Joseph high school for many years. Another son, John Donovan Roberts, was city auditor. I visited his wife. He had been dead about 10 years. She was a gracious lady and I had several letters from her. I have also corresponded with their son, Jesse Richardson Roberts, of the Miss. Highway Dept. at Jackson, Miss. They seem to be the kind of people that my people can be proud of. They had quite a lot to do with the "Growing Up" of St. Joseph.

Next I find Sterling in Montgomery County, Tenn. where he married Elizabeth (Betsy) Gordon Jan. 25, 1808. He died there in June 1823. They had these children: Richard born 1810, girls Lucy, Mary, and Elizabeth born from 1812 to 1818, Alexander Gordon born 1820 and Sterling Sebastian born 1823. Lucy Ingram married Isaac Burns and had children Musadora and Peter.

After Sterling died I find Elizabeth and her children in Stewart County, near Dover, from 1829 until about 1859. She must have died about that time and they began to move away.

In 1850 census Elizabeth, 65, was living with her son Sterling Sebastian Ingram. Her mother, Wildren Gordon, 92, and born in Virginia was also living with him. The 1850 Census shows: Sebastian Ingram, 27, T; Susan, his wife, T.; Benjamin, 4, T; Mary Bell, 2, T. The 1860 Hickman County, Ky., Clinton District, Clinton, Ky. shows: S. S. Ingram 35 T; Benjamin S. 14 T; Mary Bell T; Alexander N. 9 T; and Carter P. 6, T. In 1870 New Madrid County, Mo. Census, Big Prairie Township, page 1, shows: S. S. Ingram 47 T; Sarah 38 (second wife) Ky; Alexander N. 19 T; Carter P. 16 T; Emma 11 Miss.; and probably a daughter of Richard, Louis 10 Ky; Lucy 6 Ky, Sarah 5 Ky; and Louisa 3 Ky. I did not find this family after 1870. I did find Alexander N. and his family in the Fulton County, Ky. Census of 1880, but have never contacted any of them.

Richard Ingram was born in Montgomery County, Tenn. in 1810. The 1850 Census of Stewart County, Tenn. shows: Richard Ingram 40 T; Eliser, his wife, 34 S. C.; Mary 14 T; Levina 12 T; Jesse 10, T; Elizabeth 8 T; Peny 6 T; and Quintas 2 T. He married a second wife, Frances Chester, April 15, 1854. I never found this family after this. His son Jesse fought in the Civil War, married Lydia Cunninghan, and died in 1869. He left one daughter and that part of the family ran out a few years later.

Alexander Gordon Ingram was born in Montgomery County, Tenn. in 1820. He married Mary DeWitt Walker in Stewart County on Nov. 30, 1841. I think she was the daughter of Alexander Walker. Her brother, Dr. Joseph J. Walker, was an early doctor at Hot Springs, Ark., coming there in the early 1880's. He is buried in Hollywood Cemetary, having died in 1903. His wife, Margaret J. died in 1932. Their son, Dr. DaCosta Walker died in 1923 without heirs.

Alexander Gordon and Mary DeWitt Walker Ingram had 14 children -- the last seven being boys. They left Tenn. about 1844 and lived in Johnson County, Ill. until about 1850, when they came to Arkansas, and settled at Ingram Springs in what is now Faulkner County. She died in 1880 and he in 1892. They are both buried at Ingram Springs.

#### JAMES FENTRESS - Revolutionary War

James Fentress; 1832 list age 70; also 1840 census; served in N. C. line; drew pension in Montgomery Co. (TWENTY-FOUR HUNDRED TENNESSEE PENSIONERS-REVOLUTION-WAR OF 1812 by Zella Armstrong page 42)

James Fentress (1763 - 1843) House, 8th, 9th, 10th, 11th, 12th, 13th, 14th and 15th General Assemblies 1809 - 25. Represented Montgomery, Humphreys, and Stewart Counties in 9th; Montgomery County alone 10th thru 15th inclusive. Speaker of House 11th, 13th, 14th, and 15th sessions 1815-17, 1819 - 25. Born in Hanover County, N. C. Feb. 16, 1673 (error. Should be 1763); son of James Fentress. Schooling described as "quite limited". Came from North Carolina, 1798; settled on Yellow Creek, Montgomery County, to engage in farming. First married Barbara Wells; their children, born in North Carolina were: William, Absolom, Douglas, a daughter whose name was not found, David born in Tennessee. First wife died in 1804. Second marriage in 1810 to Anna Read. Children: John, Wiley Blount, and a daughter name not indicated. Date and exact place of neither marriage found. Chairman Montgomery County Court 1808; one of commissioners to develope proposed town of New York, Montgomery County, 1818; named one of commissioners to select county seats for Haywood, Carroll, Gibson and Weakley Counties. Fentress County and its seat of government, Jamestown, named in his honor, 1823; presidential elector, 1836 on Democratic ticket of Martin Van Buren and Richard M. Johnson. Died at Sailor's Rest, Montgomery County, June 20, 1843; buried at that place.

This would be the right age for his son Wiley Blount Fentress. Many times in the old records Wiley is spelled WILLIE. (AWD)

#### MOSES COLLIER - War of 1812

"He served for a short time in the War of 1812 with Capt. William Bolling's Goochland Volunteers Troop of Cavalry from the 56th Regiment. Virginia Militia stationed at Camp Fairfield, Va., and the records indicate that his organization was from Nottaway Co., Va. His record was from Aug. 23rd to Sept. 3rd 1814." Foot Prints - 1660 - Collier 1965 by James Baker Collier.

William Moses Collier, son of Moses (Revolutionary Soldier-Va.) and Nancy Blanks (m. 1Aug 1769), married Angeline Agnes (or Evangeline) Cross b. 1780, daughter of Charles Cross (1747-1785) (Revolutionary War from Va.)

Moses Collier and his wife had come from Virginia to Mississippi to Montgomery County, Tennessee by 1820. They moved back into Mississippi and back to Montgomery Co., Tenn.

Willie Blount Esq. records his stock mark viz. a Crop and Two Splits in each ear.

The Jury that was appointed last term to view and mark a road from the fork of McAdow Road to Parsons Creek returned to this term that they had done the same.

Josiah Fort is appointed guardian to Mathew Mills Murphey in place of John Sherrod gave bond with Robert Prince and Joseph Robinson his securities.

On Motion, ordered that John Baxtor Deputy Sheriff for Montgomery County be allowed and payed by Treasurer for s'd County the sum of Forty Dollars and seventy four cents for expenditures and services in keeping and executing a Negro Man Slave Moses.

Bill of Sale Wright Outlaw to William C. Jamison for a Negroe Boy named Virgin was acknowledged in open court and ordered to registration. (166)

John Wilson vs John Criswell --Case. Jury: 1. William Corlew 2. William Good 3. David Linch 4. Joshua Weakley 5. David Brigham 6. Joseph Dickson 7. William A. Gibson 8. Josiah G. Dukes 9. Dennis Rushing vs Wright Outlaw - Trover. Samuel Luton a witness proves four days, one hundred and forty miles riding and four ferriages in the above suit.

Benham vs Loggins - Tresspass. Reuben Loggins a witness proves nine days and six ferriages in the above suit. George Moore proves 8 days, six ferriages.

Benjamin Mason vs Jessee Watkins - Certe'a?. William Weakes a witness proves ten days attendance and six ferriages in the above suit.

Court adjourned for one hour.

A motion made in the case of Christopher Stump surviving partner to Christopher & Jonathan Stump vs Benjamin Weakley, David Weakley & John Weakley, that the death of David Weakley should be sayed? of record the same was refused a Writ of Error prayed on behalf of the defendants. Ordered that the above motion be exponged. (174)

25 Deed of Conveyance - Samuel Craft to George West was proven in open court by the oaths of Wright Outlaw & P. W. Humphries, subscribing witnesses thereto for 320 acres.

Court adjourned untill tomorrow at 9 0'Clock.

The Worshipfull Court of Montgomery County have met according to adjournment Thursday April 16th 1807. Present the Worshipfull Robert Prince, James Fentress and Joseph Robinson Esquires.

State vs Dempsy Kennedy - Indictment. The Defendant in this case being solomnly called & came not therefore it is the oppinion of the Court he has forfited his Recognizance & orders Sissa (Sipa? Sifa?) to issue against him to next term. James Tribble, Goodman Trawick the securities in the case of the State against Kennedy were both solomnly called to bring forth the body of Dempsy Kennedy as they were bound to do & came not therefore. The Court are of oppinion that they have forfited their Recognizance & that Sifa? Issue to next term.

Bill Sale: Nathanial Jefferis to James Jefferis acknowledged in open Court for Eleven Negroes & ordered to be registered.

William Hubbard vs Aaron Fletcher. January Term 1816. Pleas before the Honorable John Overton & Archibald Roane Judges of the Supreme of Errors & Appeals of the State of Tennessee in the fifth Judicial Circuit at the Court House in the Town of Clarksville on the fourth Monday being the 22nd day of July in the year of our Lord 1816 and of the Independence of the United States the 41st.

Be it remembered that heretofore to wit; on the 27th day of March 1811 a Bill of injunction was filed in the Clerks office of this Circuit Court of Stewart County which Bill is as follows to wit;

To the Honorable the Judge of the fifth Judicial Circuit of the State of Tennessee setting in Equity for the County of Stewart Humbly complaining sheweth unto your Honor your orator, William Hubbard of Stewart, That on the 26th day of March 1811 Aaron Fletcher of said County obtained a Judgment in the Circuit Court of said County against your complainant for the sum of Eighty Six Dollars or thereabouts and Costs on a note of your complainant to said Fletcher for the sum of Eighty Six Dollars dated the 5th day of January 1809 and payable the 25th day of December 1809. Your complainant avows that the aforesaid Judgment is one which in Justice and Equity he ought not to be compelled to pay inasmuch as your complainant received no valuable consideration whatever from said Fletcher for said note and as the same was abtained by said Fletcher from your complainant by an act of gross fraud and oppression. Sometine in the month of November or December 1808 your complainant & other persons at the United States \* Salt Works took up a Negroe man & woman who were said to be runaway and to belong to one Richard J. Cocke of Maury County in this state. Your complainant brought said negroes home with him and leaving them at his house went to the house of said Richard Cocke where said Cocke after being informed that said negroes were there at the house of your complainant agreed that if your complainant would at a day then appointed deliver said Negroe woman to him said Cocke at Bryants Tavern on Sycamore in Robertson County and pay him one hundred & fifty

dollars that he (said Complainant) should have and be entitled to said Negroe man, but should be bound to convey him out of the State before entering into said agreement. Said Cocke stated unto your Petitioner that he had offered to give the negroe man to anyone who would bring the woman home and that said Negroe man had behaved so badly that he would not suffer him to come to his house again. After your complainant returned home he had some conversation with said Aaron Fletcher relative to the sale of said Negroe man him and informed said Fletcher of the agreement he had made with said Cocke, but not being able to make contract with said Aaron on terms satisfactory to your complainant he (said Complainant) on or about the 8th? (blot) day of January 1809 st sold said Negroe man to one Simon Fletcher. On or about the 4th day (blot) -- y 1809 your complainant set out with said Negroe woman to meet said Cocke in pursuanc-(blot)-appointment & went the first day as far as the house of Col John Cocke in Montgomery County. Said Aaron who lives near your complainant went with your complainant as far as the house of said Cocke, alledging before they set that he was going to Clarksville and after they were on the way, alledging that he was going to meet said Richard Cocke in order to buy said Negroe woman of On the next day when your complainant was about setting out from the house of said John Cocke on the prosecution of his journey the said Aaron said he had declined his intention of going farther and would return home. But after your complainant had proceeded a few miles on his journey he was uxexpectedly overtaken by Aaron who then stated to your complainant that he was going to Nashville to enter a piece of Your complainant now growing suspicious charged said Aaron with an intention of going on before him to said Richard Cocke and defeating or injuring said Camplainant in the business in which he was then engaged which your complainant believed it to be in the power of said Aaron to do, inasmuch as he could travel much faster than your complainant incumbered as said Complainant was by the Negroe woman whom he had in charge and as there then was no written agreement whatever between said Richard Cocke and your complainant & no one but the wife of said Richard was present at making the agreement aforesaid.

On being so charged said Aaron acknowledged that this was his intention and swore that he would defeat said Complainant in said business at the --gue? (blot) of One Thousand Dollars as well as said complainant recollects the sum, and stated shewing your complainant a paper which he had in his hand and refused to let the complainant take, that he had a letter from John Cocke to said Richard Cocke his cousin requesting said Richard not to perform his contract with your complainant untill he had come and seen said John. And that he said Aaron was then going on to purchase said Richard said a Negroe Man and asked of your complainant to whom would he look for his reward, if he said Aaron should get a Bill of Sale from said Richard for said Negro. While using these threats said Aaron took care to shew his power of outtravelling your complainant by riding on fast before him.

At length the said Aaron proposed to your complainant that if he would give him One Thousand Dollars, and afterwards that if he would give him Eighty Dollars that he would suffer him to go on in said business without interruption and enforced said proposition by a repitition of his aforesaid threats. Your complainant thinking he had no other means of preventing the execution of said threats at length executed the aforesaid note for eighty dollars on which said Judgment was founded, which note your complainant positively charges was given to said Fletcher for no other consideration whatever than to prevent the execution of the aforesaid threats. At the time of executing said

note your complainant received from said Aaron a paper under his hand and seal which is as follows to wit, "This is to certify that where as Aaron Fletcher was about taking a underhanded advantage of William Hubbard in a trade of Negroes that said Hubbard had of Ric'd J. Cocke of Maury County the said Fletcher bind himself in the sum of 200 dollars not to meddle nor interfere(th?)(blurr) in given my hand and seal 5th January 1809 Aaron Fletcher (Seal) Teste Wm Andrews" which said writing of said Aaron is hereunto annexed as an exhibit. Your complainant further: states to your Honor that he indeavoured to pr--- (blot) the aforesaid circumstances on the trial at Law but the testimony which he offered to this effect was adjudged as h(blot)informed? to be inadmissable there, and he is advised that in a Court of Law he cannot in the manner aforesaid impeach the consideration of said note.

For as much therefore as your complainant is without remedy except in a Court of Equity where matters of this sort are properly cognizable and relieviable, and to the end that said Adam Fletcher may be made Defendant h--(blot) may as true full and perfect answer make to all and singular the matters herein set forth as if the same were repeated and he interrogated them? and that the said Aaron may be injoined from all farther proceedings on said judgment (the lower left hand corner of the page is torn. In microfilming the torn portion was not placed in line with the rest of the page, making it almost impossible to read) at Law untill? the matter can be heard in Equity and further decree of this Honorable Court shall be had there? and that said Injunction maybe rendered perpetual and that your Complainant may have s --? other and further relief as to your Honor may seem fit and required by the nature of his case. May it please your Honor the premise considered to grant your complainant the States Writ of -- unction etc? and also the Writ of Subpoena etc. commanding etc. And your Orator shall wer--- etc. Minor for the Complainant.

Humphries, Judge of said Circuit & made oath that the matters in this Bill so far as they are stated of his belief he believes them to be true. "William Hubbard" Sworn to & subscribed before me this 27th March 1811. P. W. Humphries, Judge

Let--(blot) of Subpoena & Injunction issue agreeable to the prayer of this Bill on the Complainants giving Bond of Security to the amount of the Judgement & Cost recouvered at Law & which is prayed to be injoined. P. W. Humphries Judge of the 5th Judicial Circuit"To the Clerk of the Court of Stewart County" (Aaron Fletchers statement signed above is recopied here)

To which the following Answer was filed in the office aforesaid on the 25th September 1811 (?? (blot) as follows to wit:

The answer of Aaron Fletcher to a Bill of Complaint exhibited against him by William Hubbard of Stewart County humbly sheweth unto your Honor that your respondent now and at all times reserving to himself the beneift of the many inaccuracies, mistatements & untruths exhibitted in the said Bill of Complaint answerth and saith that he admits he obtained a judgment against the Complainant at the place & time & for the sum stated in said Bill, but denies that the note on which that judgment was bottomed was obtained from said complainant through fraud or imposition but on the contrary expressly avers that a full consideration was given for the same by this respondant to the complainant,

which consideration was in substance following, The complainant William Hubbard had agreed with this respondent respecting the sale of aNegro man for a stipulated price and afterwards ascertained that he could dispose of the said Negroe man to a third person on more advantageous terms, that the complainant in consequence of the respondants relinquishing his bargain aforesaid connec-(edge of page torn) with certain services which the respondant rendered to the said Complainant in aiding and assisting him to convey a Negroe Waman from the County of Stewart to the County of Robertson, executed and delivered said note to this respondent in good faith and for the said herein stated.

This complainant further answering saith that he utterly denies having made use?(blots)of threats & --(blots)--ed in the said Complainants Bill while -(margin torn) respondent was at the house of (blots) or at any time previous or after that & with? (margin torn) deference would insist that even if the consideration of said note had been as the complainant avers which however this respondent denies in toto that this respondent should forbear purchase said Negroe man of said Rich'd J. Cocke still that it would have been a consideration valid both in Law & Equity & this respondent is somewhat supprised that this should have been one of the items of the charges exhibitted against him.

Further answering this respondent denies although he does not conceive it necessary that he attempted to frighten the complainant by shewing the superior speed and prowess of his horse and that he had it in his power thereby to defeat the objects of the comp'lt respecting the purchase of said Negroe. On the contrary this respondent avers that he made use of no art, intrigue or device calculated to impose on the complainant or to force from him the note before alluded to.

With respect to the receipt or certificate which is made an exhibit in the said complainants Bill the respondent answers & says, that he did sign a piece of writing purporting as this respondent believed from its being read to him, for this respondent did not read it himself, that he this respondent bound himself in a penalty of \$200 to relinquish the bargain he had made with the complainant relative to the purchase of said Negroe man and not to interfere with said Complit in any arrangement which said complainant might make with said Richid J. Cocke respecting the purchase of said negroe man, but this respondent expressly denies having intended to acknowledge that he was about to take an unlawful advantage of said complainant and that he never knowingly signed a writing of that import.

This respondent prays your Honor to dessolve the injunction in this case, and by decree to compell the complainant to pay the said Judgment obtained in a Court of Law together with his interest & cost and to do such other things in the promises as to your Honor may seem meet and proper, & to dismiss the said Bill of Injuction with costs and your respondent will pray etc.

This repliant now and at all times saving & reserving to himself all manner of advantage of exception to the manifold insufficiencies of said Answer for replication thereto saith that he will aver & prove his said Bill true certain & sufficient in law to be answered unto and that the said answer of the defendant is uncertain, untrue and insufficient to be replied to by this repliant without that, that any other matter or thing whatsoever in said answer contained material or effectual in Law to be replied unto, confessed and averred, Traversed or denied is true, all which matters & things the repliant is and will be ready to aver & prove as this Honorable Court shall de-t (blot) & humbly prays as in & by his sd Bill he has already prayed. Minor for complainant.

And at the present term of this Court on the 26th day of the month a final decree will made in said cause which decree is as follows to wit:

William Hubbard vs Aaron Fletcher, Injuction Bill in Equity. Upon hearing of this cause and upon hearing the testimony produced & mature consideration had theron by the Court, it is ordered adjudged and decreed that the said Aaron be and is hereby perpetually enjoined from proceeding in the suit at Law mentioned in the Complainants Bill aforesaid; and that the said suit at Law be perpetually enjoined agreeable to the prayer of said Bill; and it (corner of page torn and not lined properly before photographing) --ther ordered adjudged and decreed that the said Complainant recover against said Fletcher --cost of the said suit at Law and also the cash of his Bill and proceedings in this court.
