FIFTH JUDICIAL CIRCUIT COURT RECORDS 1816 - 1826

(Original located in manuscript section of Tennessee State Library and Archives, Nashville, Tennessee. These records are also on micro-film.)

Samuel Vance vs Sarah Smith & others March Term 1818

(p. 14) Pleas before the Honorable John Haywood, Archibald Roane & Robert Whyte, Judges of the Supreme Court of Errors & Appeals of the State of Tennessee in the Fifth Judicial Circuit of said state at the Court house in Charlotte on the second Monday in March 1818 and in the 42nd year A. I. Be it remembered that...on the 20th July 1812 was filed in the Clerks office of the Court a Bill of Injunction....to wit:

...The Bill of Complaint of Samuel Vance of Montgomery County..showeth that your complainant & one John Bradley surviving partners of Vance, King & Bradley recovered a Judgement on the 8th day of November 1810 in the Court of Stewart County for the s(blot) against one Sarah Smith of Stewart County for the sum of one hundred and fifty eight dollars fifty one and one half cents for debt & damages and their costs which were taxed by the Court at Seven Dollars & Seventy four cents. That a writ of ? (blot. This may show up clearer on the original copy but is impossible to read on the microfilm).... Judgement returnable to the February Term 1811 of said Court which for the want of personal property was levied by the sherriff on a tract of two hundred acres of land in said County of Stewart which was granted to said Sarah Smith by the State of Tennessee by patent dated the 28th day of February 1809 which was interred as your complainant is informed and believes in the name of said Sarah Smith on the 6th day of August 1807 by virtue of a Military Warrant no 4210.

The sherrif by his deputy, Yancy Thornton,....proceeded duly to advertise the land for sale & to expose the same to public sale at the Court House in Dover on the 2nd day of February 1811, when your complainant purchased the same for twenty dollars, his being the highest bidder. The said two hundred acres of land appear from the copy of said patent to Sarah Smith as registered in Stewart County to be bounded as follows:

...an elm in Charles Gerards south west corner in the twentyth range & fourth section, running with his south west boundery line...to Jacob McCarthy's line..south.....east...to a poplar in John Stringers west boundery line..north..to beginning.

Your complainant has been informed that one James Smith son of said Sarah sets up a claim to said tract of land under a conveyance which he pretends to have from said Sarah. Your complainant charges the said conveyance to be fraudulent & to have been made expressly with intent to defeat said Vance & Bradley in the attempt to recover said debt. Your complainant believes that for said conveyance no valuable consideration was received by said Sarah, and that said deed from her was made about the time or not long before the rendition of said Judgement.

Your complainant has also been informed & believes that said Sarah ever since making said deed to James Smith has continued and yet is in possession of said land and that although said James has lived on

and culled? a part of said land, he has lately removed away & left Sarah in entire possession of the same.

Your complainant after taking a deed of conveyance from the Sherriff of Stewart County for said tract of land, which was acknowledged in said County Court of Stewart at their February Term 1811 which bears date the 4th day of February 1811 and has been duly registered in said county instituted an action of Ejectment in the Circuit Court of Stewart County against said Sarah Smith & James Smith for the possession of said land....but on the Title papers being examined by your complainants attorney after instituting said action of Ejectment your complainant was for the first time informed & advised that the grant to said Sarah Smith does not appear to have been registered in the Registers Office of West Tennessee and that this was necessary to entitle said Grant or copy thereof to be read in evidence.....Your complainant not having the said original grant in his possession advised that he .. compel the delivery of the same in order to have it registered that the fraudulent conveyance from Sarah to James ..be set aside and the title to said land decreed to your complainant. That said Sarah and James be enjoined from nonsuiting your complainant & from all further proceedings in said action of Ejectment..... H. Minor for the Complainant.

This 24th day of August 1812 said Sam'l Vance made oath in open court that the information given in the above bill was true to the best of his knowledge. Signed Sam;l Vance. John Sommerville Clk.

On the 27th July 1813 the answer of Sarah Smith was filed:

.....before she had any reason to suppose that said suit would be instituted against her...made a Deed of Gift of the said land to her four sons James Smith, John Smith, Peter Smith and William Smith. She was induced to make the said conveyance not only by the natural love and affection which she bore her said sons, but by the following circumstances, that her deceased husband James Smith, left considerable personal property having died intestate and no person having administration on his property remained in the possession of this defendant and was partly applied by her to making payment for said landthe defendant absolutely disclaims any intention of fraud in the above conveyance to her sons and declares the same was made honestly and with good faith....says the deed of conveyance bears the date 11th day of January 1809, that partition by order of the county court of Stewart County was made to best of her recollection in the year 1810. ...John Smith sold his part of the land to James Smith sometimes in that same year.....James Smith afterwards sold the two parts to Jeremiah Taylor Forsythe.....Forsythe sold the said two portions to Vachel Smith..who sold one half to Lewis Thomas and the other half to (blank) Murphey.....Lewis Thomas conveyed to a certain Peaples, who conveyed to his son Thornton Peaples who is not the tenant in possession of the same... that said Murphy is she believes still in possession of the part which was purchased by him.

She said that Peter Smith and William Smith are yet infants and under the age of twenty one years..that she was appointed their guardian by the Court of Stuart and she and her two sons live together on that part of the land which was allotted to Peter Smith.

This defendant further saith that she made a contract with a certain Morgan Brown for the purchase of the land about the year 1809 and

agreed to give him four hundred dollars and supposed at that time that Morgan Brown had a good title to the said land, but afterwards found that the land was vacant and that she was only entitled under the occupant law, having made a settlement in consequence of her supposed purchase from Brown. Before she had discovered the want of a title in Brown she had paid him \$245 part of the said purchase money, that the note which was given to the complainant for one hundred and fifty five dollars was given to him as the agent of Brown who was out of the country, and was given for the remainder of the aforesaid four hundred dollars; that she had no objection to making the note payable to the complainant instead of Brown thinking it a matter of indifference and not being then apprized of Browns defect of title to the land. But she supposed at the time that the note was taken by the complainant payable to himself in order to prevent Browns creditors from coming at the money. That it was on said note and by virtue thereof that the suit was constituted in the County Court of Stewart, the payment ordered and the execution issued and levied as stated in the complainants Bill of Complaint.

Vance agreed to take property in payment of the note but afterwards refused and sued her immediately. She had at that time property enough of her deceased husband consisting of stock which afterwards died and came to nought. That the complainant was the son-in-law of Brown and from the connection and intamacy subsisting between them was from the information received from the defendant she had no doubt but that he was acquainted with all the circumstances before recited, and particularly with the fact of the land being purchased on the credit of the property of her deceased husband and which rightfully belonged to her children.....T. Jones for the Defendant.

Sarah make oath that the above information is true....July 27, 1813.
Sarah (her X mark) Smith. Test Jno Minor, Clk.

Amended Bill of Complaint ...filed 5th January 1814:since exhibiting his said (bill) it has been disclosed to him by the answer of Sarah that she conveyed said tract of land to her four sons John, James, Peter & William Smith. That John sold his part to James who sold his two shares to Jeremiah Forsythe; who sold to Vachel Smith, and Vachel sold one half his land to Lewis Thomas by whom it was sold to David Peeples and by him the same was conveyed to Thornton Peeples who is now in possession thereof. That said Vechel Smith conveyed the other half of said land sold to him to one (blank) Murphy who is now in possession thereof. Complainant charges that conveyance from Sarah to her four sons was fraudulent as set forth in his original bill..... and that at the time of sales and conveyances to Murphy and Thornton Peeples they were severally informed of the suit of your complainant as above set forth. And your complainant prays that (blank) Murphy Thornton Peeples, Peter Smith and William Smith may fully answer the several matters...set forth and that he may have such other and further relief as to your honor the nature of his case may seem to require.
Minor for Complainant.

The answer of Thornton Peeples filed 25th July 1814.

The answer of Thornton Peeples to the amended bill of complaint of Sam'l Vance: The said defendant saving to himself all manner of advantage of exception to the many untruths...in the bill contained.. says that the said tract of land was purchased of Lewis Thomas by David Peeples the defendants father for the benefit of this defendant and

that the valuable consideration of one hundred and fifty dollars was actually paid by David to Lewis Thomas. And this defendant says that at the time of the purchase he was ignorant that the said Samuel Vance had instituted a suit for said land, but understood at the same time that the said suit had been decided against him. This defendant disclaims all knowledge of the fraud alledged in the Bill of Complaint and believes he was obtaining a good title to the land and is ready to produce the Deed executed to him by Lewis Thomas.....Jones for the Defendant.

January 22, 1814 Thornton Peeples swears the above statements are true. Henry H. Bryan J.P.

The answer of Peter Smith & William Smith filed 25th January 1814. Both infants under the age of twenty one years by Sarah Smith their mother & guardian. They say the material in the Bill was otherwise than they have heard their mother say. That the said lands were conveyed to them by their mother and were purchased with the property of their deceased father and the Defendants being infants and of tender years submit themselves to the Judgment of this Honorable Court..... pray what ever right or title they may have to the lands may be saved & protected..... Jones for the Defendants. Sworn to by Sarah Smith.

At January Term 1814 The Compl't obtained an order of Publication against the Defend. James Smith, not an inhabitant of this State.

At July Term 1814 said James Smith not appearing said Bill was taken for confessed against him and ordered to be set for hearing exparte.

At January 1815 Discontinued by order of Court--Order for discontinuance set aside on a--? and the cause set for hearingnext term.

The Comp't having filed his Replication..now finally comes to Court March term 1818 before Honorable John Hagweed, Robert Whyte and Archibald Roane, Judges.....it appearing to the satisfaction of the Court that a grant issued from the State of Tennessee to Sarah Smith dated the 28th February 1809 and numbered (blank) for 200 acres of land in Stuart County in the first district 20th Range and the 4th Section(mentions) Charles Gerards south west corner.....Jacob McCarthys line....John Areinstons west boundry line...which grant was founded on an occupant claim entered on the 6th day of August 1807 and surveyed 10th June 1808...it appearing that on the 9th day of April 1808 Sarah Smith executed to Vance, King and Bradley her certain Bill single for one hundred and fifty dollars payable on the first day of January thereafter with interest from the date on which Samuel Vance and John Bradly surviving partners of said firm ..instituted a suit against the said Sarah in...Stewart County returnable to May term..1810...on 8th November 1810 a judgment was obtained by said Vance & Bradley...against Sarah for \$158.50½..(plus costs)...there being no personal property by which the same could be satisfied levied the same on the said tract of land, and after advertising the same...on 2nd day of February 1811 exposed the same to public sale, the said Samuel Vance the highest bidder became the purchaser and the Sherrif of Stewart on 4th Feb. 1811 by deed conveyed the same to Samuel Vance. And it further appears to the satisfaction of the court that Sarah with a view of defeating the said Vance and Bradley....in recover of their debt..refused to let Grant be registered.....as required by law and fraudulently and without any valuable consideration executed a deed of Gift to her four sons..

for all her property both real and personal including the land in question; which fraudulent deed of conveyance was dated on or about the 11th day of January 1809; that said land was portioned amongst her said four sons; that John Smith sold his share to James Smith who sold portions to Jeremiah Forsythe; who sold two portions to Vachel Smith; who sold to Lewis Thomas; who sold to David Peeples; who sold to Thornton Peeples; all of whom at and before their respective purchases & before the execution of any deed for the same had notice & well knew that the said deed executed by the said Sarah..to her sons was made without any valuable consideration and with the view of defrauding said Vance & Bradley....out of the debts aforesaid and defeating them in the recovery thereof.

This court therefore doth think fit and do accordingly order adjudge and decree that on or before the first day of the next term of this court the said Grant be filed with the Clerk & Master of this Court that the same may be registered and that all title which the defendants or either of them have to the land in question derived under said grant by any of the conveyances aforesaid be divested and vested in said complainant and that the defendants pay the costs of this suit.

and 3238 Drexel St, Omaha, Neb 68107)

Col John Hogan, Sr was born ca 1750 and died ca 1810. He was appointed Colonel of Orange Co, NC Minute Men on 9 Sept 1775 by the Congress of the Colony of NC. (p207, Vol 10, Colonial Records of NC) By 27 Aug. 1776, he was chairman of the Safety Committee of Orange County (p 785, Vol 10, Colonial Records of N. C.)

Further information:

- 1778 Apointed Trustee for Orange Co., N. C.
- 1779 Senator in N. C. General Assembly from Orange Co.
- 1779 Owned 10,728 acres of land in Orange Co., N. C.
- 1790 Had 10 or more slave in Orange or Chatham Co., N. C.
- 1792 Donated 200 acres for University of N. C.
- 1795-6 Came from Orange Co., N. C. to Montgomery Co., Tenn.
- 1798 Owned 1047 acres in Montgomery Co., Tenn.
- 1799 Lived near where Big Brush Creek empties into the Cumberland River

He married Mary Lloyd, daughter of Major Thomas Lloyd of Orange Co., N. C. and had six children:

1. John Hogan, Jr. 1773-1818; married 1792 Martha Ann King, and came to Montgomery Co., Tenn about 1795. Lived on Big Brush Creek and had ten children. Buried at Hogan-Stewart-Graham Cemetery, Montgomery Co., Tenn.
2. William Hogan 1774-1836; married Elizabeth Allen; lived in Randolph Co., N. C. and had 12 children. He and wife buried at Hopewell Methodist Church Cemetery, Randolph Co., N. C.
3. Margaret Lloyd Hogan born ca 1775; married 1794 John Kimble. They moved to Montgomery Co., Tenn in 1796. He was a tavernkeeper in 1801 in Clarksville, Tenn. No further information.
4. James Hogan, born ca 1777. No further information. May have died young, but was living in 1792.
5. Alexander Hogan, born ca 1779; married Eliza Tabitha Osborne, his cousin, and lived in Iredell Co., N. C. She is buried in Centre Presbyterian Church Cemetery, Iredell Co. They had at least one daughter, Helen, who married Nelson Kirkland in 1867 in Orange Co., N. C.
6. Thomas Hogan, born ca 1780, married 1795, Tabitha Stroud and moved to Montgomery Co., Tenn, then to Christian Co., Ky in 1806 where he died sometime after 1846, leaving several children, who later moved to Pike, Franklin and Jefferson Counties in Illinois.

FREDRICK RUDOLPH - War of 1812

"Fredrick Rudolph was born in North Carolina Dec 28, 1789. Fredrick fought in the War of 1812. I have the pistol that he used in the Battle of New Orleans. It was made in England. Dr. Marshall Rudolph first cousin of my father wanted it to hang in his office in Clarksville but Father never would relinquish it"

LUCULLUS CARR ATKINS Confederate Soldier

The following information was compiled from questionnaires sent out to Veterans of the Civil War in 1922 by the Tennessee Historical Committee, Department of Libraries, Archives and History, John Trotwood Moore, Director. The originals are in the Manuscript Section of the State Library and Archives in Nashville, Tenn.

LUCULLUS CARR ATKINS in 1922 lived at Adams, Tenn. He was 76 years old. He was born in Montgomery County, Tenn. Both he and his father were farmers. Lucullus owned one 3 year old horse, valued at \$100 at the opening of the war. His father owned 6 slaves and 350 acres of land. The property was valued at \$14,500.

Their home was a log house consisting of 7 rooms and a hall. Lucullus did all forms of work..plowed, hoes, and similiar work. His father did general farm work. His mother looked after the housekeeping, but did not do any cooking, weaving or spinning.

He attended short term subscription schools. Altogether he attended school about 6 years. The nearest school was about one mile from his house. The schools in his neighborhood were private schools taught by Esq. Johnson and wife; another taught by Childs; and private school taught by Rev. Louis Lowe. The schools lasted about 6 mos. each year. The boys and girls in the community attended school regularly. He had both men and women teachers.

He enlisted in service of the Confederacy in May 1862 at Port Royal, Tennessee. He served in the 3rd Kentucky, Co. G. He remembers the following men who served with him in that company: _____ Dortch, Capt; _____gan Williamson, 1st Lt.; _____ Merritt 2nd Lt; (these names are probably clear on the original. The copy is dim at this edge) Henry Merritt;

3rd; H. A. Yates; T. S. Woodson; Geo T. Rosson; A. F. Rosson; Bill McGee; Hiram Grant; Bill Hogan; Horris Lurton; Frank Browder; Jim Jones; Hight Small; Mont. Merritt; Bill Grizzard; Joel Grizzard; Monroe Mason; Henry Fort; Clark Johnson; Jno Shaw; Alex Watts; Bill Adams; Dee Mason; Tomp. Jones; Alex Roles; Milton Davie?; Obb Greer; Jake Archer; Bob Weatherford; Henry Atkins; Dan Mason. (Darr Mason?)

After enlistment his company was first sent to Riggins Hill. His first battle was in 1862. Then joined Woodard's Cavalry & was sent to Russellville, Kentucky. He was in the battle of Riggins Hill about two months after he enlisted. (Riggin's Hill is in Montgomery County near New Providence--ED) He was discharged May 9, 1865 at Washington, Ga.

In answer to the question: "State in your own way your experiences in the war from this time (time of first battle)..." he made the following statement:

"From Russellville, Ky., joined Col Morgan. Went to Murfreesboro, then to Bowling Green, Ky.; then Hartsville, Tenn. Battle lasted about 1 hr. captured 2200 Yankees; carried them to Murfreesboro. In and around Murfreesboro we had several small battles; battle Snow's Hill; then to Smithville, Tenn; Readyville. We lived well in camp in the south. Slept out doors. 1 blanket. exposed to cold. Never slept inside during war except while in prison. July 1863 ordered to Indiana and Ohio. Took two boats on Ohio River and crossed and set fire after crossing.

"Then we rode 11 days and nights on our horses, without sleep. One night we rode 100 miles. The enemy fired on us several times each day. We had two 6 pound cannons with us. We encountered a stockade but our guns were not sufficient to run them out. At one time we were ordered to burn this stockade, but this was countermanded. We went down below about 2 miles on Green River and crossed the river. Timber was cut all along our way. All towns through which we passed were deserted. Could not see a man. We were captured by Woolfords Cavalry near Penn. line, who had followed us through Ohio and Indiana. I lost my horse here. We were carried to Chicago, Ill. and put in prison. we remained there 8 mo. Were fed on bread, pickled meat and tin cup of rice. We were not allowed money in prison. Slept on bunks with straw and 1 blanket. We were punished in prison if we disobeyed by being made to ride Morgans house, which was a rail.

"We were exchanged to Richmond, Va. There we were given \$130.00, 30 days furlough. We went to Blocksburg and spent our 30 days among southern people. At expiration of our 30 day furlough, Apr. 1865, we were ordered to mount and report to Washington, Ga. where we reported for duty 9th of May. We surrendered at Washington, Ga.

"They gave us \$33.00 gold. I sold my horse for \$10.00 gold. We had free transportation home. We rode on train where tracks were not torn up. Other time we walked. Atlanta to Dalton we walked 100 mi. in 3 days then entrained for Nashville. Remained there 3 days and took train for Springfield, Tenn. From there we walked home.

"We could not buy food without gold or silver. People would not take currency. Reached home at 9 O'Clock P. M. Walked in and my dog knew me after 4 years being away.

After he came home he did no work that year. His father gave him a horse & saddle and told him to "get go-until next Jan 1866 before I went to work". In January 1866 he took charge of farm for his father for \$500.00 each year. During the next five years he hauling?, rented a farm. Bought a farm in 1872 at Port Royal, Tenn. and lived there for 40 years. He moved to Adams in 1912.

His father was Jas. Thomas Atkins b. Montgomery Co., Tenn. He was for two years Tax Collector for Montgomery County. His mother was Virginia Carr dau. of James Carr and Martha Ann, his wife, who lived in Kentucky. The family came from Virginia and settled on a farm near Port Royal.
