HELM FAMILY OF VIRGINIA, TENNESSEE, KENTUCKY

John Buck Helm, my Great Grandfather, was the son of Meredith Helm and Grandson of William Helm of near Front Royal, Virginia.

John Buck Helm had two brothers, Presley Neville Helm and Meredith Helm, and one sister, Jane? . I have not been successful in determining where John Buck Helm was born, or where buried, but records show that he was married in Montgomery County, Tennessee, to Martha Lettitia Blakemore on June 6, 1842. This date is also confirmed in the family Bible.

After Martha L. Blakemore died, John Buck Helm married Bebekah Price Buck. No children were born of this union.

John Buck Helm's name does not appear in the 1850 Census of Montgomery Co., Tennessee, but Presley Neville Helm's name is there. Did he go back to Virginia or to another county in Tennessee prior to the Census of 1850?

John Buck Helm had three sons, John William, George Neville, Robert Thomas, and two daughters, Mary and Mattie. John William was living in Clarksville, Tenn. in 1861 when he enlisted in the Confederacy, joining the 49th Tenn. Inf. Reg. He was captured when Ft. Donelson surrendered, and his regiment sent as prisoners to Camp Douglas, Ill. His regiment was exchanged November 10, 1862, after their release on parole at Vicksburg, Miss. John William Helm died at Port Hudson, Louisiana on Feb. 9, 1863. I cannot determine where he was buried. My mother used to say that Uncle Willie was the victim of the hardships of war and being a prisoner of war, and this combined with his already frail constitution, resulted in tuberculosis, and his early death at the age of 19.

Mary and Mattie Helm, daughters of John Buck Helm, also died very young. Mary married John T. Biles and died 3 years later at the age of 21. Upon her deathbed she put her sister Martha's hand into her husband's as if to bless their union. Martha and John Biles were married the next year. Martha died a few years later. Both sisters had one child each.

Robert Thomas Helm (my grandfather) went to Paris, Tenn. where he married Josie Janes Oct. 6, 1873. They had six children. My mother was next to the youngest.

The two brothers, George Neville and Robert Thomas Helm, both moved to Hickman, Kentucky with their families. They lived and died there, where they were both buried in the City Cemetery.

CORBAN DIVORCE PETITION

Original petition located in Tennessee State Library and Archives, Nashville, Tenn. Legislative Petitions.

To the Honerable Legislature of the State of Tennessee now in session.

Your petitioner Elizabeth Corban preys a divorce of your honerable boddy from her husband, Bennet B. Corban who left her in Oct. 1830 to go to Natches as he stated for the purpose of collecting money. She further states that he left her without any provisions for sustenance more than ten days with two small children and stated that he would be back again in six weeks but have not yet returned. She states that she has frequently heard of him and have good reason to believe that he never intends coming back again. She further states that from his former conduct to her she never intends living with him again provided he should return again as she believes that she can do much better without him than with him. She further states that he left her without any just cause or provocation to the best of her knowledge and as such she hopes that your honerable boddy will consider her case and grant her a divorce as it is her will and wish as she is now living with her father where she believes that her situation would be more comfortable both to her and her children.

FIFTH JUDICIAL CIRCUIT COURT RECORDS 1816 - 1826

MONTGOMERY BELL VS HUGH WILLIAMSON March Term 1818. (page 33)

State of Tennessee Dickson County. Circuit Court for said County. Term 1810. To the Honorable the Judge of said Court. The Bill of Complaint of Montgomery Bell complainant against Hugh Williamson, defendant. Humbly complaining sheweth to your Honor Your Orator Montgomery Bell of the County of Dickson that on or about the 22nd day of March 1809 Hugh Williamson of the City of New York agreed to sell to your orator the following tract of land, towit, a tract of 4800 acres lying on Bartons Creek in Dixon County and granted to the said Hugh by the State of North Carolina and being the only tract of land of that size which the said Hugh is entitled to in that county and being the nearest tract he ownes to the Cumberland Iron Works the boundaries where of are more particularly expressed & set fourth in the said Grant. And the said Hugh set down in writing and signed the terms and conditions of the said sale in a certain letter directed to Willie Blount his Agent, which terms and conditions are thus expressed therein. He said Montgomery Bell is to pay one dollar per acre for the land you will therefore be pleased to make him a title for the tract taking his bonds for payment secured by a mortgage of the land. The Bonds by agreement are to bear interest from the date of the letter.

There are to be two bonds each for one half of the price of the land. One of them payable to me in four years from the date of this letter. The other payable in five years. It will be stated in the bonds the interest payable yearly.

Your Orator saith the terms of the sale expressed in said letter were the terms really agreed upon between your orator and the said Hugh and Your Orator sheweth to your Honor that on or about the 20th of July in the year of our Lord 1809 Your Orator prepared and tendered to the said Willie Blount a deed duly executed by Your Orator whereby the said land was mortgaged to the said Hugh Williamson by your orator for the payment of the said purchase money with interest at the several times specified in said letter. And also he prepared and executed and tendered at the same time to the said Willie Blount two single Bills payable the said Hugh for two thousand four hundred dollars each with lawfull interest from the 22nd day of March in the year of our Lord 1809 being the day of the date of the said letter the one of them payable on the 22nd day of March in the year of our Lord 1814 and the other payable on the 22nd day of March in the Year of our Lord 1813.

And at the same time Your Orator requested the said Willie to execute and deliver to Your Orator a Deed of Conveyance for said land agreeable to the power and directions contained in the said letter, but the said Willie Blount would not accept of the said Mortgage and Bonds or Bills single nor would be execute a deed of Conveyance for the said lands alledging he had received contrary directions from the said Hugh since the date of the said letter.

Your Orator sheweth to your Honor that he is still ready and always hath been since the said Tender to deliver the said mortgage and single Bills upon the receipt of a Deed of Conveyance of the said lands. And your Orator is advised that the said Hugh Williamson is bound by the rules of a Court of Equity specifically to carry his said contract into execution and your Orator had well hoped for sometime that he would have done so. But so it is may it please Your Honors the said Hugh Williamson hath persisted in refusing to execute his said contract hetherto and Your Orator is without relief except in this Honorable Court where matters of this kind are properly cognizable.

To the end therefore that the said Hugh may be compelled to Answer all and singular the premises on oath and that such decree may be made in the premises for the relief of Your Orator as shall be agreeable to Equity. May it please Your Honor to grant to your orator a Writ of Subpoena directed etc. and your orator etc.

And at March term 1818 the following order was made. Montgomery Bell vs Hugh Williamson, Original Bill, this day came the said complainant by Counsel and here in open court agrees to dismiss his said bill.

Therefore it is ordered by the court that said complainants said bill be dismissed and that the defendant may go hence without day and recover against him his costs by him about his suit in this behalf expended etc.

SOLDIERS FROM MONTGOMERY CO., TENNESSEE in the REVOLUTIONARY WAR and WAR OF 1812

MATTHEW MYRICK - Revolutionary War

Matthew Myrick, born September 25, 1752 in Warren County, North Carolina (then Bute) was the son of Moses Myrick and Susannah Ellison. He was one of three members of this large Virginia-North Carolina family to migrate to Montgomery County in the post Revolutionary War period. His first cousin, Richard Myrick, moved sometime after 1786, dying in Montgomery County in about 1802. Richard's estate is rather well documented in the county records. Matthew arrived in Montgomery County about 1795 and his brother Sterling followed sometime in late 1812. Family tradition is that they farmed and worked in an iron foundry. Few written records have been found for either brother. Most of what we know about Matthew comes from limited entries in the records of his father's estate and from Matthew's own sworn statement in 1832, when he applied for a pension.

Matthew's initial service was in 1777 for three months in Halifax, North Carolina where he worked at making shoes and cartridge boxes. About one year later, he volunteered for an additional three months service, to accompany his younger brothers Frank (Francis) and Moses. This tour was spent on garrison duty with no combat. Two months after he returned home, he was drafted for a regular term of three months in the militia. This time he campaigned in South Carolina with limited contact with the British forces. Subsequently, he and Frank enlisted in the Continental Line for one year, again with no combat. His final duty was as a three month militiaman. This time there was heavy combat at Guilford Courthouse, against Lord Cornwallis.

After the war, Matthew moved first to Burke County, North Carolina, remaining there for a few years; then to "Dilson" (Wilson) County, Tennessee, where he lived on the "Stony River"; then to Montgomery County where he remained for 15 years. County minutes refer to him in 1813, 1816, and 1817, placing him in District 15. He moved to Stewart County sometime before 1820, then to Henry County where he appears in 1830, living with William and Nancy Myrick. William may have been his son, but from census analysis is more likely a grandson. Matthew was alive in 1840, age 88.

Most recorded Montgomery County Myricks at the early 1800s can be identified as Richard's children. The census reports do indicate that both Matthew and Sterling had younger males living in their respective households. Three names appear - Samuel, James W. and Francis (Frank). Francis, who joined the group after service in the War of 1812 married a Priscilla and in 1841 moved to Bollinger County, Missouri. He is most probably the son of Sterling. From family movements it appears possible that Samuel was Matthew's son.

James W. may have been Sterling's son. Further information on this family would be welcome. Earlier history is well documented in Allie (Myrick) Bowden's The Story of the Myricks published in 1952 by J. W. Burke.

The following biographical sketch of Robert D. Read, West Point Graduate 1877 was supplied the County Historian from "Annual Report," June 14, 1920. It was reprinted in the March 2nd issue of MONTGOMERY COUNTY NEWS.

ROBERT D. READ No. 2696. Class of 1877 West Point Military Academy

Robert D. Read was born in Clarksville, Tennessee, on the 22nd February, 1854. With the advantage of two years at college, he entered West Point in September, 1873, and graduating with his class, was commissioned in 1877 as Second Lieutenant in the 10th Cavalry.

His first station was the frontier post of Fort Clark, Texas, several days by stage beyond San Antonio, which at that time was the terminus of the railroad.

After six years of garrison service at posts in Texas, varied by a campaign against Chief Victorio's band of Apaches and an occasional 'scout' or pursuit of small parties of these red skins, he was selected to represent his regiment at the Infantry and Cavalry School at Fort Leavenworth, Kansas. Here as a student officer, he received his first promotion in 1884.

On his graduation in 1885, he rejoined his regiment in Arizona and served with it seven years in that department. In 1892 he moved with it to Fort Custer, Montana, where in 1895 he was promoted to Captain. In the month of January, 1898, he took his troop to Fort Assiniboine, a more northern post in Montana, where the war with Spain found him a few months later.

His visions of active war service, of achievement against the enemy and consequent distinction and promotion had soon to give way to the humdrum scenes of a cavalry depot, as he settled down at Lakeland, Florida, to the duty of guarding and caring for the horses of his regiment, which, with few exceptions, were left behind when the bulk of the personnel went over the sea to Cuba.

On the return of the regiment a few months later, he rejoined it in the recuperation camp at Montauk Point, N. Y., and remained there with it until October 1898. Then came brief periods of service at Huntsville, Alabama, and Fort Brown, Texas, in Cuba and in the Philippine Islands. From 1901 to 1903 he enjoyed a restful tour of recruiting duty at Louisville, Ky., where in 1903, after twenty-six years of service as a commissioned officer, he was promoted to a Major. His first station as a field officer was Fort MacKenzie, Wyoming. From there he went to Fort Robinson, Nebraska, and to the Philippine Islands. On returning to the United States by way of Suez, in 1909, he did his first and last tour of duty with his regiment east of the Mississippi River, at Fort Ethan Allen, Vermont.

Here in the same year he received his promotion to a Lieutenant-Colonel which carried him from the 10th Cavalry, in which he had served since 1877, or thirty-three years, to the 3rd Cavalry. In 1912 he was promoted to Colonel and stationed at Fort Bliss, Texas, where in 1914 he was placed on the retired list on account of disability incurred in line of duty.

Of his thirty-seven years of commissioned service, fifteen and a half, or nearly half, were spent in the cactus and sagebrush region, in which

he first faced the realities of a cavalry officer's life, on the plain, mesas, and sierras of Texas, New Mexico, and Arizona.

Such is the simple story of the career of Robert D. Read. If it affords a little to excite wonder, it is because long and faithful performance of duty, sometimes arduous and dangerous, generally monotonous, and rarely, if ever glorious or thriling, has become a common thing in the traditions of the regular army.

On his personal side, Bobby Read was quick to make friends and slow to lose them. In a wall tent, in one room and a kitchen, or in more spacious quarters, he always had an attractive home and entertained generously. He married twice: in 1893, Margaret Laurie, who died in 1904; and in 1906, Alice Keen, who survives him. (1920)

GENERAL WILLIAM A. QUARLES

We are again grateful to John Wm. Johnson of Chattanooga for this additional and CORRECTED material concerning General Quarles. Gen. Quarles is listed in the Forbes Bivouac list in Volume VI, No. #3, page 86. GENERAL QUARLES IS NOT BURIED IN GREENWOOD AS STATED.

William A. Quarles, born in Louisa County, Va., July 4, 1825, came to Christian County, Kentucky, in 1830 with his parents, when they moved to the southern part of that county. He received his early education at home and in September 1845 was sent to the University of Virginia, where he studied law and was admitted to the bar in 1848 and settled in Clarksville, where he resided for more than 50 years. He become one of the most respected lawyers in the state. He was active in the Democratic party and ran for several county and state offices. He was appointed President of the Memphis, Clarksville & Louisville Railroad and in 1859 was appointed Bank supervisor of the State of Tennessee. In this office he did much to influence the state to enter the Confederacy in 1861. He served as delegate to the National Democratic Convention, 1856, 1860 and 1883.

On October 1, 1861, he was appointed Colonel in 42nd Tenn. Inf. at its organizational meeting. His regiment fought at Fort Donelson in 1862. In March 1863, Colonel Quarles was promoted to Brigadier-General. In 1863, following the fall of Vicksburg, he was commanding the 42nd Brigade. He was severely wounded at the Battle of Franklin and served in many other battles and services during the war, which record may be read in "Picturesque Clarksville, Past and Present".

General Quarles married Miss Lucy Jones Poindexter, dau. of John Poindexter, a prominent planter of Garrettsburg, Christian Co., Ky. on January 10, 1848. She was born November 26, 1825 and died August 20, 1861. They had three children: Ella, born Sept. 25, 1851 and died July 4, 1854; Willie, born October 29, 1859 and died April 23, 1860; and Johnnie born January 5, 1858 and died January 11, 1859. All were buried in the old Poindexter Family burying ground at the old homestead at Garrettsburg.

In later years General Quarles married a widow, Mrs. Louise Meriwether Barker, whose first husband died in 1869. They had no issue and Mrs. Louise Barker Quarles lived until 1906.

General Quarles died at "Meriville" near Guthrie, Kentucky the home of his step-daughter, following a stroke of paralysis on December 28, 1893. At his request and contrary to the records of the Forbes Bivouac of Clarksville, he wasburied at the old Poindexter place in Christian Co., Ky by his first wife.

THE KENTUCKY NEW ERA of Hopkinsville, Ky. issue of January 5, 1894 concludes General Quarles obituary notice with this statement: "The remains were laid to rest Sat. at 2 PM at the old Poindexter place near Garrettsburg in the southern part of the county. Funeral was in charge of by Forbes Bivouac of Clarksville."

A beautiful monument on the plot gives the inscription of the wife and three children and the front side state "The Family of W. A. Quarles", but his inscription was never added to the stone.

When the government moved this plot to Flat Lick Church Cemetery in 1942 (when Fort Campbell, Kentucky was built), General Quarles was listed as 1 unmarked grave. The only one in the plot. Let's hope some interested Confederate organization will still see that his grave is marked with a Confederate Stone.

Agreeably to the aforesaid act of the General Assembly, this said Subscription paper is now opened for that purpose in my office, to wit, We the under subscribed do oblige ourselves to pay to Joseph McMinn Governor of the State of Tennessee and his successors in office sum annexed to our names, one half of the said sum so subscribed by us or either of us to be paid on or before the first day of January 1817 & the other half thereof to be paid six months thereafter without defauleation.
