PUBLIC SALE FOR DELINQUENT PROPERTY TAX, 1818

This list is found in the July 22, 1818 edition of THE WEEKLY CHRONICLE published in Clarksville by Burrel H. Peeples. It was contributed by Capt. C. G. Hogan, Omaha, Nebraska. The paper lists property from other counties in the state. Only the Montgomery County portion is used here.

"Notice is hereby given, that the Direct Tax of the United States for 1816 on the following described property, situated in this state, having remained unpaid one year from the time of the notification of the collector in whose district the said property lies, that the tax had become due and payable; the same or so much thereof as may be necessary to satisfy the said tax due thereon; with an addition of twenty per cent will be sold at Public Sale, at the Franklin hotel, in the town of Franklin, in the county of Williamson, on the 24th day of August, 1818--Sale to commence at ten o'clock, A. M. and continue from day to day, until all are sold.

FIFTH JUDICIAL CIRCUIT COURT RECORDS 1816 - 1826

(Original located in Manuscript Section of Tennessee State Library and Archives, Nashville. These records are also on microfilm.)

JAMES TRAYNER vs MATHEW BROOKS & JOHN TRAYNER March Term 1818

(p. 34) Filed 23 June 1817. State of Tennessee Circuit Court of Robertson Co.

Your orator James Trayner of County of Rutherford in said state ...on the 27 April 1793 a grant for 640 acres of land lying in Robertson Co..was issued by State of North Carolina to heirs of James Trayner, deceased..."Grant #1626..To heirs of James Trayner a private in the Continental Line of said state ... 640 acres of land in our county of Davidson below the fork of Nelson's Creek. (mentions)..Humphrey Hogan's line...signed Richard Dobbs Speight. Attest: James Glasgow, secretary. Warrent #287 (#2870??) which grant was issued....Entry made 2nd November 1790 in name of heirs of James Trayner.

Your orator further states that the said James Trayner, deceased, had at the time of his death only three children--John Trayner, the eldest son, who your orator prays may be made defendant to this bill and who now lives in Warren Co., Kentucky--also your orator--and Peggy Trayner, married to Alexander Doherty now decd. & now living in Pendleton County, South Carolina.

Your orator sheweth that himself and said brother John Trayner at the date of the said entry and grant were the only heirs of said James Trayner dec. who could inherit or take said lands.

Your orator also sheweth that shortly after the American War, himself, his mother and said Peggy Trayner moved to the State of Georgia where your orator remained untill about one year ago when he moved to this state. John moved to South Carolina where he ataid untill 8 or 10 years ago when he moved to Kentucky.

While in the State of Georgia a great many years ago your orator who was then young, heard his mother say that the family ought to have something for his father's military service, but expected that nothing ever could or would be got as she had no certificate to shew them. Your orator having no other knowledge on the subject than such as his mother gave as aforesaid and being very ignorant of such things continued in the same ignorance of his right until he had settled in this state, before which time he never knew and he is sure his mother never knew that there was an entry or grant made in the name of the heirs of James Trayner or that any had been made in the name of James Trayner.

After living in this county and learning that it was an easy matter to know what rewards if any had been bestowed on every soldier, your orator made the necessary inquiry on the subject and for the first time about one year ago found that an entry and grant had been made in the name of the heirs of James Trayner as aforesaid.

Your orator shortly afterwards went to the premises described in the said grant and found the same in possession of persons under deed executed by said John Trayner to one Mathew Brooks, Junr. who now lives in Jackson County in this state and whoo your orator prays may be made a defendant to this Bill.

A copy of said deed is herewith filed marked A to be taken as part of this Bill.

Your orator also further states that about the time the said deed bears date, as he is informed and believes--one Mathew Brooks Senr. now deceased hearing that a grant had issued as aforesaid the heirs of James Trayner and supposing as they lived out of the state that their rights could be got verry low ..went to the said John Trayner in South Carolina & proposed to buy said land..stated to him that there was a particular time within which non resident proprietors of land should come into this state and make their claims known.. that the time was nearly lapsed and that the claim would be forever barred or lost unless he would come to the country and make it known within the limited time and offered him a horse supposed to be worth \$100 for the land.

The said John who before that time was also ignorant of the said entry and grant stated he could not conveniently come to this state in so short a period, but sooner than loose all, he would take the horse, but stated at the same time that he had a brother, to wit, your orator, who was also an heir and whoose right he could not sell. Said Brooks replied that the said John being the elder son was the only heir to said land and that we would take from him a quit claim or special waranty for the whole tract and give him a bond indemnifying him against all damages that might result from executing said deed. Which being agreed upon and said Mathew Brooks Senr wishing the said deed..executed to his son..Mathew Brooks Junr....

Mathew Brooks Junr..now claims..the whole tract except 200 acres.. ..which he has sold...to persons unknown to your orator.

Your orator expressly charges that he never knew untill after he settled in this state...that the deed had been made by said John ... and...that any entry or grant had been made in the name & behalf or said heirs.

He further charges that the horse given for said land bore no kind of comparison to the value of said land it being at the time worth two dollars per acre and indeed Brooks shortly after the deed was executed said the land was worth \$2000.

Your orator states that after he went to the land..he applied?? to said Mathew to partition said tract of land and to relinquish to him one half the same...The said Mathew combining and confederating with divers persons unknown to your orator has uterly refused and yet refuses to relinquish to your orator .. his one half of said tract of land or in any way to divide the same...sometimes giving as a reason .. he has had more than seven years possession of the land and at other times that John Trayner was by law the sole owner....

To the end therefore that the said Mathew Brooks Junr &...John Trayner and their confederates may true and perfect answers make to the foregoing matters in all respects....that said Mathew Brooks Junr be divested of one undivided moiety? of said tract of land and the same be vested in your orator and his heirs.....John E Beck, Solt for Comp'lt.

Demurer of Mathew Brooks defendant to the Bill of Complaint exhibited against him..the said Mathew and John Trayner .. in the Circuit Court for the County of Robertson--And the Defendant Mathew Brooks by his attorney comes and sayeth that he is advised that the Bill of Complaint...filed against him and John and the matters and things charges & allegations..contained are not sufficient to authorise a decree against him according to the prayer of the said complainant and he is not bound to make any answers to the same and this he is ready to verify and establish whensoever and in whatsoever manner this Honorable Court may order and decree wherefore for want of a sufficient Bill....complainant prays for ...he prays to be hence dismissed with his reasonable costs in this behalf expended.... P. W. Humphries for defendant.

And for cause of Demurer in law the said defendant Sews?? the following (viz) that the complainants relief is at law and not in Equity 2nd. That the Circuit Court of Robertson has no jurisdiction of the case if the party is releivable in Equity 3rd. The said Bill wants form etc. Humphreys Solt etc Joindes in Demurer John E Beck.

April Term 1817 of the Robertson Circuit. In Equity on Demurer this day came the said Mathew Brooks by counsel & the demurer being read and argument..being heard & mature consideration ..had. It seems to the court here that the demurer of the defendant Mathew Brooks to the aforesaid Bill of Complaint the complainant be sustained and that the Bill of Complaint..be dismissed & the complainant pay the respondents their cost about their suit ..expended. Whereupon the said complainant by his counsel prays an appeal in the nature of a Writ of Error to the next Supreme Court of Errors and appeals in the 5th Circuit and thereupon the said complainant having entered into bond with John Hutchison his security and according to the Act of Assembly ..the appeal aforesaid is granted.

Decree on original Bill in Equity on Writ of Error from the Robertson Circuit Court. This day (March Term 1818) came the parties by their attorneys..the matters and things by said Complainants for Errors assigned being seen inspected and by the court..understood and argument being had..Because it seems to the court

that in the record and process...and the judgment of the court.. there is no error, it is ordered adjudged and decreed by this court that the decree and judgt. of the Circuit Court be in all things affirmed and that the Complainant pay the costs of this suit as well in the Circuit Court of Robertson County....

10 Deed of Conveyance - Howel Tatum to David Peoples for 200 acres proven in Court by the oath of Samuel Thornton & Nathan Peoples subscribing witnesses..& ordered to be registered.

ADAM HARMON JUNR VS JAMES HUGHES & CHARLES HENSLEY -- O. Attach^t Isaac Morgan was summoned as a guarnisher Sworn & says he owes to his note given to James Hughes Fifty six dollars fifty nine & a half cents. And also he has in his hands Two Dollars thirty three & Two Thirds cents cash on which note the said Hues has brought suit in this Court.

THOMAS MCGEE -- REVOLUTIONARY WAR

State of Tennessee, Montgomery County. Thomas McGee, a citizen resident of the County of Montgomery personally appeared in open court this fifteenth day of October in the year of our Lord one thousand eight hundred & thirty two; aged seventy years & who being duly sworn according to law, doth upon his oath make the following declaration for the purpose of obtaining the benefit of the Act of Congress passed the 7th day of June in the year 1832.

That he was raised from a small boy in the County of Anson in the State of North Carolina...was born in the County of Orange but the record of his all having been lost he is ...(this is written in small print above the line and is not easily read)

That he was taken a prisoner by the Tories in the County of Anson and was taken by them into the State of South Carolina. When he made his escape & upon his return enlisted in the Regular Service near the town of Hillsborough for the term of twelve months in a company commanded by Capt Tilman Dickson in what was then termed the first Regiment of Infantry commanded by Col. Henry Dickson a brother of the captain and a man by the name of Donahoo was the Major.

That he was enlisted verry soon after the Battle at Guilford Court-house; that he was first marched from Hillsborough to the high hills of Santee in South Carolina near a place then known by the name of Thompson's fort where we joined the army under the command of Gen'l Greene and in a few days, Gen'l Greene marched his army to the Sutaw?? Springs when they had the battle -- and the said applicant was at that time sick & others who were sick together with the baggage waggons were marched to the hills of Santee, where they continued until after the battle and the return of Gen'l Greene. They were then marched to a place then known by the name of Pacon's Bridge said to be sixteen miles above Charleston.

That he continued with the troops in the neighbourhood of Charleston until after Cornwallis was taken & he was continued in the service until the expiration of the term of service for which he enlisted. That he returned with Col Dickson to North Carolina where he was discharged and received his discharge from the Col. which he thinks was signed by the Capt & Col. both. That after the service was performed his pay was due him & he sold his claim and transferred his discharge to a man by the name of John Welker.

That he knows of no living witness who can prove his service except a man by the name of Thomas Robertson who served with him in the same Regiment & who at this time he is informed & believes resides in the County of Stewart in the State of Tennessee & who he is informed & believes is now partially deranged & unfit to be called on as a witness.

That he has no written evidence by which his services can be proven. That after the war he returned to Anson where he resided until about the year 1805 or 1806 when he removed to the County of Montgomery in Tennessee where he has ever since resided. That he is not on the pension roll of any agency in any state or of the United States or or any State. That he hereby relinquishes all claim to any annuity or pension from the United States except the present one.

The original deed to the Church Property is recorded in County Register's Office, Book 16, page 458. Approximately one acre sold to Ed Hewell and recorded in Book 95 page 234.

"We whose names are undersigned met together at the Christian meeting house, July 3, 1889, and organized ourselves together in the capacity of Christian worshipers. Obligating ourselves to take no creed save God's Holy Word; which we covenant to take as a Lamp to Our Feet and A Light To Our Pathway. Said organization being composed of baptized believers, is to be known as the Church of Christ at New Providence. We the undersigned agree to keep house for the Lord at the above named place as best we can until death ends our Christian warfare or till our names are transferred to another body or congregation of worshipers like to that we read of in The New Testament of Our Lord and Savior Jesus Christ."

There seems to have been a Christian Church in New Providence before 1858, but there are no records of it.

Book P, page 71 - Wills and Records of Montgomery County, Tennessee. Will of Thomas W. Atkinson made 24 April 1858 and reg. May term of court 1865. (He died in 1862 but because of the war the will was not probated until 1865.)

"..the one acre lot - corner of Chapel and Market streets..My executors will deed to the trustees of any religious body of the Christian reformed church nicknamed Campbellites with limitations and reservations as follows--that it be used for religious purposes in said denomination and no secular or political meetings ever be held there; and a good permanent house of worship to be erected thereon in five years after my death.."
