MATHEW ROGERS

Departed this life at his residence in Stewart County, Tenn. on the 18th of May, Mathew Rogers, with an attack of fever--aged 68 years.

He was born in Granville County, North Carolina, and removed when quite young to Sumner County, Tennessee; thence he removed to Montgomery County in 1821 where he remained till his death.

Embraced religion in 1838 and united himself to the Cumberland Presbyterian Church....

He has left an affectionate wife and a large family of children.

Lafayette, Ky. July 12, 1843.

THE CLARKSVILLE CHRONICLE, Aug 22, 1843. (They copied from The South Western Christian Advocate)

FIFTH JUDICIAL CIRCUIT COURT RECORDS 1816 - 1826

(original located in Manuscript Section of Tennessee State Library and Archives, Nashville. These records are also on microfilm.)

MANN PHILLIPS vs THOS J. OVERTON. March term 1818.

(p. 37) ... In 1805 Mann Phillips, your orator, of Stewart Co., was sued in the county court of Montgomery by one, Louder Hall on a pretended claim to one third part of the value of three years service of a negro man named Jefry, estimated at about seventy-five or six dollars... On the morning of about the fifth day of March 1805 he (Phillips) met with Thomas J. Overton at Clarksville the place of holding the Court of Pleas for Montgomery County...that Thomas J. Overton then a stranger to your orator represented himself as an attorney of that court and resident there who would .. be regular in his attendance at court. Your orator..mentioned to him the suit just commenced against your orator by Lowden Hall and.. desired to know what sum he would be willing to take to put in a plea and defend him ... Thomas J. Overton answered that the Law allowed him but two dollars and a half which he thought was too little, but said if your orator would agree to give him ten dollars he would clear him and have him acquited....Your orator agreed to pay Thomas J. the..sum of ten dollars...Thomas agreed to perform his part of the agreement.

.. it was not mentioned by either party that it should be reduced to writing, but afterwards in the evening of the same day and at the same place, your orator is informed and believes he was in such a state of inebriety as to be disqualifyed for ordinary business and such indeed was his unfortunate situation that he knew not what he did nor is he now able to recollect any of the transactions of the afterpart of that day, but he is informed and believes that whilst he was in that unfortunate situation that he the said Thomas J. Overton taking advantage of the absence of your orators mind and his almost if not total want of intelect came to him..with a note written and sealed, dated the fifteenth day of March 1805 and containing a promise to pay him one hundred dollars and expressed to be for value received and presented the same to your orator to be signed...stating he was your orators Lawer in the case where Lowder Hall had sued him and that he must sign that note for the fee he had agreed to give ... and your orator did then and there as he is informed put his name to said note without reading it nor knowing what he was about and not being able to understand if it had been read to him.

Shortly after the day of the date of said note..Thomas J. Overton left Clarksville and was absent at the two succeeding courts there ...that he was under the necessity of employing other counsel to defend said suit or a judgement by default would have been had against him. He did employ N. A. McNary, a practicing attorney

.. He gave ten dollars for making his defense ...

Your orator..states that except the contract herein before recited he never had any with the said Thomas J. Overton and he never owed him any sums of money on any other account...Your orator represents that Thomas J. Overton afterwards commenced an action against him on said note so fraudulently obtained...in the Court of Pleas etc held in Montgomery County and afterwards removed the same by a Writ of Error to the late Superior Court of Law holden for the District of Robertson and.Thomas J. Overton concealed from the said Court all the above mentioned facts and such were the pleadings and the nature of the action that your orator could not disclose the above..facts and circumstances to the court nor could he by any means avail himself of them and upon the said note the said Thomas J. Overton obtained a Judgement of said Court against your orator...in the sum of one hundred dollars with interest and costs...

Asks for relief...and that Thomas J. Overton, his agents, attornies and Sheriff of Stewart County be enjoined from proceeding to cause said Judgement to be executed.....G. W. L. Marr Atty for complainant. July 2, 1810.

Thomas J. Overton answeres that he was hired by the defendant for one hundred dollars to defend him in said suit...made no agreement with compl't that he would take ten dollars as a fee... He states he did move away from Clarksville to <u>Russelsville</u> in Logan County Kentucky before the determination of the suit brought by Lowder Hall...but avers that he attended to it regularly...except he might have omited to attend one or two courts through sickness or some other <u>unforseen</u> accident which prevented him but having been informed by the Compt himself that he had employed Mr. N. A. McNary as counsel with this respondent at the same court, he employed this Deft to attend to the suit aforesaid that inconvenience of a Judgment by default likely to be obtained against the complainant as stated in his bill could not well have happened even if this respondents nonattendance could be attributed to neglect.

This respondant moreover atates that the Comp't not only employed Mr. N. A. McNary, but also the Honorable Parry Humphries This respondant conceives it to be quite immaterial how many attornies the compl't might have thought proper to employ in the defence of his cause. What the nature of the controversy or of what value the negro or his hire might have been estimated at certainly does not alter or vitiate his bond .. solemly executed to this respondent under his hand and seal in the presence of two subscribing witnesses. He conceives it to be entirely immaterial whether it was in the forenoon or afternoon of the day that the complainant executed his obligation...but he most positively denies that he attempted to take any advantage of the complainants want of intelects or his unfortunate and deplorable situation as the Complt would wish to insinuate and this respondent would by way of Answer to this cause of the Complainants bill beg leave to ask how far is the want or absence of a mans intelect and understanding to be regarded by the contracting parties and whether a Court of Justice will assume upon

itself to measure the understandings or consciences of men. This respondent expressly avers that he did not make use of any means to procure the inebriety of or intoxication of the complainant if he was in that condition as charged in his bill. This respondent would with great difference to the Court beg leave to inquire how far a man like unto the complaint can plead his own disability to avoid his bond. This respondent does not conceive it to be material to answer whether the bond was read to the complt or not unless he can shew with the rest of his afflictions weaknesses and disabilities that he was so illiterate, unlettered and unlearned a man that he could not read and requested the reading of it and it was refused, but he could wirte, his eyes had not failed him if his intelects had.... Th. J. Overton.

William Dudley, presiding Justice of Fayette County, Kentucky certifies that Thomas J. Overton appeared before him and made the foregoing statement. 22 February 1811.

Replication of Mann Phillips to the Answer of Thomas J. Overton filed 24 August 1812.

By consent of parties by their (smeared) it is ordered that the following issues of fact be sent down to the Circuit Court of Montgomery County for trial..towit: was the Complainant drunk at the time of executing the writing obligatory mentioned..and 2nd was he drunk by contribance of the respondant 3rd was there any, consideration from Dft to said Complainant for said writing obligatory and what was said consideration 4th did the defendant perform his part of the agreement mentioned.... Marr for Complainant. Minor for defendant.

....Mann Phillips of Stewart Co..on the 18th August 1810..exhibited his bill..against Thomas J. Overton for an Injunction... Thomas J. Overton not being an inhabitant of this state and residing in Barren County..Kentucky....did appear and put in his answer...on 26th March 1811...your orator did afterwards file his replications on 24th August 1812...but before any further proceedings were had in said cause..on or about the month of (blank) last past the said Thomas J. Overton departed this life...without having made his last Will and Testament leaving several Brothers and Sisters, his heirs at law, whoose names are unknown to your orator except James Overton of Lexington, Sally Overton, Eliza Overton, and Patsey Overton and those hereafter mentioned and all of whoom he is informed and believed reside in the State of Kentucky, except Archebald W. Overton and John Overton who reside in the State of Tennessee...All of whoom your orator prays may be made defendants to this bill of Complaint....

On March 18th 1818 court appears satisfied that Thomas J. Overton departed this life about --- day of --- 1815... Agree he was hired as an attorney...charge unreasonable...granted ten dollars and defendants to pay cost of this suit out of any assets of said Thomas J. which may have come to their hands and if none have come, the complainant to pay the costs of this suits..and recover his costs when assets descend to them.

SOLDIERS FROM MONTGOMERY CO., TENNESSEE in the REVOLUTIONARY WAR and WAR OF 1812

WILLIAM WIGGINS -- Revolutionary War <u>S1739</u>

State of Tennessee, Montgomery County -- Circuit Court--August Term 1832.

On the 22nd day of August personally appeared before the Judge of the 5th Judicial Court for the State of Tennessee...Montgomery Co ..William Wiggins a resident of Montgomery State of Tennessee age 73 years who being first duly sworn..doth make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832.

That he entered the Army the United States the first of April 1781 by enlisting for the term of one year with Captain Hargrove in the Continental Line, that he served in the regiment under the following officers, that he was taken by Capt. Hargrove beyond Smithfield, N. Carolina. He was then put under the command of Col. William Linton? ----amted to Capt Bary? Grims? Company. Not long after Col. Linton was broke for executing some tories .. properly he was put under the command of Col. Kenyon? near Wilmington and was in the battle at Rock Fish Creek near Wilmington and was wounded in his right thigh a little above the knee. The Americans were routed. They then fell back to Nuse River near Smithfield. We run around? on Nuse River untill after we heard of the capture of Cornwallas at Little York. After this news came that the British had left Wilmington we were then discharged, but from the fight at Rockfish Creek our Col. had never again found us and the Major that was then whose name I have forgot told us we might be discharged for further orders. I never had a regular discharge owing to the circumstances before mentioned.

At the time I inlisted I lived near Roanoak River, County of Halifax North Carolina. There is no person now living by whom I can prove my service, the last of my fellow soldiers that lived any where in this country that I know of, to wit: Gen'l R. Carney and Thos. Bayless, died a few years since. Thos. Bayless was commessary? for our Regiment.....(signed) William Wiggins.

We, Robert McCorkle, a clergyman in the county of Montgomery and state of Tennessee and Dawson Bayliss residing in the same county and state hereby certify that we are well acquainted with William Wiggins who has subscribed and sworn to the above declaration.. that we believe him to be seventy three years old, that he is reputed and believed in the neighborhood where he lives to have been a soldier of the Revolution and that we concur in that opinion....(signed) Robert McCorkle, Dawson Bayliss.

William Wiggins again appears in Circuit Court of Montgomery Co.

on August 28th 1833 concerning his pension.

He states his discharge was on the 18th day of October 1781. He states he was born in Martin County, North Carolina. He can not remember which year...he is 73 or 74 years of age....there is no record of his age..he has the information of his age from an elder sister. (no name given).

He was subscribed on the Roll of West Tennessee at the rate of 21.66 cents per annum to commence on the 4th day of March 1831.

LEGISLATIVE PETITION JAMES M. REYNOLDS AND JOHN R. McFARLAND

The original petition is found in the Legislative Petitions, State Library and Archives, Nashville, Tennessee.

To the Honourable the General Assembly of the State of Tennessee now sitting in Knoxville,

The Petition of James M. Reynolds and John R. McFarland respectfully represents, That in the winter 1807 your Petitioners purchased a Negroe man named Moses, about thirty five years of age, from a certain Joseph Penrice of the County of Montgomery for the sum of Three hundred and thirty three dollars thirty three and one third cents, which Negroe afterwards, to with, before the delivery of him to us, shot and killed a citizen of Clarksville whose name was Samuel Minott, for which offence he was arrested, tried and convicted, and pursuant to the sentance of the Court was executed at Clarksville.

After the execution of said Negroe, said Penrice demanded payment of us, which we refused to make on the grounds of his never having been delivered prior to his committing the murder aforesaid. In consequence of which refusal said Penrice commenced suit against us and ultimately recovered of us Three hundred and thirty three dollars thirty three and one third cents, together with the interest thereon, making in all the sum of Three hundred and sixty one dollars sixty four cents, together with the cost of suit which added to the foregoing sum makes an agregated sum of four hundred and one dollars eighty two and one half cents, which we paid to the Sheriff of Montgomery County as his receipt which accompanies this petition will fully shew unto your Honourable Body.

Your Petitioners having fully and fairly represented this case which they believe a hard one and knowing no reason consistent with principles of immutable Justice which would prevent the State from making to us full compensation for the loss we have sustained by the mere operation of the laws of the State and conceiving ourselves fairly entitled to receive from the State the sum which we have been compelled by Law to pay and relying on the Justice of your Honourable Body chearfully submit the decision on our interest in the above recited case to you.

We do not concieve that the State ought to deprive a Citizen of his property by the operation of Law (altho it is right that Culprits should be made to suffer punishment) without making the owner reperation therefor, any more than one Citizen has a right to the use of the property of his neighbour without paying a valuable compensation for the same. All which is respectfully submitted.

G. E. EDLIN Confederate Soldier

The following information was compiled from questionaires sent out to Vererans of the Civil War in 1922 by the Tennessee Historical Committee, Department of Libraries, Archives and History, John Trotwood Moore, Director. The chief purpose of the questions was to bring our facts that would be of help in writing a true history of the Old South. In addition to the information abstracted the veteran also gave his opinion concerning the relationship of slave owners and non-slave owners in his community. The originals are found in the Manuscript section of the State Library and Archives, Nashville, TN.

G. E. EDLIN in 1922 lived in Guthrie, Ky. He was 76. He was born in Montgomery County, Tennessee, and served as a Confederate Soldier in Co. C, 2nd Ky Cavalry under General Forest.

His father, James Edlin, was a boot and shoe maker born in Ireland. His mother was Sarah Francisco, daughter of John Francisco and his wife, Nancy. The family lived at New Providence, Tenn. Before the war his father owned 150 acres of land valued at \$1500 and eight slaves. They lived in a five room frame house. As a young man, he did all kinds of work--plowed, howed, carpenter, trad., fishing.

He attended pay schools for 8 years, traveling from 1/2 to 4 miles to school. These public schools ran for 10 months a year and had men teachers. The boys and girls attended school together.

He enlisted in service at Riggins Hill on Sept 22, 1862 and went into battle at Riggins Hill the same day. Afterwards they company went to Hopkinsville and then to Murfreesboro. They were in the Battle of Lookout Mountain; Atlanta, Georgia; and Fort Worth, Texas. He was discharged at Washington, Georgia. The "yanks took our pases ..walked home and beg for a little to eat". After he came home, he went to school for 1 session. He then served three years learning the carriage trade.

He notes that Jeff Davis gave up and took the oath in the same town he did (Washington, Georgia, May 9, 1865).

CRONOLOGY AND HISTORICAL SKETCH of McCULLOCH LODGE No. 189 F. and A. M.

AD 1912 A. L. 5912

Submitted by Mildred S. Glenn, Clarksville, TN. This is a posterlike paper or like a large hand bill.

A Charter for a Lodge located at Palmyra, Tennessee, known as McCulloch Lodge No. 189, F. and A.M. was issued December 10th 1849, by Grand Master R. L. Caruthers, countersigned by Grand Secretary J. S. Dashiell, naming: Brothers John F. Outlaw, W. M.; Washington Cooper, S. W.; Isaac Shelby, J. W. The Lodge worked regularly until April 4, 1863, when the Lodge room, including the furniture and charter were burned by Federal Troops.

The Lodge met again September 9th, 1865, in a storehouse in Carbandale, under dispensation with sixty-three members enrolled. A new charter was granted December 6th, 1866, by Grand Master T. A. Hamilton, countersigned by Grand Secretary C. A. Fuller, naming: Brothers John F. Outlaw, M. W.; Rolfe Eldridge, S. W.; Peter Oneal, J. W.

The Lodge worked about a year in the storehouse, moved to a new school house nearer Palmyra, where regular meetings were held until the present Lodge room was built in connection with the church in 1870.

HISTORY OF SHADY GROVE CHURCH

by Cleo G. Hogan, P. O. Box 2132, Asheville, North Carolina 28802

The Shady Grove Church and school came into existence sometime before 1877. Travelling preachers of various persuasions preached there in the same building as was used for a graded school. On a busy Sunday, Sept. 17, 1893, Rev. Jerry Cullom recorded the following in his diary: "At eight o'clock, married Charley Mc-Daniel to Miss Donia Johnson. At eleven, preached at Grant's Chapel, at three at Mt. Carmel, and at night at Shady Grove. We protract the meeting. There were eleven mourners, and one conversion tonight." This well-known Methodist was still having "a good crowd at Shady Grove" as late as Sunday, July 7, 1901. The new century was to bring changes to the community, however.

The brothers, Lycurgus Bartlett Shannon and John W. D. Shannon, arrived at Shady Grove and organized the Freewill Baptist congregation, with ten members on July 20, 1902. A Building Committee was appointed soon after the organization, consistion of W. T. Major, S. N. Hogan, and Robert and Will Heflin. The brothers Shannon boarded at the home of the community storekeeper, Monroe Williams, while the building was being erected. The log building was completed and dedicated on April 9, 1911 by the Rev. Jessie Hudgins. A photograph of this building survives, and shows it had two front doors, and three side windows. It was replaced in the early 1950s with the present structure, on approximately the same site.

By 1912 the congregation was sending delegates to the Baptist Association meetings. J. A. Major, A. R. Hogan and A. Jackson were delegates in that year. The next year Henry Holt and A. R. Hogan were to go, with J. A. Major as alternate.

The congregation has yielded more than one minister to Christian service. The first was A. R. Hogan, who preached the second sermons in June 1916 and was later ordained an Elder. He subsequently became a Methodist, and labored in that denomination for over forty years.

The present church building was constructed in the 1950s. It has basement classrooms and a large sanctuary. Since 1970 a large wing has been added on the west side, and the entire structure has a brick veneer. A modern Parsonage was constructed in the 1960s one mile south of the church.
