MILITIA COMMISSIONS

Before Tennessee became a state, the early militia organizations, as well as those of the South West Territory, were based on the Militia laws of the State of North Carolina. Under these laws each county had a separate regiment of Militia, divided into Captain's Companies, each regiment being designated by the name of its county. In 1797 the General Assembly ordered that there be a regiment of militia on the South side of the Cumberland River to be designated as the First Regiment of Davidson County, and one on the North side of the Cumberland River to be designated as the Second Regiment of Davidson County. In each of the other counties their regiment was designated as the "First Regiment of the County".

Under the Militia Law of 1803, the General Assembly adopted a numerical system of identification, assigning a number to each regiment, in each county, again, these regiments were known locally as the First Regiment of the County.

It was not until 1810, that the increase in population made it necessary, under the law, to organize an additional regiment in some of the counties. These were known as the "Second Regiment" of the county and were assigned a Regimental number in the order in which they were organized by the General Assembly of 1811.

NEW YORK ACADEMY

New York was located near where Blooming Grove Creek empties into the Cumberland River. The following was taken from the TENNESSEE WATCHMAN, Friday, November 2, 1821. Copies of this paper are on microfilm in the Clarksville-Montgomery County Library and at the State Library and Archives, Nashville, TN.

The public examination of the students of New York Academy closed on Thurdsay, last, highly to the credit of the Teachers and Students, and perfectly to the satisfaction of the parents and supporters of the school. The Committee feel themselves justified in saying that the improvements of the school evince great exertion on the part of the teachers and diligence and industry on the part of the pupils.

If any are entitled to distinction, where all deserve praise, they are the following:

ENGLISH DEPARTMENT -- James Craft, Arthur Bryant, of a class which commenced the alphabet this session, read and spell with most accuracy. Henry Bryan, John Bayliss, John Armistead, Cordy Wall, and Lucinda Shemwell of a class in Spelling and the Testament, deserve distinction. The next class in Reading, Spelling, and English Grammer consisting of twenty four members deserve commendation—arina Bryan, Joseph Williamson, Gilford Mitchel, Drew Smith, and Robert Armistead were considered the best in grammer, but in reading and spelling Harriet Craft, Mary Bryan, Sally Craft, Penelope Bayliss and Maria Craft bare equal praise. John Outlaw acquited himself handsomely--

Of those who have attended to Arithmetic, John Clements, John Askin, and (sic) Mockbee, have improved most. Eleanor Shemwell and Henry F. Cossitt appear to have improved most in writing.

CLASSICAL DEPARTMENT -- In a class in Euclid, if there by any difference, it is in favor of Turner Smith. In a class in Greek Testament, if there be any difference, it is in favor of Wm. K. Turner. Of the class in Corfeii (?) William Dortch is decidedly the best scholor. Nicholas G. Smith acquitted himself very handsomely in Historia Sacra and the Greek Testament.

Of the class in S(e?)lectae Vetria, if there be any difference, it is in favor of Robert Clement, but George Craft also deserves honorable mention. With regard to those who attended to Geography, Astronomy and the use of the Globes, as they commenced at different times, and studied different authors the committee cannot speak with percision, but acquiesce in the pinion of the teachers who all give the place in astronomy to William K. Turner and Turner Smith. Several appropriate speeches were delivered by the young gentlemen, which did honor to their taste and abilities.

The business of the Academy will be resumed on Monday the 28th October under the superintendam of the Reverand F. R. Cossit, as principal and George G. Cosit, as assistant.

SOLDIERS FROM MONTGOMERY CO., TENNESSEE in the REVOLUTIONARY WAR and WAR OF 1812

WILLIAM GRAHAM -- Revolutionary War

On the 22nd of August 1820 William Graham appeared before the Circuit Court of Montgomery County, Tennessee, and made the following statement for the purpose of obtaining a pension under the Acts of Congress of 18th March 1818, and first of May 1820. He was then seventy one years of age.

He enlisted for the term of two years on the ______ of February in 1777 in Virginia in the company commanded by Captain Nathaniel Cox, Colonel Dangerfields Regiment. He served his two years and was discharged from service in the State of Pennsylvania. He was in the battles of Piscatawa, Saratoga and Marsh Plains. He has no evidence now in his power of his said service except his own affidavit.

In pursuance of the Act of the first of May 1820 he swears he was a resident of the United States on the 18th of March 1818 and has not since that time by gift or sale disposed of his property in an attempt to deminish it. He has no property or debts intrust for him...He lists one sorrel mare worth forty dollars,.."a tiller I am of the earth and am not able to support myself, through bodily infirmities, and have no family of any sort."

He was inscribed on the Pension Rolls of West Tennessee on 31 Aug. 1819 at the rate of \$8.00 per month.

The 1820 Census of Montgomery County, Tennessee, (page 8) shows William Grayham 1 m under 10; 1 male 26-45; 1 male over 45-1 female 16-26.

BAYLESS E. PRINCE -- War of 1812

In response to the article in the March issue on Bayless Prince, Jill Garrett, Editor of THE RIVER COUNTIES, added the following bit of information:

"The following tombstone is in the old James Holland Cemetery on Duck River here in Maury County....

PRINCE, Bayliss Ear, who died in Aug. 1825. He served his country with credit to himself as an officer in the Creek War at the Battle of New Orleans...... The stone is down and broken today."

FIFTH JUDICIAL CIRCUIT COURT RECORDS 1816 - 1826

(original records are located in the Manuscript Section of the Tennessee State Library and Archives, Nashville. These records are also on microfilm.)

THOMAS S. KING & OTHERS vs AMOS HATCHER & OTHERS - March Term 1818

(p. 43)...Bill of Complaint of Thomas Seawell King and Betsy Hicks King, his wife, and Peggy Frear Seawell, an infant by her next friend William Cogswell Morgan, and the said William Cogswell Morgan and Nancy Booker Morgan, his wife, complainants against Amos Hatcher, John Henderson, Daniel Henderson, Thomas Traves, Samuel Smith, and Charles Cherry defendants....

...Archibald Butts served as a drummer in that part of the Continental Line which was raised in North Carolina for and during the war...Sometimes about 1783 or 84 he was issued a grant from North Carolina for 1000 acres of land... Sometimes before the 19th of July 1784 he sold the warrent to Thomas Tullock now deceased, but then of the town of Halifax, North Carolina. He paid for the same "a full and valuable consideration which said Archibald actually received." The warrent was transferred in writing which has been lost and was not endorsed on said warrent. The warrent was delivered to Tullock.

Thomas Tullock before the 19th July 1784 delivered the warrent to Anthony Crutcher and James Cole Montflerence or one of them to be located. The land was located and entered for him on the Entry Book kept for the Military Lands by Martin Armstrong, the Surveyor General, and bore the date in the said book 24th July 1784. A survey was made upon the entry the 26th of March 1785 and a grant issued thereon the seventh of March 1786...the grant describes the land as "on the North side of Cumberland and Red River at a Sulpher Lick and sweet gum marked E.C...north 200 poles to a hickory and poplar...west 400 poles to a red oak a post oak.... south 400 poles to two red oaks and a ash .. east 400 poles to an ash and gum on the bank of Red River..north 200 poles to the beginning."

On the 10th day of January 1785 Thomas Tullock died leaving a last Will and Testament directing that the lands be sold and disposed of by executors, who, however, never did dispose of the same in any manner, and left also one only child named John Vincent Tolluch and a widow Susanna since married to Benjamin Seawell of Davidson County by whom she had three children, "towit",..Betsy H. King, who married before she was 21 to her present husband Thomas Seawell King...Nancy Booker Morgan, who married before she was 21 to William Cogsdel Morgan..and Peggy Frear Seawell....all born in the lifetime of the said John Vincent Tulloch, who died intestate and under the age of twenty-four years without wife or child or other brother or sister about the 23rd day of August 1805...All his realestate both legal and equitable descended to the orators as heirs at law....

....Long after the emenation of the grant. Robert Nelson now accused made several entries for the same lands all dated after the day the grant was issued... Nelson knew that the land was claimed by the son of Thomas Tullock, deceased....

Thomas Tulloch appointed four persons to be the executors of his last will...Susanna, his widow who never qualified...Robert Freer, who also did not qualify and is long since dead...James Cole Montflerence who did qualify as one of the executors and left the United States for France in 1790 or 1791..and Andrew Armstrong who qualified..and is long since dead. James Cole Montflorence has not been heard of..for six or seven years...

Nelson entered and took possession of all the said land comprised in the grant to Archibald Butts in the time of the infancy of John Vincent Tullock .. until he sold the same to the defendants above named..all of whom and no others were now in possession ... Nelson, before taking possession of the lands sued Thomas Dunbar in a Action of Ejectment for the same in the Court of Pleas & Quarter Sessions of the County of Tennessee and obtained judgement in the July Term of Court 1792. Robert took possession of the land that same year and kept possession and occupation thru the years 1801-1802-1803.

Being bound to pay the taxes on the lands for 1802, Robert either failed to pay the taxes or to give in the same for taxation... the sheriff reported to the court in 1803 that the taxes for the year 1802 were not paid and the court ordered the land sold for taxes against Archibald Butts, who was then dead....

The lands were sold in October of 1803 to the said Robert for nine dollars and forty one cents....the orators state that the omission to pay the taxes was intended for the fraudulent purpose of extinguishing such claims for the land that were opposed to his title.....

..In 1799 in the Supreme Court for the District of Mero an Action of Ejectment for recovery of said land was brought for the demise of Archibald Butts, but really for the use of the heir..of the said Thomas Tulloch against the said Nelson..and others holding under him. In that action Richard Fen was the Plaintiff as the assee of Archibald and....Judgement adverse to the claim of the said Tullock and Butts ..issued to said Nelson....Orators declare fraud on Nelsons part as their claim was well known to him since September 1788.

Request lands be returned to the defendants and accounting of the profits during the possession.... J. Haywood for the Complts.

Thomas Travis admits in court on 24 January 1815 that he is in possession of a small tract of land, part of the land (so he had heard)... granted to Archibald Butts...He holds the land as tenant at will to the heirs of John Timms? deceased whose widow

he married he has never pretended to claim any title to the land.... He asks to be dismissed with his reasonable costs and charges in this behalf "most wrongfully sustained".

Will L. Brown Solct.

Daniel Henderson comes into court and states he believes Archibald Butts did get a 1000 acre grant from North Carolina...but he knows nothing about the transfer to Thomas Tulloch or anyone else.... He does admit that Robert Nelson, now deceased, made several entries covering the land granted to Archibald Butts, but does not know if they were made previous to or subsequent to the Butts Grant....Grants were issued to Nelson pursuant to his entries but had no knowledge if Nelson knew about the claim of John Vincent Tullock or any other person....He knew nothing about the suit against Thomas Dunbar....He did believe that Nelson took possession of the land about 1792 and that Nelson or some person claiming under him was in possession during the years 1801-2-3.

He "humbly insists" that Nelson was not bound by law to pay the taxes inorder to prevent the said land from being sold as the property of Archibald Butts...Nelson was not prevented by law from purchasing the land at the sale for taxes for the purpose of quieting and perfecting his (Nelson's) title to the land.. that he had no knowledge that Nelson intended any fraud in the act...to extinguish the claim of Butts or any other person....

This defendant says he is in possession of 100 acres of the land contained in the Complainants bill...this land and 20 more acres contained in the tract were conveyed by Robert Nelson to James Lindsey on 1 January 1796 by a deed duly proven and registered in the same year...(for \$60). This defendant claims title to the 100 acres by a deed from William Ross Junior executed on 18 Dec. 1805 for \$110. William Ross was in actual possession of the land at the time of purchase from him and claiming under the said James Lindsay,..deeded to the defendant one undivided moity or three sixth parts of the tract of 120 acres...Sometimes in the year 1811 he bought the remaining 40 acre tract from John Lindsey, one of the heirs of James Lindsey....But as yet he has not yet gotten a deed from John for the forty acre tract...

He claims he knew nothing about the claim of Thomas Tullock's heirs at the time he made the purchases....further states that he has had more than seven years "quiet and peaceable possession" of the lands without any suits...asks that he be allowed the benefit of the third and fourth sections of Act of Assembly of the State of North Carolina which is in full force.. in this state enacted in 1715 entitled "An Act concerning old titles of lands and for Ametations of -ctions and for avoiding suits in law and also the benefit of the fourth section of an act of the General Assembly of the State of Tennessee entitled "An Act prescribing what shall be the legal probate of deeds and conveyances of land and mortgages when such probate shall be made without the limits of this state and within the limit of the United States and for other purposes"...

Charles Cherry comes into court on 24 January 1815 and states he knows nothing about the transfer of the land from Butts to Thomas Tullock or about the suit against Dunbar, but does know that Robert Nelson was in possession of the land granted to Butts since 1792...that he has title to 274 acres of the land by a good deed frim William Tait dated the 30th October 1812 which has since been proven and registered in Montgomery County for which he paid seven hundred dollars...he had no knowledge at the time of purchase of any other claim.... William Tait claimed title to the land by a good deed of Conveyance from John Newell and Newell by a good deed from Robert Nelson, since deceased.. who he heard and believed received the land by grant from the State of North Carolina....

He claims he has had more than seven years quiet and peaceble possession....requests benefit of third and fourth sections (as above).....

John Henderson comes into court on 24th January 1815...He has no knowledge of Tullock, but does admit that Butts received a Grant for his services and that Nelson made several enteries covering this land...Nelson received a grant, but does not know if Nelson knew about the other claims... He knew nothing about the suit against Dunbar...He does believe Nelson took possession of the land about 1792 and was in possession of the land in 1801-1-3., but "humbly insists" that Nelson was not bound by law to pay the taxes..... Has no knowledge of fraud in this action...

He admits being in possession of 106 1/4 acres of this land... He purchased 100 acres of the land from Samuel French about the 9th of August 1804 for \$100 and received a good deed..Robert Nelson gave him the good deed for the other 6 1/4 acres about 30th December 1807...(\$15)...He has had no notice of any other claims against the property...He has been in quiet and peacable possession.....Requests benefits as above....

Amos Hatcher comes into court on the 26th January 1815....He knows about the grant from North Carolina to Archibald Butts, but has no knowledge of transfer to Thomas Tulloch....Robert Nelson did make entries on this land and obtained grants on these entries....Nelson took possession of land in 1792...he knew Nelson purchased the land for taxes in 1804...his is "ignorant" of any fraud...

He is in possession of 255 acres...230 he claims by a good deed from Hugh F. Bell about 24 August 1810 for \$1000...the other 25 acres he claims by a good deed from Thomas Brantley dated 7 November 1809 for 139 3/4 acres..Brantley held theland by deed from Nelson.. He requests benefits as above....

Samuel Smith comes into court on 26th January 1815.... He has the same knowledge as the others.... He is in possession of about 162 acres which he purchased from Hugh F. Bell about 25th August 1811... Requests benefits as others before.

The defendants file Replication to the answer of each man and state it is not true....22 February 1815.

DECREE--18 March 1818 this cause heard before the Honorable Archibald Roane, Robert White and John Haywood, Judges...A copy of the grant mentioned was produced and was proven by the deposition of Benjamin Seawell that James Taylor told him he was present when Tullock dec'd purchased Archibald Butts land warrant for 50 Pounds paid in merchandise and that Taylor was acting as clerk for Tullock at that time.. Seawell further says that sometimes after 1798 he informed Nelson of Tulloch's claim...some conversation was had on the subject of a compromise which failed...

Witness further proves that John Vincent Tulloch was the only child of Thomas Tullock deceased..that John V. Tulloch was born about the 21st October 1782 and died about 23rd August 1805 in Rutherford County, Tennessee...the complainants are his heirsat-alw...He does not know what became of the mercantile books of said Tullock, but believes they were inveigled or destroyed by Tulloch's executors by the deposition of Mary Peterson, Isaac Peterson and Thomas Dunbar. It was proven that Nelson had notice of Tulloch's claim...and defendant's had knowledge of Butts grant and claim, but not of Tulloch's...Copies of Nelson's grant and purchase of land for taxes proven....

As present owners paid money for land and did not know about Tulloch ..ordered that Complaintants Bill of Complaint be dismissed .. and complaintants pay the cost of suit..

Confederate Soldier

This information was compiled from questionaires sent out to Veterans of the Civil War in 1922 by the Tennessee Historical Committee, Department of Libraries, Archives and History, John Trotwood Moore, Director. The chief purpose of the questions was to bring out facts that would be of help in writing a true history of the Old South. In addition to the information abstracted the veteran gave his opinion concerning the relationship of slave owners and non-slave owners in his community. The originals are found in the Manuscript Section of the State Library and Archives, Nashville, TN.

B. H. HUNT lived at Route 4, Clarksville, Tennessee, when he answered his questionaire in 1922. He was 74. He was born in Bedford County, Virginia, and served as a confederate soldier in Co. I, 58th Virginia Regiment.

His father Thomas H. Hunt, a farmer, was born in Bedford County Virginia. His mother was Sophia Ann McGhee, daughter of Charles McGhee who lived near Liberty, Virginia. Before the war his father owned no land or slaves. They lived in a three room log house. As a young man he worked on a farm--plowing, hoeing, and doing general farm work until he joined the army. His father was a regular hand on the farm. His mother's duties were those of a general housewife..cooking, spinning and weaving, etc.

He attended subscription schools for about five years, walking three miles to school. These private schools ran about six months in the year. Both boys and girls attended the school. The school had a man teacher.

In 1864 (March) he enlisted at Liberty, Virginia. His company was sent to the Rappahannock River. About two months after his enlistment he was engaged in his first battle at Battle of the Wilderness.

Following the Battle of the Wilderness he went to Spottsylvania Court House where they fought six days and six nights. They then went to Cold Harbor, Virginia. The confederates, he adds, were victorious in all the above battles. They had plenty to eat at times, but at other times they did not have very much to eat and were exposed to cold and disease. He was discharged soon after the surrender.

After the war he farmed as long as he was physically able. He lived in Kentucky and Tennessee after the war. He was a member of the Missionary Baptist Church.
