REV. JOHN NEBLETT
of Virginia and Tennessee

Francis Neblett made his will in Lunenburg County, Va., August 27, 1777, and same was probated June 11, 1778. We, therefore, prove that Francis evidently took no part in the Revolutionary War. His wife, Elizabeth, died after 1783 but there does not appear to have been any court record pertaining to her death. Her name appears as having paid a tax the last time in 1783.

The inventory of Francis Neblett is very long and uninteresting with only one entry after another of various items showing that he collected quite a mass of worldly goods during his life. This is recorded in Lunenburg County, Will Book 3, page 9, dated July 7, 1778. The appraisement is also noted in the same book.

From the will of Francis Neblett as on record in Lunenburg County, Virginia, we gather his issue with notes as follows:

1. Sterling, born October 23, 1753 in Albemarle Parish; married twice: first, Mary Chappell, second, Betsy Coleman. He appears from the records of Sussex County to have owned land in that county and been a most prosperous citizen. He has descendants scattered throughout Southside Virginia. His son, Dr. Sterling Neblett became a very prominent man in his day.
2. John born Albemarle Parish September 10, 1775. This John is not to be confused with another John mentioned in the Albemarle Parish Register as son of Francis and Elizabeth. It is true we do not find an entry to the death of the first named John, but it is presumed that he died and later they (Francis and Elizabeth) named another child born to them the same name. John Neblett born September 10, 1755, became a minister. I find that he lived at various places in Southside Virginia during his career in that state. He married Susannah Hightower.
3. Elizabeth, born November 23, 1746, married Sterling Orgain. Many of their descendants

are to be found in Montgomery, Stewart, and adjoining counties of Tennessee and some in the Kentucky-Tennessee border counties.

4. Sarah, born October 21, 1750, married a Mr. Allen. I am told that they also migrated to Montgomery County, Tennessee, and settled with the Orgain and the John Neblett families. This is probably a fact, as I find an Allen family in Montgomery County who appear to have been very closely associated with the Neblett and Orgain families, there.
5. Lucy, who in her father's will is not mentioned as being married.

John Neblett (Francis) married Susannah Hightower prior to 1779. We have record of a son Edward born 1779 and he is said not to have been the eldest child, which is shown by the will of his father, provided the children are named in said will as they were born.

John Neblett was a minister of the Methodist faith and appears to have lived in Lunenburg, Brunswick, and adjoining counties of Virginia at various times before coming to Tennessee and settling in Montgomery County.

There are some twenty five or thirty entries of deeds in Lunenburg in the name of John Neblett, few of which give any information except that he purchased and sold land at various times in that section.

On September 11, 1788 he purchased a tract of land from Drury Mathew and same is recorded in Deed Book 15, p 249.

In April 1800 he sold to Joseph Moor a tract of land in Lunenburg County. Book of Deeds 18 p 171.

April 10, 1800, John Neblett to Sterling Neblett, a tract of land in Lunenburg County. Deed Book 18, p 172.

November 12, 1803, John Neblett and others to Wm. Singleton land in Lunenburg County, Deed Book 19, p 214.

October 8, 1806, John Neblett to Thomas Adams, land in Lunenburg. Deed Book 21, page 16.

October 8, 1806 John Neblett to Thomas Orgain, Deed Book 21, page 17, land in Lunenburg County, Virginia.

May 22, 1806 John Neblett to Herbart A. Sturdivant, land in Lunenburg County, Virginia. Deed Book 21, p 18.

After this date he is not found in Lunenburg County in any business transactions, but is found in Montgomery County, Tennessee.

In Brunswick County, Virginia, Deed Book 18, page 11, John Neblett of Lunenburg County, on January 3, 1800, buys land in Brunswick County from Daniel Taylor and his wife, Rebecca. Witnessed by Sterling Neblett, Jr., Wm. Duke, and John Oghern (Orgain?). On page 59 of the same book, Rebecca the wife of Daniel Taylor acknowledged her dower.

In Book 20, p 53, of the deeds of Brunswick County, John Neblett and Susanna his wife of Lunenburg County to Sterling Neblett, Senr. of the same county and etc...in 1807 a tract of land.

In Montgomery County, Tennessee, there are a large number of deeds recorded which refer to this John Neblett.

In Deed Book D, page 57, Septhen Cocke deeded to John Neblett 450 acres of land on the south side of Cumberland River. This deed reads as follows:

(being a short deed I copy here in full)
This Indenture made this nineteenth day of July Eighteen hundred and six between Stephen Cocke of the County of Montgomery and State of Tennessee of the one part and John Neblett of the County of Lunenburg and State of Virginia of the other part, Witnesseth that for and in consideration of the sum of Eighteen hundred Dollars in hand paid, the receipt and payment is hereby fully acknowledged hath granted bargained sold aliened conveyed and confirmed and do by these presents grant bargain sell and convey and confirm unto the said John Neblett a certain tract or parcel of land lying and being in the county aforesaid, etc, etc, etc,...Witnessed by William Allen, Abner Harris, Isham Trotter, William Whitehead. (Signed) Stephen Cocke. Proved in Court September Term 1806.

There is not a doubt that the John Neblett in Lunenburg is the John Neblett of Montgomery County, Tennessee, from this deed.

Permit me to extract a number of other deeds and other records in Montgomery County pertaining to this man which may be of interest to my readers.

Will Book B (1811-1818) p 444. A bond. John Neblett Jr. and others including John Neblett, Sr, all of Montgomery County,

bound to Joseph McMinn, Governor, July 21, 1818. The obligation is John Neblett, Jr., to account for Public Monies collected by him from the Treasurer of West Tennessee.

On the same page is another bond. John Neblett, Jr. and John Neblett Senr., whereas John Neblett Se. is appointed Sheriff of Montgomery County. Bond is dated July 21, 1818, and is bound to Joseph McMinn, Governor.

Will Book B, page 240, a bond. John Neblett Jr. and John Neblett Sr., and others of Montgomery County, Tennessee, bound to Governor Joseph McMinn July 16, 1816. The condition of this obligation is John Neblett Jr. accounts for public monies collected from Treasurer of West Tennessee, etc. etc.

Will Book C, Montgomery County, Tennessee, page 322. John Neblett of Montgomery County as Sheriff makes sale and gets judgement against James Dickson, Jan'y 24, 1820.

In Will Book D, page 99, Montgomery County, Tenn., I find a bond which I am unable to say refers to the John Neblett Jr. or Sr. Therefore, I extract it here, in brief: Sterling Neblett, John, Stephen Neblett and others are bound to the Governor, October 21, 1822. Sterling Neblett is appointed Executor of the last will and testament of David Harrison, dec'd.

In Will Book H (1837-1840) page 3, is an account with the estate of John Neblett.

In Will Book G (1834-1837) page 522, shows the division of slaves of John Neblett.

Will Book H, p 74, shows a short inventory of the estate of Susan Neblett in 1837.

On page 635 of Will Book G, the bond executed by administrators of Susan Neblett.

In Will Book 1826-27, page 225, John Neblett was made guardian for heirs of Asel Brunson, dec'd and he makes settlement, Jan'y 28, 1828.

Rev. John Neblett lies buried in Montgomery County, Tenn., and his tomb although standing, is in a very delapidated condition. It is in a barn lot on the farm owned by the heirs of Mr. Andrew Lyle, located on the Palmyra road nine miles south of Clarksville. This tomb shows that he was born Sept. 10, 1755 and died March 11, 1830. These dates check with the family Bible of his son Edward as to the death date and the birth checks with that given in the Albemarl Parish Register. Therefore, there can be no mistake in the correct identity of the man.

There is one other tomb standing in this sacred plot of ground, that of Sarah Vance Neblett born March 19, 1790 who was

twice married: first to Asahel Brunson, Jr. and second to John Neblett Jr.

John Neblett's will is in the records of Montgomery County. There are many deeds pertaining to this man but after a careful examination I find they are so little value I omitted them.

Permit me to make a remark here regarding the tomb of Rev. John Neblett. Unless some step of preservation is made in the near future, I fear that another ten years will find no trace of stone or grave. When I visited the place stock was allowed to run in this lot and nothing there to protect the stones. On my first trip to this place I found a sheep leisurely using it for a pillow upon which to rest its tired body in the shade of a few small trees, more commonly called bushes.

I did not find the tomb of Susanna Neblett, his wife, but I did find that there are several graves which have no tombs in the small plot which in days gone by were enclosed by a small rock fence about one and a half feet high. I am confident she must be buried in this same place.

From the will and various other records we have the issue of John and Susanna Neblett as follows:

1. Francis. Married a Miss Ferguson.
2. Sterling. Married a Miss Daly.
3. Elizabeth. Married _____ Whitehead.
4. Edward, born August 9, 1779 and died Oct. 11, 1845. Married Ann H. Roberts December 5, 1805. (Bible Record)
5. Lucy. Married Peter Givin (Gavan).
6. John Neblett. Married Sarah Vance, the widow Brunson. I have seen some records that give John's name as John Ball Neblett. His second wife was a Miss Roberts.
7. William Neblett. Married Miss Carney. He married three times, two of which I have positive records of.
8. Benjamin. Married twice. First wife's name unknown. Second wife, a Miss McAllister.
9. Susan, who married Richard H. Adams.
10. Stephen. Married a Miss Allen.
11. Mary, who married John Martin

12. Henry. Married a Miss Bosley
13. Sally, who married Mr. _____ Daly.
14. Daniel. Some family records of Mrs. Weaver (nee Mary Bell Neblett) of Charlotte, Tenn., Dickson County, gives the name of Daniel in the list of children of Rev. John and Susannah, but no other place have I found the name.

Mrs. Weaver has in her possession some old papers and data showing much of the family tree of John and Susannah. It is just an outline made by some member of the family without any documentation. I think, however, it was made a number of years ago during the life of her father W. H. Neblett who died in 1909.

Rev. John Neblett having been a Minister in Virginia is possibly the reason why he is not found to have been a notable soldier of the Revolution. The only record of his having aided in that conflict where the name is spelled NEBLETT is where he furnished three hundred pounds of Beef to be used in the feeding of forces: Lunenburg Co., Va. Public Claims, 6 May 1782, John Neblett--paid for 300 pounds of beef used in service at 20 shillings per pound.

We find in the Revolutionary manuscript papers in Richmond, Virginia, the mention of a John Noblock having served from 27th of February to 27th of March 1781: (Virginia State Library-- "A Payroll for Capt. Robert Patterson's Co. Milita, ordered on duty in defense of Fayette Co. from 27 Feb. to 27 Mar. 1781. By order of Cy. Lt. Todd. I. P. D. 166.

It is the opinion of those in the department in Richmond, known as the Department of Archives and History; of Mr. Bell, who is an authority on the Lunenburg records; and myself that this service is for John Neblett, as we do not find a family by the name of Noblock in Lunenburg County. This same entry is found mentioned in the Lunenburg County records in the Court House and in Order Books. I include it for additional service, with the stipulation of a doubt, but in our opinion is intended for the same man.

We prove that he furnished some supplies as above stated where his name is John NEBLETT. This is sufficient within itself for membership into the Daughters of American Revolution. We know the man who furnished the beef is our John Neblett.

JOHN DARNELL -- War of 1812

1st Reg. (Bradley's) Tennessee Volunteers 1812.

"Know all men by these present that I John Darnall of Montgomery County and State of Tennessee do hereby constitute and appoint Thomas Potts of Rutherford County and state aforesaid my true and lawful attorney who may and in my name receive of the paymaster of Tennessee or such other person as may act for him to pay what is due me for my service against the Creek Indians, who is authorized to receive and receipt for the same in a full and simple a manner as if I were personally present myself in Testimony where of I have hereunto set my hand and affixed my seal this 5th day of September 1814.

John (X) Darnall "

State of Tennessee

On this 30th day of June 1854
John Darnel, aged 67 yrs--
Resident of Montgomery Co.,
Tennessee --was a private in

a company commanded by Capt Thomas Nash---Volunteered for two years---called about 1st December 1812---was mustered at Nashville---tour of duty to Natchez Co.---about four months. Discharged at Nashville 20 April 1813---Does not think he received any written discharge---Again called at Fayetteville, Tennessee...He thinks about October 1813 in same Company--- Performed a tour in the Creek Nation of Indians and continued to serve, he thinks, about January 1814..Last service about three months and was discharged at Fayetteville, Tennessee, about 1 January 1814 and received an honorable discharge which has since been lost or misplaced so that he cannot command it having given to a friend sometime since to procure his warrant who never did it and has removed so that he can hear nothing.. but that he made no declaration or application whatever and has received no Bounty Land whatever for said service...he makes this declaration for the purpose of obtaining the Bounty that may be due him for said service. He also hereby appoints Wm. Rogers his attorney to do and transact any and all matters thereto pertaining.....

Sworn to before Chas. Bailey, JP.

State of Tennessee
Montgomery County

...27th day of June AD 1871 personally appeared before me Peter Oneal, Clerk of the county court for Montgomery County & State of Tennessee, a court of record within and for the county and state aforesaid, John Darnell, aged eighty-two years, a resident of Montgomery County...who being duly sworn according to law, declares that he is married...that his wife's name was Betsy Pruitt to whom he was married in Montgomery County on the ___ day of ___ 1865...(NOTE: Marriage Records, Montgomery Co., Tennessee, Book 3, #1760--John Darnell to Mrs. Elizabeth Pruitt 24th August 1866...AWD)

....That he served the full period of sixty days in the military service of the United States in the War of 1812..that he is the identical John Darnell who volunteered in Captain Nash's Company, 1st Reg. Tennessee Volunteers commanded by Col. Carral ___ Brigade ___ Division on the ___ day ___ 181- and was discharged at Huntsville, Alabama, on the ___ day ___ 1881-that he served as a private in the infantry service at the Battle of Tallegega, Alabama, on the 9th day of November 181- and the Battle of Tallahatchee on the ___ day of ___ 181- and has received under the Act of Congress of the year 18-- Land Warrent No. 12475 issued on the 8th of December 1855 as will be seen by reference to the pension book of that date.

...That he at on time during the late Rebellion...against the authority of the United States....

...February 14th 1871 his post office is at Oakwood in the County of Montgomery, State of Tennessee. He lives at Oakwood.

"Po're" John...he never did get his pension. He should have known if he was there, but one place it is JOHN DARNOLD!

John Darnell shows up first in Montgomery County, Tennessee, in 1809..Hands on the road. David Lamb, James and John Lamb are on the same road. Tradition is that John Darnell's first wife was Elizabeth Lamb and the mother of his children.

According to the pension papers and the Montgomery Co. Census, John Darnell was born about 1787 and his wife Elizabeth about 1790. Both were born in North Carolina.

An administration bond was made for John Darnell on 31 May 1880 and acknowledged 7 June 1880. His first wife died after the 1860 Census and before he married in 1866.

According to the census, there were eight children. One I cannot prove, but think his name was Samuel.

Children of John and Elizabeth Darnell:

1. William Darnell born 1820 m. Elizabeth Smith, dau. of Basel Smith and Martha Hood. They are buried in the Darnell Cemetery near Blooming Grove Creek, but have no stones. William's descendants still live on his land. They had eleven children.
2. Alford (Alph) Darnell b. Sept 11, 1822 d. Jan 5, 1897. m. Louisa Tolar 3 March 1843. They are buried in the Liberty Church yard. Both have stones. They had five children.
3. Mary Darnell b. 1817 m. Peter Terrell 1 August 1839. They had seven (or more) children.
4. George Washington Darnell b. 1825 (census) m. Martha Barbee 24 July 1850. He was never seen after the Battle of Fort Donelson. The older people state that she took her three children and returned to North Carolina.
5. Robert L. Darnell b. February 10, 1829 d. Dec. 29, 1896. He is buried in the Darnell Cemetery and has a stone. His first wife was Ellen Tolar. They had at least six children.
6. Emily E. Darnell b. 1832 (census) m. (1) Bartley Barbee 1846. She had one daughter by this marriage. (2) Robert J. Tolar 3 October 1856. They had five children.
7. Joanna Caroline Darnell b. 1830 d. 1887. She married Will Henry Tolar 22 Feb. 1847. They are buried in the Liberty Church yard. She has a stone. There were several children.

The census gives all of the children born in Tennessee.

FIFTH JUDICIAL CIRCUIT COURT RECORDS 1816 - 1826

PHILLIP PARCHMENT vs JONATHON RAMSEY AND SAM'L CROCKET -- 18th September 1818.

Honorable Judges Archibald Roan, Robert White and John Haywood.

Sometimes in the month of December 1803 Phillip Parchment of Giles County in Tennessee executed a bond to the defendant, Jonathon Ramsey of the State of Kentucky for the payment of two hundred gallons of whiskey to be delivered at Clarksville, or one hundred dollars in money. The bond was due and payable sometime in the year 1805.

Sometime after the bond became due and before your orator (Parchment) had made any payment on it, one Samuel Crocket of Robertson County in Tennessee (where your orator resided) came to your orator and told him he had purchased the bond from Ramsey and had it in his possession. He proposed receiving salt from your orator in payment of said bond in lieu of whiskey & money.

(Parchment) did deliver to Crocket salt and money in payment of said bond. He called on Crocket for a settlement and demanded the bond be delivered to him. Under various pretences and excuses evaded delivering the bond. In 1812 a suit was filed in the courts of Robertson County on said bond in the name of Jonathon Ramsey, the original owner. In the April Term 1815 in Robertson County (Circuit Court) judgement was obtained against Parchment in the amount of \$130 which your orator could not give evidence of having paid. He asks the court to set aside the decision. They rule for the Plaintiff.

THOMAS SHUTE vs JACOB HARDER & OTHERS--September Term 1818

Thomas Shute of the County of Rutherford, Planter, ... on or about the sixth day of August 1807 Jacob Garrison entered a tract of land in the County of Dickson now Humphries in the entry book kept by the surveyor General for the first district on White Oak Creek of Tennessee River..containing 640 acres and was numbered with number 48..founded upon Warrant No. 4179 and in entry land was described as set fourth in the schedule..marked "A".

On the fourteenth day next following that on which said entry was made John Curtis entered in the same office two hundred acres of

..described in the schedule..marked "B"...and in the schedule annexed "C" the former being the words of the entry ... and the later the words of the grant to him expressing the boundaries of said land.

Your orator sheweth to your honor that as to the said two hundred acres entered by said Curtis he the said Curtis afterwards obtained his grant..dated on the same day set fourth and expressed in schedule "C" and the said Curtis after the grant had (been) issued to him conveyed the said two hundred acres described in his grant to Jacob Harder and his heirs and the said Garrison for valuable consideration actually paid to him in money the said Garrison bound himself by bond executed and delivered to the said Harder to convey to him the six hundred and forty acres of land contained in entry No. 48 which bond your orator does not have a copy of....but Harder has possession of bond and ought to set fourth the same.....

Your orator in the name of one Robert Thompson entered three hundred and forty acres of land within the bounds of the six hundred and forty acres surveyed for Jacob Garrison, except about four or five acres which land so entered in the name of Thompson is described in the entry as well as the date of the entry..on Schedule marked "E".

....Your Orator prays may be taken and considered as part of this Bill of Complaint and upon a Caveat filed to prevent the said Harder from obtaining a grant in the name of Jacob Garrison or in his own name or in the name of some other person on the said entry made by Garrison as he may cause the survey to be transferred..so that the grant may(be) issued to them for the purpose of defrauding your orator..... It was finally decided on said Caveat that ..the entry made in the name of Garrison was given preference in obtaining a grant over the entry made in the name of Thompson...Costs to be paid by Thompson....Harder to procure a grant.....for the 640 acres described in entry No 48....This defrauds your orator....

The Court of Pleas and Quarter Sessions for Williamson Co. in January term 1814 issued a judgement against Harder infavor of one Reuben Huggins. ...A sale was held in Humphries County by the sheriff and the 640 acres was purchased by Asa Shute, now deceased, on the 5th of March 1814.

Asa Shute died intestate leaving your orator one of the heirs.. That is he left the following persons, the children of his sister Anna, now deceased, but formerly married to Robert Hewitt, to wit, Caleb Hewitt, Hazael Hewitt, Malinda Hewitt under the age of 21, Emily Hewitt under the age of 21 years, Polly Hewitt under the age of 21 years, Aralina Hewitt under the age of 21 years, Carline Hewitt under the age of 21 years. The said Anna had not any other children.

Also he left the following persons, the children and heirs of his sister, Lydia, now deceased, but in her lifetime was married to John Gowen: John Gowen under the age of 21 years, Wilford Gowen under the age of 21 years, Amanda Gowen under the age of 21 years, Minerva Gowen under the age of 21 years, Maria Louisa Gowen under the age of 21.

He left also the following persons, the children and heirs of his sister, Polly, now deceased, who in her lifetime was married to Henry Childress, that is to say: Eliza Childress under the age of 21 and Margary Childress under the age of 21 years.

He left also the following persons, his brothers, to wit: William Shute, John Shute, Thomas Shute, your orator Philip Shute.

He left also the following persons, sisters who are yet living: Margery married to Beal Basley, Susanna married to John Harding, Rachel married to Christopher Stump, Elizabeth married to John Witherspoon.

Your orator showeth that Harder ought not in Justia obtain a grant for the said 640 acres of land as he is now at liberty to do by virtue and force of the judgment finally rendered on the Caveat as he will be at liberty to sell the land to some purchaser not having any notice of the facts set forth and to bar the claim of the heirs of Asa Shute which your orator believes will be wholly fruitless owing to his circumstances which in the opinion of your orator renders him unable to pay the value of the land to the heirs. Notwithstanding the just claim of your orator and the other heirs of Asa Shute, the said Harder is preparing to procure and cause the grant for the land to issue to him or to Garrison or some other person for the above mentioned purpose....

Asks the Court to grant a Wirt of Subpoena and a Writ of Injunction to stop the said Harder from proceeding on the said Judgment rendered as aforesaid.....etc.

"A" -- Jacob Garrison assignee of Jacob Smith heirs enters six hundred and forty acres in Dickson County on White Oak Creek of Tennessee in Range nineteen Section six begining eighty poles south of William Christian's north east corner running south three hundred and twenty poles thence etc.. Warrant No. 4179. Location No. 48, August 6, 1807, Survey & Returned 22 February 1810 by John Humphreys.

"B" -- John Curtis assignee of Waddle and McMillin enters two hundred acres of a part of Warrent No. 10 in Section six and eighteenth Range on White Oak Creek Begining on a Hickory forty poles south of Baleys Hoopers Northwest corner thence west two hundred poles thence north for complement to include his improvements in a centre of a square Location No. 76 August 14th 1807. Survey etc. & returned March 9, 1808 by John Humphreys

"C" -- There is granted to John Curtis by virtue of warrant No. 109 a tract of land containing two hundred acres being on part of said warrant and by virtue of Location No. 76 and entry made the 14th day August 1807 lying in Dickson County in Section Sixth and nineteenth Range on White Oak Creek begining at a Hickory forty poles south Baily Hoopers northwest corner runing thence west two hundred poles to a small crooked poplar and hickory thence crossing said

creek north one hundred and sixty poles to a Buckeye thence east two hundred poles to a white oak thence crossing said creek south one hundred and sixty poles to the beginning including his improvements on occupant Claim Grant issued 29th day of August 1808.

"E" -- Robert Thompson assignee of Thomas Clynseys heirs enters two hundred acres of land in Stewart County on White Oak Creek of Tennessee Beginning on the upper line of an entry in the name of John McNary for two hundred and six acres on Warrant No. 4106 Location 249 Running up the creek on both sides an oblong so as to include the best vacant land as the law directs parts of said warrant, Warrant No. 5138, Location No. 1518 March 30th 1808. Thomas Shute Loc. Survey etc. Returned 22 February 1810 by John Humphreys D.S.----- Robert Thompson assignee of Thomas Clinsey's heirs enters one hundred and twenty acres of land in Stewart County on White Oak Creek of Tennessee beginning on the upper line of an entry in the name of the said Robert Thompson for two hundred and twenty acres on Warrant No. 5138 Running up the Creek on both sides so as to include the best vacant land..part of warrant No. 5138 Location No. 1519. March 30, 1808. Thomas Shute Loc. Survey. etc. Returned 22nd February 1810 by John Humphreys D. S.

The above statements were made by Thomas Shute on 2nd of September 1816 before Robert White one of the Judges of the Supreme Court of Errors and Appeal....

Subpoena and Injunction issued according to prayer of foregoing Bill.

Thomas Shute also asks the Court to appoint Philip Shute guardian to the infant heirs of Asa Shute...Malinda Hewitt, Emily Hewitt, Polly Hewitt, Aralina Hewitt, and Caroline Hewitt; John, Wilford, Amanda, Minerva and Maria Louisa Gowan; Eliza and Margery, children of his sister Polly (Childress); ...Guardian to defend the suit...

Harder asks that the case be dismissed and that he recover his costs. ...Brown for Defendant Harder

Court rules for the defendant... Bill dismissed....Complainant to pay costs....

CAPT WILLIAM R. JAMES departed this life at the residence of his father two miles from Dover on Thursday the 25th inst.....in the 28th year of his age..

An example of the information to be found in these records is noted in the application of Joanna Staten of Mayfield, Ky. She states she had lived there since 1884 and was 29 years old. She was born in Montgomery County, Tennessee on 1-12-1857. Her maiden name was Joanna Lemay. Her husband, John James Staten was born in Sumley? (Sumner) County, Tennessee. They were married in Mayfield, Ky. John enlisted in Graves Co., Ky in 1861 Co. B. Ky Inf. later Mounted. He died 3-17-1902. She owns no property. They have two daughters one 16 the other 13.Application made 3-2-1914.

Attached is an afd. from E. I. Seay of R#8, Mayfield who states he does not know Joanna, but knew her husband all of his life. He was in the same company with him.....

Mark E. Staten, states he has known her for 26 years and that he was present at their marriage or or about 2-11-1888 in Mayfield, Ky.
