Red River Baptist Church Minutes

These minutes were copied from a typed copy in the State Library and Archives, Nashville, Tennessee. The original records were in the possession of Charles H. Fort in 1936. Please refer to Vol. IX, Issue #1 (September 1979) for the location of the various churches mentioned.

November the 26th 1791. The church met according to appointment. Bro. George Neville chosen Moderator. Bro. Richard Thomas informed the church that he had heard from and seen something like, repentance in sister Pope for her disobedience, her affair talked of & laid over for further consideration.

Bro. Richard Thomas requested and was granted a letter of dismissal from this church.

Bro. G. Neville ordered to cite Bro. F. Elliott to our next meeting to answer for absenting himself from meetings. Dismissed in order.

December 24th The church met in order Brother Neville moderator. Brother Neville informed the church that he had cited Bro. Elliott. Bro. & Sister Elliott laid under the censure of the church for not attending agreeable to citation.

No Church meeting in Feb. 1792.

Saturday April 29th 1792 After divine service the church met, chose Bro. Neville moderator. The affair of Sister Pope came before the Church, considered and laid over till our next meeting. Brother Elliott being present acknowledged his fault for nonattendance, says he repents & is restored to full fellowship again. Sister Elliott's nonattendance considered, and further dealings with her deferred to next meeting.

Agreed that the Church furnish the brother deacons with money or good trade to purchase wine before May Court. Likewise that Bro Prince purchase a Table cloth at the churches expense.

Saturday, May 26th 1792 The church met in order at their usual place. After singing and prayer, Bro. William Prince chosen moderator, proceeded to consider the affairs of Sister Pope, and further dealings continued and deferred to our next meeting.

Sister Elliott's nonattendance considered & continued; Bro. Elliott requested to make it known to his wife, that the church desires her to attend their next meeting. And so were dismissed.

June 23rd day. after divine worship the church met chose Bro Prince moderator. Proceeded to consider Sister Pope's affairs, & again laid it over to next meeting, and appointed Bro. Sal'll Wilcox to cite her to appear at the same.

Sister Elliott's nonattendance considered and satisfaction being obtained, she restored to full fellowship.

No church meeting in July.

August 25th. The Church met chose Brother Neville Moderator. Sister Lettuce Pope was excommunicated for obstinately refusing to obey the Church & breaking her solemn covenant engagements thereto.

No Church meeting till January 26th 1793.

January 26th 1793. The Church of Christ of the Baptist order near the mouth of Sulpher Fork of Red River met at the house of Bro. William Prince being time and place appointed. Chose Bro Geo. Neville moderator. Our desolate state at present for want of a preacher among us was taken into consideration, & it was thought necessary to write a letter, to the preaching brethren in Kentucky in order to stir them up to visit us, but with submission to the Will of the Lord, accordingly Brethren William Prince, Geo, Neville & Hugh Lewis were chosen to prepare one for that purpose & forward the same by the first proper opportunity. Then dismissed.

Accordingly a letter was sent in April ensuing by Jno. Mann.

April 27th 1793 The Church met at the time & place appointed. Chose Bro. Neville moderator, proceed to consider some disorderly conduct wherewith Bro. Cordery had been charged. On a motion by Bro. Prince for private dealing the whole Church obtained satisfaction thereby.

Rec'd Elias Fort and his wife Sarah by letter of recommendation from the Baptist Church of Christ near the falls of Tar River in Nash & Edgecomb Counties North Carolina. Then dismissed.

July 27th. The Church met after singing & prayer chose Bro. Neville moderator. On motion by Bro. Fort agreed that a majority of male members may hold conference in order to settle any Church business.

Query, by the Moderator, Is being present at feasting or frolicking such as is in practice, in the world consistent with orderly walking? The Church thinks that such feasting & frolicking where is drinking strong liquors, fidling, dancing etc., is pernicious and not to be practiced or countenanced in any ways by Christians.

Brother & Sister Elliott being absent several Church meetings, Bro. Neville is desired to cite them to our next.

On Motion the building of a meeting house was considered and agreed that one be built convenient to Bro. William Prince Spring, and agreed also that said meeting house be built by the county of the inhabitants of which purpose Bro. Fort is appointed to lay before our next meeting for consideration an instrument of writing for subscriptions.

Agreed that a contribution of money be made for Bro. Mason. Then dismissed.

August 24th 1793. Church met and after divine worship chose Bro. Neville moderator. Some contention between Bro. Cordery & William Brown Senr. considered, agreed that Cordery make Brown reasonable satisfaction.

An instrument of writing was presented to the Church by Bro. Fort in order to get subscribers for building a meeting house, approved and commissioners appointed. So dismissed.

September 21 1793. The church met. After divine worship chose Bro. G. Neville moderator. Agreed that a letter be prepared by the Clerk and sent by the Rev. John Sutton to the Elk Horn Association in Kentucky which was prepared accordingly.

No conference in October nor November.

December 28th 1793. The Church met. After singing & prayer Bro. Neville chosen moderator.

On motion the privilege of Female Members considered and deferred.

Saturday Jany 25th 1794. The Church met. After singing & prayer the Church chose Bro. R. Thomas moderator.

The privilege of female members conferred on at our last meeting considered. Agreed that the Sisters act freely and mutually with the male members in all matters of Fellowship & discipline but not to make motions, in their own Persons nor debate on the floor until further consideration. And so dismissed.


Saturday, March 22nd 1794. After public worship, the church met. Chose Bro. Rich'd Thomas moderator.

A door being opened rec'd Milbrey DeLoach by experience.

July 7th 1794. The church being called together, when Bro. Geo. Neville was called by the church to exercise his gift who cordially accepted the same, and as they began so concluded with singing & prayer. Then dismissed.

Dec'r 27th 1794. Being the time of our monthly meeting Church met chose Bro. Neville Moderator, a charge was exhibited against Bro. Roberts for taking his gun in anger to keep out the right owner of the house, of which he & his family were possessed. Bro. Roberts confessed his fault & said he was sorry for it. Showed visible marks of repentance, and was acquitted, & restored to Church fellowship again.

On motion by Bro. Fort & seconded by Bro. Prince agreed that four male members, be a church to do business. Bro. Isaac Wilcox being charged by members of this church with drunkenness, for which, and for removing his residence to a distant part, without consulting with the brethren-he is suspended from the privileges of this church until satisfaction can be obtained. Bro Elliott & Bro. Cordery for sundry charges are in like manner suspended from church privileges and Bro. Geo. Neville appointed to cite brethren, Wilcox & Elliott to appear in this church & answer to their charges. Bro. O. Roberts appointed to cite Bro. Cordery for the like purpose. Dismissed by prayer.



EARLY STOCK MARKS REGISTERED IN DAVIDSON COUNTY ¹

Along the frontiers during the early period of our country's history there were few fences to confine livestock to the owner's farm. In order to identify farm animals, a system of marking or branding was established and stock marks and brands were registered in the local courts. The system of marking stock and registering marks and strays was established in Davidson County at the January Court, 1784. Montgomery County was carved from the territory which originally constituted Davidson County, so that many names found in early Davidson County records are later located in Montgomery County, due to the change in boundary lines of the counties. The following list of stock marks is taken from early Davidson County court minutes.

January Term 1784 - Isaac Linsey Esquire is appointed for the registering of strays.

7th January 1784

DAVID ROUNSWELL records his Stock mark a cross & underkiel in the left ear and brands 2.

EBENEZER TITUS records his Stock mark a Slope under the Left ear and Underkiel in the Right and slit the Dewlap upwards & brands thus E:T:.

ELMORE DOUGLAS records his Stock mark thus an Under & over Kiel in each ear and Brands E.D.

JOHN BLACKAMORE records his stock mark thus a crop off the left Ear & underkiel in the Right: and Brands .

JAMES ROBERTSON records his Stock mark thus a crop & Underkiel in each ear and Brands R.

SAMUEL BARTON records his Stock mark thus a Cross & Underkiel in the Right Ear & a slit in the Left.

GASPER MANSCO records his stock mark thus a Crop off the Right Ear & Slits the Dewlap and Brands K:M:.

Davidson County, Tennessee Minute Book A, 1783-1790.

JAMES McCAIN records his Stock Mark thus a Crop off each Ear & Upper and underkiels in each and Brands R.

JONATHAN DRAKE records his Stock Mark a crop off the left Ear & a slit in it & Two underkiels in the Right and Brands I D.

JAMES SHAW records his Stock mark thus a half crop in the left Ear and underkiel in the Right and Brands I 2.

FRANCIS HODGE records his Stock mark thus a Crop and a hole in each Ear and Brands F H.

ANTHONY BLEDSOE records his Stock mark thus a Crop off the left Ear.

JOHN BUCCHANAN records his Stock mark thus a Crop off the left Ear and an under half Crop in the Right and Brands Wt Y^c flower de lace.

STEPHEN WRAY records his stock mark thus a Crop & Underkiel in the Right Ear and a Crop and under and Overkick in the left & brands S:R.

JAMES HOLLIS records his Stock mark thus a Swallow fork in the left Ear And a Slit in the Right and Brands I:H.

WILLIAM COLLINS records his stock mark thus a Crop off the Right Ear and a hold and underkiel in the left and Brands W.C.

THOMAS FLETCHER records his stock mark thus a Crop & a hole in the right Ear and underkiel in the left and Brands F.

JOHN BOYD records his Stock Mark thus a Crop & a slit in the Right Ear and two slits downward in the Left & Brands I B.

BENJAMIN DRAKE JUNR. records his Stock mark thus a Crop & Underkiel in the Right & Brands B.D.

ISAAC BLEDSOE records his stock mark thus a Crop and a slit in the Right Ear And underkiel in the Right and Brands thus IB in a Diamond.

DANL. WILLIAMS records his stock mark thus a Swallow ford in the Right Ear and Brands thus W.

WILLIAM OVERALL records his Stock mark thus, a Slit on the Right Ear and a Crop off the left.

OBIDIAH TERRELL records his stock mark thus, a crop & underkiel in the Right Ear and a cut downward in each side of the point of the left & brands thus **(T)**.

JOHN COCKRILL records his Stock mark thus, a crop off the Right Ear and underkiel in the left: And brands T:C.

MARK ROBINSON records his stock mark thus, a swallow fork and underkiel in each Ear.





PETITION SUPPORTING
THE BUILDING OF DAMS
ON RED RIVER

(Petition #1819-142. Original in Tennessee State Library and Archives)

To the Honourable General Assembly of the State of Tennessee --- We your petitioners humbly shew to your honourable body that the Citizens of Robertson and Montgomery County did in the year Eighteen hundred and twelve lay a petition before the General Assembly of this State praying that they wood repeal so much of an act that was passed in the year 1796 prohibiting any obstruction to the Navigation of Red River from Port Royal to the Kentucky line as there is many valuable mill seats on that part of said river, which petition was granted and since Mr. Gowen has built a mill across said river in the County of Robertson, and now Joseph Woolfolk and Cordial Norfleet has commenced building a mill across said river near and above Port Royal and the Citizens of Robertson County in order to prevent the building of said Mill are preparing a petition to lay before your Hon'd body at your rest session praying you wood pass an Act to prevent the said Woolfolk and Norfleet from erecting a mill dam across said river under a pretext that it wood obstruct the navigation of said river from Gowen's Mill to Port Royal which is only seven or eight miles and seldom deep enough for boats to pass but the hon'd petitioners of Robertson did not think that the building of a mill across sd river in Robertson County was any obstruction to the navigation of sd river because it was to benifit themselves. It plainly appears that they do not deal by others as they wood wish to dealt by. If they do they wood not try to prevent the people of Montgomery County from having the same priviledges as they have themselves and as there is no other watercourse in this part of the state that affords water sufficient to keep a mill grinding during the summer season such a mill as is now building by said Woolfolk and Norfleet wood be of very considerable advantage to a great number of people.

Therefore your petitioners humbly pray that your Honl body wood not pass a law prohibit the building of said mill and your petitioners ever pray..etc.....

The defendant by his attorney motioned for a New Trial agreed by the Council of boath parties. It is Ordered by the Court that a New Trial be granted.



KEITH KINFOLKS by Larry King, 100 Longview Dr., Hendersonville, TN. 37075. 363 pages. Hardback. Full name index. \$25.00

This well done book contains a record of the descendants of James Keith, Sr., who came to America as an infant in about 1719.

It is well documented with detailed explanations given for conclusions drawn by the author. "Family Traditions" are included in this publication, but are clearly noted as such.

The descendants are separated into generations (about eleven generations in all) with a simple numbering system to identify each individual. A descendant can easily trace his line thru some 16,000 names to James Keith, Sr.

Mr. King is also the author and publisher of BLUE RIDGE MOUNTAIN KINFOLKS published in 1976 (\$15.00)

These companion books are not only excellent resource material, but are extremely attractive additions to the bookshelf.

A GUIDE TO GENEALOGICAL RESEARCH IN TENNESSEE by Naomi M. Hailey. Published by Cook & McDowell Publications, 719 E. 6th St., Owensboro, Ky. 42301. 54 pages. Soft bound. \$4.00.

Although Mrs. Hailey states in the Preface that this is not designed to be a beginners book, she has included very good directions on how to begin a genealogical research which will apply to any location.

For Tennessee researchers she has included a list of census records available in the Tennessee State Library and Archives in Nashville, as well as the existing tax records for the state. Some of the private papers in the Manuscript section of the Tennessee State Library and Archives are also mentioned. Migration patterns INTO well as OUT OF the State of Tennessee are briefly discussed.

Her discussion of church records mentions some printed sources as well as depositories found in the state.

The researcher with Indian ancestry may find help in the section on Indian Heritage.
