PAYNE FAMILY NOTES

Between December 1779 and May 1, 1780, several groups of settlers made their way from the settlements on the Holston and Clinch Rivers in present Sullivan and Washington Counties, Tennessee, and the original territory of Washington County, Virginia, from the New River Settlements in present Montgomery County, Virginia, from higher up in Botetourt and Fincastle Counties, and from Kentucky, to the present site of Nashville, Tennessee. Names of Payne family members appear in Middle Tennessee records from the earliest period of 1780.

On 8 March 1780 a young man by the name of Payne was murdered by Indians on the Tennessee River while on the way to the Cumberland River settlement. He was a member of the John Donelson party which came by water from the Holston and Clinch River settlements.

Many of the first Cumberland River emigrants signed the first document drafted to form a government in the infant settlement, commonly called "The Cumberland Compact". While no Paynes are found on the Compact, signed in May, 1780, the name of Mathew Pain appears on the Petition of the Inhabitants of Cumberland River, drafted and signed in the Summer of 1780 and submitted to the North Carolina legislature in 1782.

John Allbright, one Tennessee historian, states that one Mr. Payne was scalped and murdered by Indians in a cabin at Asher's Station in present Sumner County in late Summer, 1780. Mr. Allbright's statements are often inaccurate and, to date, the death $_3$ of a member of the Payne family at this time and place is unverified.

As the Revolutionary War drew to a close and the North Carolina Legislature began drafting plans to compensate soldiers of the North Carolina Continental Line by awarding them land grants in present Middle Tennessee, it was necessary to consider the prior claims of the Cumberland settlers. In January 1783 a commission met and established the preemption rights of the settlers who were on the Cumberland River before May 1780, providing that they exercise their claim in a timely manner as perscribed by North Carolina Law. The preemption rights of two members of the Payne family were among those approved: (1) Mathew Payne, 640 acres on the north side of Cumberland River at the mouth of Gasper's Cr.; (2) George Payne, 640 acres located above the mouth of Cedar Cr.

The majority of the first settlers did not remain long on the Cumberland River, but returned to their homes, leaving only a handful of hardy souls to guard the frontier settlements from the Indians. In 1784, the North Carolina Assembly passed special legislation providing special land grants to those who remained to defend their new home from marauding

Indians. None of the Payne family is among the "Roll of Honor" of those who remained, so they apparently returned to the Clinch River farms in late summer of 1780.

On 18 June 1782 letters of administration were granted on the estate of John Blackmore, Jr., to Elizabeth Blackemore and Josiah Payne, with John Blackemore, Sr., William Blackemore, and Alexander Ritchie as securities. Andrew Davis, Almore Douglas, John Norris, Joseph Blackemore, Samuel Richie, Patrick Porter, and George Gibson were sworn to appraise the estate, which was inventoried and divided on 21 August 1782. The estate settlement is found in the records of Washington County, Virginia.

The Paynes had moved into the Clinch River settlement about 1777. Listed on a payroll of Capt. Joseph Martin's men stationed at Fort Blackemore (on Clinch River in present Scott County, Virginia), in 1777 were Mathew Pane, Sr., Josiah Payne, George Payne, Mathew Payne, Junr., Lewis Green, Senr., and James Green. More will be written about the Green family later. On 21 August 1781 Mathew Payne surveyed a land grant of 400 acres on South Side of Clinch River in Washington County, Virginia, which had been settled in 1777. On 19 November 1782, he acquired another 175 acres, also on the South Side of the Clinch River. In 1777, Washington County, Virginia, Josiah Pain and Patrick Porter were bondsmen for the estate of James Naul. John Blackmore, Sn., George Pain, Samuel Riche, John Blackmore Jun., and Andrew Davis were appointed appraisers.

The Paynes, along with members of the Green family, left their home on Clinch River and migrated permanently to the Cumberland River settlements in 1784. The following document is found recorded in Davidson County, Tennessee, $\underline{\text{Wills}}$, $\underline{\text{Vol A}}$:

"The Testimony of Sundry Person Concerning a Nuncupative Will made by Lewis Green Decd...

Sarah Payne Daughter of the Decd and wife of Josiah Payne of full age deposeth That her father the Tesator made his abode in Washington County on Clinch River With(?) her and her husband, And While he lived with them made a Written Will As he The Testator told her in Which he Bequeathed a Certain Negro fellow named Charles to be Sold and the Money to be Equally Devided Among all his Children That Sometime Afterwards in the Month of October Last Her father the Testator And all her Husband's family Removed to the Settlemt on Cumberland before her father left Clinch (About Eighteen Months before) he left the Written Will wt their (sic) Benjamin Nicholas And not Long before their Removal Gave the sd Nicholas Charge not to make any use of the Will Untill he heard from him the Testator; for when he got to the Cumberland he should Alter it and leave this Negro to his Son Zachariah Green because all his Other Children Were Married and gone from him: And had Moreover Received the Portion Which he Allotted them all but his Son Zachariah. That on the Road to Cumberland at the place called the Blue Springs her father was Very Sick: he called up the Most of the grown people that Were Encamped wt them and After Asking this Deponent if she was Willing her Brother Zachariah Should have the Negro, and being Answered in the Affirmative Declared before her the Deponent

and Sundry other persons Particularly Mary Payne her Mother in law George Payne her Brother-in-law And Jno Payne That the sd Negro Charles Should be his Son Zachariah's And Should Serve no other person And that his Son Zachariah Should Pay all his Debts: That this Would then have been put in Writting at that Time but there was no Materials to write wt in the Camp: And in About Three Days Afterwards her father the Testator Died: And further saith not: Which was Subscribed by the Mark of the sd Sarah Payne.

Mary Payne, Wife of Matthew Payne of full Age Deposeth and Saith That She did for a long time live a Neighbour to Lewis Green The Testator. Was Acquainted With his Making the Written Will And Was present When he made the Nuncupative Will, And knows that What her Daughter in law Sarah Payne Deposed Above, is the Truth: And further Saith not. Subscribed by Mary Payne...

Taken before us Magistrates for Davidson County Danl Smith At the Request of Zachariah Green: by Josiah Payne Isaac Linsey Who was to Act for him in his Absence, This 4th Day of Aprl 1785.

The following facts are stated in the above document: (1) Lewis Green is the Testator; (2) He died at Blue Springs on the road to Cumberland from Clinch River; (3) He made a verbal will three days before his death; (4) Sarah Payne is the daughter of the deceased (Lewis Green; (5) Sarah Payne is the wife of Josiah Payne; (6) Sarah Payne's brother is Zachariah Green, son of Lewis Green; (7) Lewis Green had other children who had already married; (8) Mary Payne is mother-in-law to Sarah Payne; (9) Mary Payne is wife to Matthew Payne; (10) Sarah Payne is daughter-in-law to Mary Payne; (11) Mary Payne "did for a long time live a Neighbour to Lewis Green The Testator; (12) Sarah Payne and Mary Payne are both "of full age"; (13) "in the month of October last...the Testator and all her (Sarah Payne's) Husband's family Removed to the ... Cumberland"; (14) The deposition is dated 4 April 1785; (15) John Payne's relationship is not stated.

Mathew Payne and George Payne exercised their preemption rights approved by the North Carolina Assembly in 1783. Mathew Payne's grant on Gasper's Cr. was dated 17 April 1786, while George Payne's grant on Blooming Grove Cr. was made 13 July 1788. Josiah Payne's grants were signed 17 November 1790, 78 acres on Cumberland River, and another dated 26 September 1795 on Stone's River.

We Could Were We personally present holding good and Valid all our sd Attory may lawfully Do in our names Given Under our hands & Seals this Second Day of July 1787.

The Above Letter of Attry Was Acknowledged by ye sd Mathew Payne in Court held for ye County of Davidson July 2nd 1787 And Henry Bradford in sd Court Made Oath that he Saw Mary Payne Likewise Sign & Seal the Same.

Nine Cows & Calves, One Heifer Two Years old, Three heifers One Year Old, Two Steers One Year Old, One Steer 5 years old, Two pair of Waggons Gears. And Afterwards Said Bradford Returned the Amount of the Sale L 140-18-6 Oct. Sessions 1787. (John Blackamore's estate was originally administered in Washington County, Virginia, in 1782 by Elizabeth Blackemore and Josiah Payne. The Widow, Elizabeth apparently had married Henry Bradford.)

2 September 1795 Mathew Payne wrote his will on 2 September 1795 and it was probated at July Court 1806.

In the Name of God Amen -- I Mathew Payne Senr of the Teritory South of the River Ohio and County of Davidson being in my Right mind and perfect meaning Yet considering the Morality of life and Certainty of Death am here-unto moved to make my Last will and Testament in manner following that is to say -- My first will and Desire is that my son Josiah Payne should have one Hundred and forty Acres of Land at the Lower End of My Preemption whereon I now live Begining at a large white Oak on the Bluff at the lower corner of my Preemption from thence Runing up Cumberland by the Meanders to include his Dwelling house and his present Improvement from thence a Direct Course to Join the part of my Land I Conveyed to John Donelson Secondly I will to my son George Payne one hundred Acres of my Land Begining where my line intersects George Maxels on Manskers Creek at two Elms and two Hickorys near the Bank of the Creek from thence running Down said Creek to include said George Dwelling House and his present Inclosure from thence Runing South on my No line for compliment this being the same Parcel of Land that the sd George Payne Bought of his Brother Mathew -- I thirdly will and Desire that my son Mathew Junior lives and remains at his present Dwelling and Enjoy all his present privileges during Pleasure and when he sees Cause to Remove his Brother Joel Payne to pay him the Simple Value of his Improvement-fourthly I Desire that the Remaining part of my Preemption with all my stock of Every kind as Also my Tenements & Household furniture whatsoever to Remain in the Possession of my Beloved Wife Mary Payne during her Natural life and then the Above Mention part of my Preemption to Devolve to my son Joel with all Privileges thereunto Belonging -- I fifthly Will and Desire that all the Above mentioned Stock and household Stuff of Every kind be disposed of at the Descretion of my wife Mary Payne at her Death only Paying to my Sons Josiah George and Mathew Payne and Also to my Daughter Elizabeth Bradford one Dollar a peace. In witness whereof I have hereunto set my hand and affixed my seal this Second day of September 1795. Witness Isaac Lindsey, Samuel Baird Mathew (X) Payne his mark

My present Desire that my son Mathew Payne Enjoy free privileges of that part of my Preemption from the mouth of Gasper's Creek up to George Paynes line & running South to include his Improvement that he now hath this to him his heirs while he lives thereon the day and Date above. Date above.

we also find that the administrators has paid debts to the amount of fifteen hundred and forty dollars & ninety six cents we also allow the administrators their account of one hundred and twenty dollars for their services for settling the estate given...Given under our hands and seals this 30th of January 1811.

Agreeably to the annexed order in the undersigned provided to divide the Estate of Josias Payne, deceased, in the following manner to wit: We have had the land on Cumberland River surveyed and find there are Three Hundred-Eighty and one-half acres. We then proceeded to divide the land agreeably to quality. We are of the opinion that 120½ acres on the Stones River was not more than equal to 100 on the Cumberland River. Of the land on the Cumberland we have laid off One Hundred-Thirteen and One-Half acres, with improvements, for the widow. The remainder as follows to wit: Lot No one thirty eight acres drawn by William Payne Lot no two thirty nine and threefourth acres to Zachariah Payne Lot No three thirty eight and one-fourth acres to George W. Paynes representative Lot no four thirty seven and a half acres to Greenwood Payne Lot no five thirty five acres Minerva Payne Lot no six forty acres to Squire Payne Lot no seven thirty six acres to Ann Pillow Lot no eight one hundred and twenty and a half acres on Stones River to Spencer Payne your commissioners report further that they could not divide the negroes of said estate among the heirs there not being one to each they therefore are of the opinion the Court should order a sale of them. Given from under our hands and seals August 27th 1813.

The Humble Petition of a number of the Inhabitants of Sumner County, Living on the North side of Cumberland river, Sheweth; that as your petitioners expect two new Counties to be taken from sd County of Sumner this Session of Assembly, & your petitioners wish to shew to your honourable body what they Humbly conceive to be best in forming said Division, your petitioner with their fellow Citizens may be equally accommodated in forming sd Division, Your petitioners therefore pray that the County of Sumner may not be suffered to Cross Cumberland river, as it is Seventyone miles at least from said river to the Kentucky Line, which has been ascertained by actual Survey, your petitioners wish to show that they are unbiased by private Interest, for, we wish the public Buildings of sd County of Sumner, to be as near the Center as may be suited to the majority of of the people having no regard to any Town, or Towns, or any other place whatever, & they only crave a Constitutional County, and your petitioners as in duty bound shall ever pray -- July 27th 1799 --

Red River Baptist Church Minutes

by Irene Morrison Griffey

These minutes were copied from a typed copy in the State Library and Archives, Nashville, Tennessee. The original records were in the possession of Charles H. Fort in 1936. Please refer to Vol. IX, #1 (September 1979) for the location of the various churches mentioned.

..........

Forts Meeting house October 2d. 1802. After sermon by Bro. Totewine Church met in order, chose Bro. E. Fort moderator. Rec'd Isaac Phillips, & George Wolf by experience. The constitution of the Church was read by Bro. Sugg Fort. The letter to the Mero District Association was read & sent Brethen, Smith Totewine J. & S. Fort appointed to go to the West fork.

Saturday 16th October 1802. Church met in order, chose Bro. David Smith moderator, & Bro. Sugg Fort clerk protem. The proceedings of the wing at the west fork rec'd. Query - The third chap. of 2d Thess that part of the Chapter which concerns discipline? Postponed. Query - The 2d Whether Judas Iscarriot did partake of the lords supper or not?

Nov. 20th 1802. After sermon by Bro. Skinner Church met in order, chose Bro. Skinner moderator - former query's postponed. Query - Whether Evengelical faith in Christ is required of all that hear the gospel or not? postponed.

At E. Lawsons Decr. 18th 1802. After sermon by Bro. Totewine. The church met in order chose Bro. Totewine moderator. Queries postponed.

At E. Lawsons Jan. 15th 1803. Sermon by Bro, Skinner. Bro. Skinner moderator. Rec'd Dudley Williams by experience, to be baptised the second Lords day in February next, at Mrs. Hollands. The Queries continued Brethren Neville, Smith, S. Fort, Connell & J. Fort appointed to go to the West fork.

October 9th, 1802. From the wing. After sermon by Bro. Totewine met in order Sister Johnson acknowledged that she had been in fault under all the Churches dealings with her. And was restored to fellowship. The above forwarded by Bro. Roberts clerk of the wing.

<u>February 12th 1803</u>. After sermon by Bro. Totewine, at Bro, Cordery's met in order chose Bro. Totewine moderator. Bro. Brooks made enquiry of the wing whether they thought proper to call for a presbytery to enquire into their order, and whether they are ripe for constitution or Not? After some deliberations

they thought proper to have one, and send a petition by Bro, J. Fort to the Church at Red River to appoint such members as they think proper, as a presbytery to enquire in to their order, and send members from said Church with power to dismiss such members, as they should think proper, if the presbytery judge them ripe for Constitution.

Feb. 19th 1803. After sermons by Elders Moore and Renfrow Church met in order, motioned to appoint one or more deacons in the Church. Nominated Brethren J. Fort, David Smith & Willie Holland. Postponed for further consideration. Bro. E. Fort motioned that a treasurer be appointed in his room. And Bro. J. Fort is appointed treasurer for this Church. Brother George Wolf appointed to cite Bro. Sam'l Wilcox to appear at our next Conference, to inform the Church of his present standing. The petition from the West fork taken under consideration. And we think it most advisable only to send members from the body to enquire into their order and standing, and whether they are ripe for a constitution or not. And to meet on Friday before the 2nd Lords day in March next. And appoint all the male members belonging to the Church to go. No. communion for want of wine.

March 11th 1803. West Fork Church met in order. After some deliberation, the constitution of the wing into a Church postponed till Saturday before the 2nd Lords day in June next.

March 19th 1803. Sermon by Bro. Skinner, Church met in order, chose Bro. J. Fort moderator. Saml. Sugg's Hager offered her experience, but was not rec'd, but, was recommended to attend next meeting. Bro. Sam'l Wilcox called on to inform the Church of his standing. He informed them that he was in the same standing as formerly. He was requested to attend next conference. The Church took into consideration the proceedings of the general Conference, and are of opinion that they form themselves into an Association, and appoint brethen J. & S. Fort to write the letter to the general Conference. Query, whether Evangelical faith in Christ is required of all that hear the gospel, withdrawn. Query, That part of the 3rd Chap. of 2nd Thess, as concerns discipline to be sent to the general Conference. Query, whether Judas Iscarriott did partake of the Lords supper or not? Sent as above. Bro. Sugg Fort appointed to cite Bro. G. Connell to come to next Conference, as it is reported he behaved at Portroyal & c.

April 16, 1803. After divine Worship by Bro, Skinner & Totewine the church met. Chose Brother Skinner Moderator. Made enquiry for fellowship. Brother Connell came forward agreeable to citation & gave General Satisfaction. That the report was not true. Agreeable to the request of last Conference, Bro. Wilcox came forward, & appeared not to be yet satisfied with himself but left the Church to do with him as they thought proper. After sometime spent in conversing with him, the church rec'd him into full fellowship as a christian. Hager belonging Sam'l Sugg came forward agreeable to the request of last Conference & was received by Experience. Also Elias Fort (MCreek) or (Brush Creek) and Archer belonging to Bro. Josiah Fort were both rec'd by Experience. They were Baptized next day.

May 14, 1803. After a sermon by Bro. Skinner the church met. Chose Bro. Jos. Fort Mod. There appeared to be union among ourselves. Rec'd Sarah Wimberley by experience. Brethen E. Skinner, Wilcox Holland, Williams, Neville & Sugg Fort are appointed to go to the West Fork to enquire with the helps from other Churches whether the wing is ripe for constitution or not. Appointed Brethren E. Skinner, Smith & Boydstone to wait on Bro. Moore's Church in order to fix on a plan of Friendly Correspondence, with us. And Brethren Josiah Fort & Elias Fort (MC) to wait on Bro. Rawles Church on the same business.

June 18th 1803. After a sermon by Brother Brooks the Church met, chose Bro. Skinner Mod. appeared in fellowship. Rec'd Bro. Francis Graham & his wife Rachel who were members of Millers Creek Church. We rec'd them by giving them the right hand of fellowship. This church on Millers Creek having by their disorderly conduct (as we thought) become out of our fellowship, we therefore adopted a Rule to Receive members from that church by Experience or acknowledgement or acquaintance & c as a letter from that church to us was no act. No Motion, Took into consideration Joseph Dorris and Church appointed Brethren Jos. & Sugg Fort to draw a plan for the Church to act on also; a plan for the church to recommend to the Association. The Brethren & Sisters belonging to the wing of this church, on the West Fork & Little River, petitioned by Breth Jesse Brook, Obadiah Roberts & Daniel Fristoe for a letter of dismission in order for constitution & they are dismist.

July 16, 1803. After sermon by Bro. Skinner, the church met chose Bro. F. Graham Mod. fellowship among us. Appointed Brethren Francis Graham, Josiah & Sugg Fort to write the letter to next Association. On motion & The plan or consitution of the Association with the Abstract of their principles & Rules of Decorum were Read and meeting the approbation of this Church were ordered to Register in our church Book. Unanimously agreed that one Deacon is Sufficient at this time, & that Bro. Jos. Fort be the one, the time for his Ordination the fryday before the 3rd Lords day in August, and that day set a part for fasting & prayer. On motion Appointed Brother Sugg Fort Clerk for this Church.
